In calculating the percentage of side surface area covered by 15 closed physical barriers, all solid surfaces that block air 16 flow, except railings, must be considered as closed physical 17 18 barriers. This section applies to all such enclosed indoor workplaces and enclosed parts thereof without regard to 19 whether work is occurring at any given time. 20 (b)(c) The term does not include any facility owned or 21 leased by and used exclusively for noncommercial activities 2.2 23 performed by the members and guests of a membership 24 association, including social gatherings, meetings, dining, and dances, if no person or persons are engaged in work as 25 defined in subsection (13)(12). 26 (6) "Person" has the same meaning as in s. 1.01(3). 27 28 (12)(11) "Stand-alone bar" means any licensed premises 29 devoted during any time of operation predominantly or totally to serving alcoholic beverages, intoxicating beverages, or 30 31 intoxicating liquors, or any combination thereof, for

consumption on the licensed premises; in which the serving of 1 2 food, if any, is merely incidental to the consumption of any such beverage; the licensed premises does not offer a 3 children's menu or include in the menu items or food portion 4 sizes that are identified as being specifically for children, 5 and the licensed premises is not located within, and does not б 7 share any common entryway or common indoor area with, any 8 other enclosed indoor workplace, including any business for 9 which the sale of food or any other product or service is more than an incidental source of gross revenue. A place of 10 business constitutes a stand-alone bar in which the service of 11 food is merely incidental in accordance with this subsection 12 13 if the licensed premises derives no more than 10 percent of 14 its gross revenue from the sale of food consumed on the licensed premises. However, a place of business remains a 15 stand-alone bar in which the service of food is merely 16 incidental if the licensed premises derives no more than 20 17 18 percent of its gross revenue from the sale of food consumed on 19 the licensed premises, the premises is licensed as a vendor as of July 1, 2005, and the licensed premises is located in a 20 building that is individually listed in the National Register 21 22 of Historic Places as defined in s. 267.021. An application to individually list the building in the National Register of 23 24 Historic Places must have been submitted to the Department of State on or before 90 days after the effective date of this 25 26 <u>act.</u> 27 Section 2.
