24	(2) The governing board of the authority shall consist
25	of <u>11</u> five voting members <u>and one nonvoting member</u> as follows:
26	(a) The chairs of the county commissions of Seminole,
27	Orange, and Osceola Counties, or another member of the
28	commission designated by the county chair, shall each appoint
29	<u>a commissioner to</u> serve as a representative on the board. <u>The</u>

appointed and during for the full extent of his or her board term.

- (b) The <u>mayors</u> mayor of <u>Altamonte Springs</u>, the City of Orlando, <u>and Kissimmee</u>, respectively, or a member of the Orlando City Council designated by the mayor, shall <u>each</u> serve as a representative on the board for the full extent of his or her term or shall designate a member of his or her municipal council or commission to serve as a representative on the board for the full extent of the mayor's term.
- (c) The Governor shall appoint five board members to 4-year terms, two of whom must be residents of Orange County, one of whom must be a resident of Seminole County, one of whom must be a resident of Osceola County, and one of whom must be a resident of Orlando. One of the Governor's appointees must be older than 60 years of age and a member of a statewide organization representing elderly residents, one must be disabled and a member of a statewide organization representing disabled residents, and three must be minorities or members of a group representing minorities.
- (d)(c) The Secretary of Transportation shall appoint the district secretary, or his or her designee, for the district within which the area served by the authority is located and this member shall be a nonvoting voting member.
- (3) A vacancy during a term shall be filled <u>by the</u>

 <u>respective appointing authority</u> in the same manner as the

 original appointment and only for the balance of the unexpired

 term.
 - Section 2. This act shall take effect July 1, 2005.

********* SENATE SUMMARY Increases board membership of the Central Florida Regional Transportation Authority to eleven members.
Specifies qualifications and terms of service for certain members. Provides for appointment by the Governor and specified county commissions and mayors. Changes the Secretary of Transportation's appointee to a nonvoting
