Any such applicant whose application is denied by the commission or one 27 2.8 of its cosponsors subsequent to its denial by the district 29 school board may exercise its right to appeal the district school board's denial under paragraph (c) within 30 days after 30 receipt of the commission's or cosponsor's denial or failure

to act on the application. However, the applicant forfeits its right to appeal under paragraph (c) if it fails to submit its application to the commission or one of its cosponsors by August 1 of the school year immediately following the district school board's denial of the application. Section 3. This act shall take effect July 1, 2007.
