### **SUMMARY ANALYSIS**

The jurisdiction of the Florida State Boxing Commission (commission) includes oversight of amateur, as well as, professional boxing and kickboxing matches and provides exclusive jurisdiction over all amateur sanctioning organizations for amateur boxing and kickboxing matches held in the state. The powers and jurisdiction of the commission are authorized to help ensure the health, safety, and well-being of amateurs participating in matches in this state. An "amateur sanctioning organization" is defined as any business entity organized for sanctioning and supervising matches involving amateurs. The commission rulemaking authority includes the establishment of qualifying criteria for amateur sanctioning organizations.

Currently, exemptions from regulation apply to the following:

- A match conducted or sponsored by a bona fide nonprofit school or education program whose primary
  purpose is instruction in the martial arts, boxing, or kickboxing, if the match held in conjunction with the
  instruction is limited to amateur participants who are students of the school or instructional program; or
- A match conducted or sponsored by any company or detachment of the Florida National Guard, if the match is limited to participants who are members of the company or detachment of the Florida National Guard.

The effect of these exemptions is to remove the listed types of matches from the regulatory jurisdiction of the commission but continue to require the approval and supervision of the matches by an amateur sanctioning organization.

The bill is designed to provide an additional exemption to the licensing and regulatory requirements.
 The exemption applies to amateur matches conducted or sponsored by the Fraternal Order of Police if the match is limited to amateur participants and is held in conjunction with a charitable event.

The bill specifies that workers compensation benefits would not accrue to participants for injuries resulting from participation in matches.

The Department of Business and Professional Regulation does not foresee any costs or revenues associated with this legislation.

### I. SUBSTANTIVE ANALYSIS

#### A. HOUSE PRINCIPLES ANALYSIS:

Provide limited government/Promote personal responsibility

The bill is designed to provide an additional exemption to certain pugilistic licensing and regulatory requirements for amateur matches conducted or sponsored by the Fraternal Order of Police.

### B. EFFECT OF PROPOSED CHANGES:

## Present situation

Chapter 548, F.S., governs pugilistic matches in the state, which include professional boxing, kickboxing, and mixed martial arts. By definition, "boxing" means to compete with the fists; "kickboxing" means to compete with fist, feet, legs, or any combination thereof, and includes 'punchkick' and other similar competitions; and "mixed martial arts" means unarmed combat involving the use, subject to any applicable limitations set forth in this chapter, of a combination of techniques from different disciplines of the martial arts, including, but not limited to, grappling, kicking, and striking.

The Florida State Boxing Commission (commission), composed of five members appointed by the Governor, has the statutory responsibility for the regulation of persons participating in exhibitions and contests as well as the regulation of the events themselves. The commission is assigned to the Department of Business and Professional Regulation (DBPR) for administrative and fiscal accountability purposes only. Section 548.003, F.S., requires DBPR to provide all legal and investigative services necessary to implement chapter 548, F.S.

The commission's statutory responsibilities are wide ranging and include licensing and regulating individuals involved in conducting professional boxing and kickboxing matches in the state, issuing permits for live matches and pay per view matches, establishing and administering medical guidelines, and collecting fees and taxes levied by chapter 548, F.S. Personnel of the commission supervise all aspects of all live bouts, including the licensing of participants not previously licensed and the weigh-in of participants, and also act as the official scorekeeper of matches. The commission maintains a database that contains all relevant information on all individuals licensed by the commission. Prior to each event, commission personnel verify that all participants are currently licensed, not under suspension in Florida or any other state, and meet all other requirements to be eligible to participate in boxing in Florida.

Section 548,007, F.S., exempts from the provisions of chapter 548, F.S.,

- matches conducted or sponsored by a bona fide nonprofit school or education program whose
  primary purpose is instruction in the martial arts, boxing, or kickboxing, if the match held in
  conjunction with the instruction is limited to amateur participants who are students of the school
  or instructional program, and
- matches conducted or sponsored by any company or detachment of the Florida National Guard, if the match is limited to participants who are members of the company or detachment of the Florida National Guard.

Section 548.008, F.S., prohibits certain amateur matches unless sanctioned and supervised by an approved amateur sanctioning organization, any amateur mixed martial arts match, and any professional match from being held unless it meets the requirements of law and rules. The section also provides that any person participating in a match that is prohibited, knowing the match to be prohibited,

STORAGE NAME: h0631c.JEC.doc DATE: 4/8/2008 commits a second degree misdemeanor. Any person holding, promoting, or sponsoring a match prohibited under this section commits a third degree felony.

# Effect of proposed changes

The bill is designed to provide an additional exemption to the licensing and regulatory requirements for amateur matches conducted or sponsored by the Fraternal Order of Police if the match is limited to amateur participants and is held in conjunction with a charitable event.

The bill specifies that workers compensation benefits would not accrue to participants for injuries resulting from participation in matches.

## C. SECTION DIRECTORY:

Section 1. Amends s. 548.008, F.S., to reference amateur matches conducted or sponsored by the Fraternal Order of Police for purposes of creating certain exemption status.

Section 2. Effective date - July 1, 2008.
