42	of individuals who are ineligible to vote by virtue of death,

46	each source refers to the same individual.

47 (3) A person other than a state or local election official may not submit a formal challenge to an individual's eligibility 48 49 to register to vote or to vote in any election if the basis for such challenge is evidence consisting of an error or omission on 50 51 any record or paper relating to any application, registration, or 52 other act requisite to voting, if such error or omission is not 53 material to an individual's eligibility to vote as provided by 54 law.

55 <u>(4)(2)</u> The clerk or inspector shall immediately deliver to 56 the challenged person a copy of the oath of the person entering 57 the challenge, and the challenged voter shall be allowed to cast 58 a provisional ballot.

59 <u>(5)(3)</u> Any elector or poll watcher may challenge the right 60 of any voter to vote not sooner than 30 days before an election 61 by filing a completed copy of the oath contained in subsection 62 (1) to the supervisor of election's office. The challenged voter 63 shall be permitted to cast a provisional ballot.

64 (6) (4) Any elector or poll watcher filing a frivolous 65 challenge of any person's right to vote commits a misdemeanor of the first degree, punishable as provided in s. 775.082 or s. 66 775.083; however, electors or poll watchers shall not be subject 67 to liability for any action taken in good faith and in 68 69 furtherance of any activity or duty permitted of such electors or poll watchers by law. Each instance where any elector or poll 70 71 watcher files a frivolous challenge of any person's right to vote 72 constitutes a separate offense.
