I. Summary:

The bill changes the minority business enterprise recertification process from requiring vendor recertification every year to requiring recertification every two years.

This bill amends section 287.09451, Florida Statutes.

II. Present Situation:

The Office of Supplier Diversity (office) is established with the Department of Management Services (department) to assist minority business enterprises (MBEs) in becoming suppliers of commodities, services, and construction to state government. One of the duties of the office is to certify MBEs pursuant to specified statutory criteria, and to recertify MBEs not less than once a year. Recertification is accomplished via a process in which a vendor enters information in online forms, prints the forms, has the forms notarized, and returns the forms to the office.

In 2008, ch. 2008-155, L.O.F., created a contracting preference for service-disabled veteran business enterprises. The department is required to initially certify such businesses and recertify them every two years.⁴
