- (c) The license plate annual use fees shall be distributed to the Florida State Lodge Fraternal Order of Police Memorial Foundation to fund its activities, programs, and projects aimed at preserving, maintaining, and expanding the Florida Fraternal Order of Police Law Enforcement Memorial. The Florida State Lodge of the Fraternal Order of Police may retain all revenue from the annual use fees until all startup costs for developing and establishing the plate have been recovered. Thereafter, up to 25 percent of the annual use fee revenue may be used for promotion and marketing of the specialty license plate and administrative costs directly associated with memorial programs and the specialty license plate. The Florida State Lodge Fraternal Order of Police Memorial Foundation shall use the remaining funds as follows:
- 1. To fund the Florida State Fraternal Order of Police Law Enforcement Memorial projects.
- 2. To provide funds for the expansion, maintenance, and support of the Florida State Lodge Fraternal Order of Police Memorial Foundation.
- 3. To provide funds to organizations that help support the families of law enforcement officers who have died in the line of duty.
- 4. To support programs and events that support the Florida Fraternal Order of Police Law Enforcement Memorial.
