### I. Summary:

Senate Bill 1554 makes it a  $2^{nd}$  degree felony for a public servant, with corrupt intent to influence or attempt to influence the competitive bidding process, to fail to advertise, publicly announce, or electronically post a solicitation for the procurement of commodities or contractual services which he or she is *already* obligated to do by statute or rule.

The bill takes effect July 1, 2010.

This bill substantially amends s. 838.22 and reenacts s. 921.0022(3)(g) of the Florida Statutes.

# II. Present Situation:

Chapter 287, Florida Statutes, generally governs the procurement and bid solicitation process for commodities and contractual services for most state executive agencies. Unless otherwise provided or exempt, it mandates that such contracts exceeding \$25K be subject to the competitive bidding/proposal/request process.<sup>1</sup> Specific exemptions to this competitive-solicitation process include contracts for:<sup>2</sup>

- 1. Artistic services.
- 2. Academic program reviews.
- 3. Lectures by individuals.
- 4. Auditing services.

- 5. Legal services.
- 6. Health services involving examination, diagnosis, treatment, prevention, medical consultation, or administration.
- 7. Services provided to persons with mental or physical disabilities by certain not-for-profit corporations.
- 8. Medicaid services by certain health care providers.
- 9. Family placement services.
- 10. Prevention services relating to mental health.
- 11. Training and education services provided to injured employees pursuant to s. 440.491(6).
- 12. Contracts entered into by the Department of Transportation pursuant to s. 337.11.
- 13. Services of commodities *provided by* governmental agencies.

# III. Effect of Proposed Changes:

Senate Bill 1554 makes it a 2<sup>nd</sup> degree felony for a public servant, with corrupt intent to influence or attempt to influence the competitive bidding process undertaken by a state, county, municipal, or special district agency, or other public entity, to fail to advertise, publicly announce, or electronically post a solicitation for the procurement of commodities or contractual services which he or she is *already* obligated to do by statute or rule.

The bill also makes a technical change, reenacting s. 921.0022(3)(g), Florida Statutes, for purposes of incorporating the new offense created in the bill into the Offense Severity Ranking Chart.

The bill takes effect July 1, 2010.

### **Other Potential Implications**:

Notwithstanding the inherent evidentiary *difficulty* in proving a corrupt intent with respect to an omissive crime --- that is, a *failure* to act as oppose to an *affirmative* act, one impact of the bill will likely be to encourage agencies and local governments to reexamine and very narrowly interpret the competitive-solicitation contracting exemptions in Florida law.
