insert:

~~(a) If the department determines that the number of students assigned to any individual class exceeds the class size maximum, as required in subsection (1), based upon the October student membership survey, the department shall:~~

~~1. Identify, for each grade group, the number of classes in which the number of students exceeds the maximum and the total number of students which exceeds the maximum for all classes.~~

71 ~~(a) School districts may use teaching strategies that~~

72 include the assignment of more than one teacher to a classroom
73 of students and that were implemented before July 1, 2005.
74 Effective July 1, 2005, school districts may implement
75 additional teaching strategies that include the assignment of
76 more than one teacher to a classroom of students for the
77 following purposes only:

- 78 1. Pairing teachers for the purpose of staff development.
- 79 2. Pairing new teachers with veteran teachers.
- 80 3. Reducing turnover among new teachers.
- 81 4. Pairing teachers who are teaching out-of-field with
82 teachers who are in-field.
- 83 5. Providing for more flexibility and innovation in the
84 classroom.
- 85 6. Improving learning opportunities for students, including
86 students who have disabilities.

87 (b) Teaching strategies, including team teaching, co-
88 teaching, or inclusion teaching, implemented on or after July 1,
89 2005, pursuant to paragraph (a) may be implemented subject to
90 the following restrictions:

- 91 1. Reasonable limits shall be placed on the number of
92 students in a classroom so that classrooms are not overcrowded.
93 Teacher-to-student ratios within a curriculum area or grade
94 level must not exceed constitutional limits.
- 95 2. At least one member of the team must have at least 3
96 years of teaching experience.
- 97 3. At least one member of the team must be teaching in-
98 field.
- 99 4. The teachers must be trained in team-teaching methods
100 within 1 year after assignment.

101 (c) As used in this subsection, the term:

102 1. "Team teaching" or "co-teaching" means two or more
103 teachers are assigned to a group of students and each teacher is
104 responsible for all of the students during the entire class
105 period. In order to be considered team teaching or co-teaching,
106 each teacher is responsible for planning, delivering, and
107 evaluating instruction for all students in the class or subject
108 for the entire class period.

109 2. "Inclusion teaching" means two or more teachers are
110 assigned to a group of students, but one of the teachers is
111 responsible for only one student or a small group of students in
112 the classroom.

113
114 The use of strategies implemented as outlined in this subsection
115 meets the letter and intent of the Florida Constitution and the
116 Florida Statutes which relate to implementing class size
117 reduction, and this subsection applies retroactively. A school
118 district may not be penalized financially or otherwise as a
119 result of the use of any legal strategy, including, but not
120 limited to, those set forth in subsection (3) and this
121 subsection.

122 Section 3. Subsection (3) is added to section 1003.44,
123 Florida Statutes, to read:

124 1003.44 Patriotic programs; rules.—

125 (3) (a) Each district school board shall designate one month
126 of the school year to celebrate the Founding Fathers of the
127 United States of America and the principles inherent in the
128 country's founding documents. This month may be coordinated with
129 Celebrate Freedom Week which is observed pursuant to s.

131 (b) During the designated month, students shall be provided
132 instruction that focuses on:

133 1. The leading figures present at the country's founding
134 who were instrumental in crafting the founding documents and
135 setting democratic political precedent.

136 2. The moral and civic virtue, self-sacrifice, intellectual
137 genius, and patriotism demonstrated by the country's founding
138 fathers.

139 3. The founding documents, including, but not limited to,
140 the Declaration of Independence, the Constitution of the United
141 States, the Bill of Rights, and the Federalist Papers.

142 4. The historical and philosophical importance of the
143 Declaration of Independence with its emphasis that all people
144 "are endowed by their Creator with certain unalienable rights,
145 that among these are life, liberty, and the pursuit of
146 happiness."

147 5. The principles inherent in the founding documents,
148 including, but not limited to, individual freedom, limited
149 representative democratic government, a free market economy and
150 system, civic virtue, national sovereignty, natural law, and
151 self-evident truth.

152 (c) The instruction may be integrated into the existing
153 school curriculum through methods including, but not limited to,
154 supplementing lesson plans, holding school assemblies, or
155 providing school-related activities.
