An act relating to the Dan Marino Foundation Florida Vocational College; establishing the Dan Marino Foundation Florida Vocational College in Broward County as a public residential postsecondary school for certain students who have developmental disabilities; providing funding for the school through the Department of Education; requiring that the school comply with the laws and rules applicable to state agencies unless otherwise provided by law; requiring that the school provide educational programs and services; requiring that the Auditor General conduct annual audits of the school's accounts and records; creating a board of trustees; providing membership, terms, and specifying powers and duties of the board; requiring that the board submit legislative budget requests for operations and fixed capital outlay; requiring that the board provide for the content and custody of student and employee personnel records; authorizing the board to provide legal services and reimbursement of expenses for officers and employees of the board; requiring notice and a public meeting under certain circumstances; requiring that all employees and applicants for employment with the board undergo personnel screening and security background investigations; providing a penalty for failure to disclose certain material facts and for use of confidential information for certain purposes; authorizing the employment of campus police and

providing powers, duties, and qualifications; requiring reporting of on-campus crime statistics; amending s. 1000.04, F.S.; providing that the Dan Marino Foundation Florida Vocational College is a component of the delivery of public education within Florida's K-20 education system; amending s. 1001.20, F.S.; authorizing investigations by the Office of Inspector General within the Department of Education; providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

Section 1. The Dan Marino Foundation Florida Vocational College.—

(1) RESPONSIBILITIES.—The Dan Marino Foundation Florida
Vocational College is established in Broward County, Florida, as
a state-supported residential school that provides students who
have developmental disabilities, who are 18 to 26 years of age,
and who have graduated from high school the opportunity to
obtain a postsecondary education on a college campus setting.
The school shall be a component of the delivery of public
education within Florida's K-20 education system and shall be
funded through the Department of Education. The school shall
provide educational programs and support services appropriate to
meet the educational and related evaluation and counseling needs
of students who have developmental disabilities and who meet the
enrollment criteria. Unless otherwise provided by law, the
school shall comply with all laws and rules applicable to state
agencies. Educational services may be provided on an outreach

basis for students who have developmental disabilities and who are 18 to 26 years of age and to district school boards upon request.

- (2) MISSION.—The mission of the Dan Marino Foundation
 Florida Vocational College is to provide an appropriate public education for eligible Florida students who have developmental disabilities. As a school that provides programs for attaining vocational, life, social, and independent living skills, the school shall strive to provide students with an opportunity to develop skills fostering their independence in a caring, safe, and unique learning environment, to prepare them to be an integral part of the community, and to allow them to become significantly less dependent on government funding. The school shall provide outreach services that include collaboration with employers, district school boards, and community organizations and shall encourage input from students, staff, parents, and the community. As a diverse organization, the school shall foster respect and understanding for each individual.
- (3) AUDITS.—The Auditor General shall conduct annual audits of the accounts and records of the Dan Marino Foundation Florida Vocational College. The Department of Education's inspector general may conduct investigations at the school in accordance with s. 1001.20(4)(e), Florida Statutes.
 - (4) BOARD OF TRUSTEES.—
- (a) A Board of Trustees for the Dan Marino Foundation

 Florida Vocational College is created and shall consist of seven

 members who are appointed by the Governor and subject to

 confirmation by the Senate. Of these seven members, two shall be

 persons who have developmental disabilities. Each board member

must have been a resident of the state for at least 10 years before his or her appointment. The term of office of each member shall be 4 years. The Governor may remove any member for cause and shall fill all vacancies that occur.

- (b) The board of trustees shall elect a chair annually. The trustees are entitled to reimbursement for travel expenses pursuant to s. 112.061, Florida Statutes, the accounts of which shall be paid by the Chief Financial Officer upon itemized vouchers duly approved by the chair.
- (c) The board of trustees may adopt rules to administer this section and relating to the operation of the Dan Marino Foundation Florida Vocational College. The board shall submit the rules to the State Board of Education for approval or disapproval. After a rule is approved by the state board, the rule shall be filed immediately with the Department of State. The board of trustees shall act at all times in conjunction with the rules of the State Board of Education.
- (d) The board of trustees is a body corporate and shall have a corporate seal. Unless otherwise provided by law, all actions of the board of trustees shall be consistent with all laws and rules applicable to state agencies. Title to any gift, donation, or bequest received by the board of trustees pursuant to subparagraph (e)11., shall vest in the board of trustees. Title to all other property and other assets of the Dan Marino Foundation Florida Vocational College shall vest in the State Board of Education; however, the board of trustees shall have complete jurisdiction over the management of the school.
- (e) The board of trustees is invested with full power and authority to:

- 2. Procure professional services, including, but not limited to, medical, mental health, architectural, and engineering services.
- 3. Procure legal services without the prior written approval of the Attorney General.
- 4. Determine eligibility of students and the procedure for admission.
- 5. Provide students with necessary bedding, clothing, food, and medical attendance and such other things as may be proper for the health and comfort of the students without cost to their parents, except that the board of trustees may set tuition and other fees for nonresidents.
- 6. Provide for the proper keeping of accounts and records and for budgeting of funds.
 - 7. Enter into contracts.
 - 8. Sue and be sued.
 - 9. Secure public liability insurance.
- 10. Do and perform every other matter or thing necessary to the proper management, maintenance, support, and control of the school at the highest efficiency economically possible, taking into consideration the purposes of the establishment.
- 11. Receive gifts, donations, and bequests of money or property, real or personal, tangible or intangible, from any person, firm, corporation, or other legal entity. However, the board of trustees may not obligate the state to any expenditure or policy that is not specifically authorized by law. If a bill

of sale, will, trust indenture, deed, or other legal conveyance
specifies terms and conditions concerning the use of such money
or property, the board of trustees shall observe such terms and
conditions.

- 12. Deposit outside the State Treasury such moneys as are received as gifts, donations, or bequests and may disburse and expend such moneys, upon its own warrant, for the use and benefit of the Dan Marino Foundation Florida Vocational College and its students as the board of trustees deems to be in the best interest of the school and its students. This money or property is not a part of any legislative appropriation.
- 13. Sell or convey by bill of sale, deed, or other legal instrument any property, real or personal, received as a gift, donation, or bequest upon such terms and conditions as the board of trustees deems to be in the best interest of the school and its students.
- 14. Invest such moneys in securities enumerated under s. 215.47(1), (2)(c), (3), (4), and (10), Florida Statutes, and in The Common Fund, an Investment Management Fund exclusively for nonprofit educational institutions.
 - (f) The board of trustees shall:
- 1. Prepare and submit legislative budget requests for operations and fixed capital outlay, in accordance with chapter 216, Florida Statutes, to the Department of Education for review and approval. The department shall analyze the amount requested for fixed capital outlay to determine whether the request is consistent with the college's campus master plan, educational plant survey, and facilities master plan. Projections of facility space needs may exceed the norm space and occupant

design criteria established in the State Requirements for Educational Facilities.

- 2. Approve and administer an annual operating budget.
- 3. Require all funds received, other than gifts, donations, bequests, funds raised by or belonging to student clubs or student organizations, and funds held for specific students or in accounts for individual students, to be deposited in the State Treasury and expended as authorized in the General Appropriations Act.
- 4. Require all purchases to be in accordance with chapter 287, Florida Statutes, except for purchases made with funds received as gifts, donations, or bequests; funds raised by or belonging to student clubs or student organizations; and funds held for specific students or in accounts for individual students.
- 5. Administer and maintain personnel programs for all employees of the board of trustees and the Dan Marino Foundation Florida Vocational College. Such employees shall be state employees, except that the classification and pay plan for academic personnel and academic administrative personnel of the school shall be set by the board of trustees, subject only to the approval of the State Board of Education. Such employees shall be subject to the provisions of chapter 110, Florida Statutes, and the provisions of law that grant authority to the Department of Management Services over such programs for state employees.
- 6. Give preference in appointment and retention in positions of employment as provided in s. 295.07(1), Florida Statutes.

7. Ensure that the Dan Marino Foundation Florida Vocational College coordinates planning with local governing bodies for educational facility construction.

- 8. Ensure that the Dan Marino Foundation Florida Vocational College complies with s. 112.061, Florida Statutes, concerning per diem and travel expenses of public officers, employees, and authorized persons with respect to all funds other than funds received as gifts, donations, or bequests; funds raised by or belonging to student clubs or student organizations; and funds held for specific students or in accounts for individual students.
- 9. Adopt a master plan that specifies the mission and objectives of the Dan Marino Foundation Florida Vocational College. The plan shall include, but not be limited to, procedures for systematically measuring the schools progress toward meeting its objectives, analyzing changes in the student population, and modifying school programs and services to respond to such changes. The plan shall be implemented for a period of 5 years and shall be reviewed for needed modifications every 2 years. The board of trustees shall submit the initial plan and subsequent modifications to the President of the Senate and the Speaker of the House of Representatives.
- (5) STUDENT AND EMPLOYEE PERSONNEL RECORDS.—The Board of Trustees for the Dan Marino Foundation Florida Vocational

 College shall provide for the content and custody of student and employee personnel records. Student records shall be subject to s. 1006.52, Florida Statutes. Employee personnel records shall be subject to part IV of chapter 1012, Florida Statutes.
 - (6) LEGAL SERVICES.—The Board of Trustees for the Dan

20111616 233 Marino Foundation Florida Vocational College may provide legal 234 services for officers and employees of the board of trustees who 235 are charged with civil or criminal actions arising out of and in 236 the course of the performance of assigned duties and 237 responsibilities. The board of trustees may provide for 238 reimbursement of reasonable expenses for legal services for 239 officers and employees of the board of trustees who are charged 240 with civil or criminal actions arising out of and in the course 241 of the performance of assigned duties and responsibilities upon 2.42 successful defense of the officer or employee. However, in any 243 case in which the officer or employee pleads guilty or nolo 244 contendere to or is found guilty of any such action, the officer 245 or employee shall reimburse the board of trustees for any legal 246 services that the board of trustees may have supplied pursuant 247 to this section. employees and applicants for employment to undergo personnel screening and security background investigations as provided in chapter 435, Florida Statutes, using the level 2 standards for screening set forth in that chapter, as a condition of employment and continued employment. The cost of a personnel screening and security background investigation for an employee of the school shall be paid by the school. The cost of such a screening and investigation for an applicant for employment may be paid by the school.

- (b) As a prerequisite for initial and continuing employment at the Dan Marino Foundation Florida Vocational College:
- 1. The applicant or employee shall submit to the Dan Marino Foundation Florida Vocational College a complete set of fingerprints taken by an authorized law enforcement agency or an employee of the Dan Marino Foundation Florida Vocational College who is trained to take fingerprints. The Dan Marino Foundation Florida Vocational College shall submit the fingerprints to the Department of Law Enforcement for state processing and the Federal Bureau of Investigation for federal processing.
- 2.a. The applicant or employee shall, under penalty of perjury, attest to the minimum standards for good moral character as provided in chapter 435, Florida Statutes, using the level 2 standards set forth in that chapter.
- b. New personnel shall be on probationary status pending a determination of compliance with such minimum standards for good moral character. This sub-subparagraph is in addition to any probationary status provided for by state law or rules or collective bargaining contracts of the Dan Marino Foundation Florida Vocational College.

(c) The Dan Marino Foundation Florida Vocational College shall review the record of the applicant or employee with respect to the crimes described in s. 435.04, Florida Statutes, and shall notify the applicant or employee of its findings. When disposition information is missing on a criminal record, it shall be the responsibility of the applicant or employee, upon request of the Dan Marino Foundation Florida Vocational College, to obtain the missing disposition information and supply such information within 30 days to the Dan Marino Foundation Florida Vocational College. Failure to supply missing information within 30 days or to show reasonable efforts to obtain such information shall result in automatic disqualification of an applicant and automatic termination of an employee.

- (d) After an initial personnel screening and security background investigation, written notification shall be given to the affected employee within a reasonable time prior to any subsequent screening and investigation.
- (e) The Dan Marino Foundation Florida Vocational College may grant exemptions from disqualification as provided in s. 435.07, Florida Statutes.
- (f) The Dan Marino Foundation Florida Vocational College may not use the criminal records, private investigator findings, or information from reference checks obtained by the school pursuant to this section for any purpose other than determining whether a person meets the minimum standards for good moral character for personnel employed by the school.
- (g) It is a misdemeanor of the first degree, punishable as provided in s. 775.082 or s. 775.083, Florida Statutes, for any person willfully, knowingly, or intentionally to:

1. Fail, by false statement, misrepresentation, impersonation, or other fraudulent means, to disclose in any application for voluntary or paid employment a material fact used in making a determination as to such person's qualifications for a position of special trust.

- 2. Use the criminal records, private investigator findings, or information from reference checks obtained under this section or information obtained from such records or findings, or to release such information or records to any person, for purposes other than screening for employment.
 - (8) CAMPUS POLICE.—
- (a) The Board of Trustees for the Dan Marino Foundation
 Florida Vocational College is permitted and empowered to employ
 police officers for the school. Such officers must be designated
 as the Dan Marino Foundation Florida Vocational College campus
 police.
- (b) Each Dan Marino Foundation Florida Vocational College campus police officer is a law enforcement officer of the state and a conservator of the peace who has the authority to arrest, in accordance with the laws of this state, any person for a violation of state law or any applicable county or municipal ordinance if that violation occurs on or in any property or facility of the school. A campus police officer may also arrest a person off campus for a violation committed on campus after a hot pursuit of that person that began on campus. A campus police officer shall have full authority to bear arms in the performance of the officer's duties and carry out a search pursuant to a search warrant on the campus. The Dan Marino Foundation Florida Vocational College campus police, upon

request of the sheriff or local police authority, may serve subpoenas or other legal process and may make arrests of persons against whom arrest warrants have been issued or against whom charges have been made for violations of federal or state laws or county or municipal ordinances. Campus police officers may enforce traffic laws within the boundaries of the campus in accordance with chapter 316, Florida Statutes.

- (c) The campus police shall promptly deliver any person arrested and charged with a felony to the sheriff of the county in which the school is located and any person arrested and charged with a misdemeanor to the applicable authority as provided by law or to the sheriff of the county in which the school is located.

A campus police officer employed by the board of trustees must have completed the training required by the school in the special needs of and proper procedures for dealing with students served by the school.

- (9) REPORT OF CAMPUS CRIME STATISTICS. -
- (a) The school shall prepare an annual report of statistics of crimes committed on its campus and shall submit the report to the board of trustees and the Commissioner of Education. The data for the report may be taken from the annual report of the Department of Law Enforcement. The board of trustees shall prescribe the form for submission of the report.
- (b) The school shall prepare an annual report of statistics of crimes committed on its campus for the preceding 3 years. The school shall give students and prospective students notice that this report is available upon request.

Section 2. Subsection (5) is added to section 1000.04, Florida Statutes, to read:

The office shall have
