485 (e) Funding model for exceptional student education
486 programs.—

487 1.a. The funding model uses basic, at-risk, support levels
488 IV and V for exceptional students and career Florida Education
489 Finance Program cost factors, and a guaranteed allocation for
490 exceptional student education programs. Exceptional education
491 cost factors are determined by using a matrix of services to
492 document the services that each exceptional student will
493 receive. The nature and intensity of the services indicated on
494 the matrix shall be consistent with the services described in
495 each exceptional student's individual educational plan. The
496 Department of Education shall review and revise the descriptions
497 of the services and supports included in the matrix of services
498 for exceptional students and shall implement those revisions
499 before the beginning of the 2012-2013 school year.

500 b. In order to generate funds using one of the two
501 weighted cost factors, a matrix of services must be completed at
502 the time of the student's initial placement into an exceptional
503 student education program and at least once every 3 years by
504 personnel who have received approved training. Nothing listed in

508 c. Students identified as exceptional, in accordance with

510 matrix of services as specified in sub-subparagraph b. shall
511 generate funds on the basis of full-time-equivalent student
512 membership in the Florida Education Finance Program at the same
513 funding level per student as provided for basic students.

514 Additional funds for these exceptional students will be provided
515 through the guaranteed allocation designated in subparagraph 2.

516 2. For students identified as exceptional who do not have
517 a matrix of services and students who are gifted in grades K
518 through 8, there is created a guaranteed allocation to provide
519 these students with a free appropriate public education, in
520 accordance with s. 1001.42(4)(1) ~~1001.42(4)(m)~~ and rules of the
521 State Board of Education, which shall be allocated annually to
522 each school district in the amount provided in the General
523 Appropriations Act. These funds shall be in addition to the
524 funds appropriated on the basis of FTE student membership in the

536 district or a full-time virtual instruction program is ~~shall be~~
537 eligible to report full-time equivalent student membership in

539 provided the following conditions are met:

540 1. The school district or the full-time virtual
541 instruction program has a plan approved by the Department of
542 Education.

543 2. The eligible student is identified and assessed as
544 limited English proficient based on assessment criteria.

545 3.a. An eligible student may be reported for funding in
546 the ESOL program for a base period of 3 years. However, a
547 student whose English competency does not meet the criteria for

564 (11) VIRTUAL EDUCATION CONTRIBUTION.—The Legislature may
565 annually provide in the Florida Education Finance Program a
566 virtual education contribution. The amount of the virtual
567 education contribution shall be the difference between the
568 amount per FTE established in the General Appropriations Act for
569 virtual education and the amount per FTE for each district and
570 the Florida Virtual School, which may be calculated by taking
571 the sum of the base FEFP allocation, the discretionary local
