b. If more than $45 \frac{25}{25}$ percent of the sum of total tax credits initially certified and awarded to productions after April July 1, 2012, 2010, and total tax credits initially certified after April 1, 2012, but not yet awarded, and total tax credits available for certification after April 1, 2012, but not yet certified to productions currently in this state has been awarded for high-impact television series, then no highimpact television series is or pilot shall be eligible for tax



credits under this subparagraph. Tax credits initially certified for a high-impact television series after April 1, 2012, may not be awarded if the award will cause the percentage threshold in this sub-subparagraph to be exceeded. This sub-subparagraph does not prohibit the award of tax credits certified before April 1, 2012, for high-impact television series.
