# I. Summary:

SB 240 allows the Department of Highway Safety and Motor Vehicles (DHSMV) to accept a military personnel identification card as proof of identity for issuing a driver license or identification card.

#### II. Present Situation:

### **REAL ID Act of 2005**

The REAL ID Act became effective nationwide on May 11, 2008. The Act establishes minimum standards for the issuance of state driver licenses and identification cards. The Act prohibits Federal agencies from accepting driver licenses and identification cards for official uses<sup>1</sup> if the United States Department of Homeland Security (DHS) has determined the state does not meet the minimum standards.

Individuals without a license from a compliant jurisdiction may present alternative forms of identification accepted by a federal agency, such as a U.S. Passport. Agencies may have additional processes to accommodate individuals lacking the prescribed identification documents.<sup>2</sup>

# Florida's Compliance with the REAL ID Act<sup>4</sup>

Florida began issuing REAL ID compliant driver licenses and identification cards on January 4, 2010. The REAL ID-compliant credentials have a star in the upper right corner of the card. According to the DHSMV, over 11.5 million individuals have met the new identity standards for a Florida driver license or identification card. Florida currently has a 70 percent compliance rate with the REAL ID Act.

## Identity Standards for Issuance of a Driver License or Identification Card

In Florida, each applicant for a driver license or identification card must show proof of identity satisfactory to the DHSMV.<sup>6</sup> Such proof must include one of the following documents issued to the applicant<sup>7</sup>:

- A certified copy of a U.S. birth certificate;
- A valid, unexpired U.S. passport;
- A naturalization certificate issued by the DHS;
- A valid, unexpired alien registration receipt card (green card);
- A Consular Report of Birth Abroad provided by the U.S. Department of State;
- An unexpired employment authorization card issued by the DHS; or
- Proof of nonimmigrant classification provided by the DHS.

The DHSMV is able to electronically verify each document and clearly establish the holder's citizenship status.

## Military Personnel Identification Cards

The Department of Defense (DoD) issues two main types of military identification cards. The Common Access Card is the standard identification for active duty uniformed service personnel, Selected Reserve, DoD civilian employees, and eligible contractor personnel.<sup>8</sup> The Uniformed

Services ID Card is held by retired military and military family members. The card is necessary for retired military and military family members to access military service benefits and privileges.<sup>9</sup>

Military personnel identification cards are not listed as an accepted form of proof of identification for the issuance of a REAL ID-compliant driver license or identification card. <sup>10</sup> The DoD's Common Access Card was considered and rejected as proof of identity for REAL ID compliance. <sup>11</sup> The DHS believes that any holder of a Common Access Card has access to one of the acceptable documents for proof of identity. Additionally, including the Common Access Card as an accepted form of identification documentation would require the DHS to allow states to access Federal databases they currently cannot access. <sup>12</sup>

# III. Effect of Proposed Changes:

The bill allows the DHSMV to accept an active or retired military personnel identification card issued by the United States Government as proof of identity for issuing a driver license or identification card.

Military personnel identification cards are not accepted forms of identification for issuing REAL ID-compliant driver licenses and identification cards. Passage of the bill as currently drafted could result in Florida not being in compliance with the REAL ID Act.

The bill takes effect upon becoming law.
