SUMMARY ANALYSIS

Since 1955, the College Board's Advanced Placement (AP) has enabled millions of student to take college-level courses and earn college credit, advanced placement credit or both while still in high school. The AP Capstone is a diploma program offered by the College Board and is based on two year-long AP courses: AP Seminar and AP Research. These courses are designed to complement other AP courses that the AP Capstone student may take. Students typically take the AP Seminar course in grade 10 or 11, followed by the AP Research course. The AP Seminar course is a prerequisite for AP Research.

The bill provides for school districts to receive additional funding through the Florida Education Finance Program (FEFP) for each student who receives an Advanced Placement Capstone Diploma in addition to a standard high school diploma.

The bill would have a fiscal impact based on the number of AP Capstone diplomas awarded. This impact will be incorporated into the overall Florida Education Finance Program (FEFP). See Fiscal Comments.

The bill has an effective date of July 1, 2019.

FULL ANALYSIS

I. SUBSTANTIVE ANALYSIS

A. EFFECT OF PROPOSED CHANGES:

Current Situation

The Advance Placement Program (AP) allows academically prepared students to pursue college-level studies while still in high school. There are 38 AP courses in seven subject areas. The exams are scored on a scale of 1 to 5, with college credit awarded for AP Exam scores of 3 or higher.¹

Currently, AP students who score a 3 or higher on the College Board AP Exam in the prior year generate a value of 0.16 full-time equivalent (FTE) bonus amount in the Florida Education Finance Program (FEFP) calculation for the subsequent fiscal year. Each school district must allocate at least 80% of the funds to the high school that generates the funds.² The school district must distribute to each classroom teacher who provided the AP instruction as follows:

- A \$50 bonus for each student taught by the AP teacher in each AP course who receives a score
 of 3 or higher on the College Board AP Exam.
- An additional \$500 to each AP teacher in a school designated with a grade of "D" or "F" who
 has at least one student scoring 3 or higher on the College Board AP Exam, regardless of the
 number of classes taught or of the number of student scoring a 3 or higher on the College
 Board AP Exam.³

Bonuses awarded shall be in addition to any regular wage or other bonus the classroom teacher received or is scheduled to receive. The Fiscal Year 2018-2019 third calculation of the Florida Education Finance Program (FEFP) includes over 29,000 add-on weighted FTE for the AP program.⁴

In 2014 the College Board established the AP Capstone diploma program to provide students with independent research, collaborative teamwork, and communication skills. The AP Capstone diploma program is based on two year-long AP courses: AP Seminar and AP Research. These courses are designed to complement the other AP courses taken by an AP Capstone student. Students typically take the AP Seminar course in grade 10 or 11, followed by the AP Research course. The AP Seminar course is a prerequisite for the AP Research course.

The AP Seminar course allows students to investigate real-world issues from multiple perspectives. Students learn to combine information from different sources, develop their own views in research-based written essays, and design and deliver oral and visual presentations, both individually and as part of a team. The AP Research course allows students to explore an academic topic, problem, or issue of interest to them. Students design, plan, and conduct a yearlong research-based investigation to address a research question, documenting their process with a portfolio.⁶

Students who earn a score of 3 or higher on the College Board AP Exams for the AP Seminar course and the AP Research course plus earn a score of 3 or higher on four additional College Board AP Exams of their choosing receive the AP Capstone Diploma. The AP Capstone diploma program

signifies that the student has completed a certain set of requirements in high school to earn an advanced diploma in addition to the standard high school diploma.

The Department of Education provided the following number of Capstone Diplomas awarded, as reported by the College Board:

• 2018 Graduated: 871 AP Capstone Diplomas

• 2017 Graduates: 559 AP Capstone Diplomas

2016 Graduates: 201 AP Capstone Diplomas⁸

Effect of Proposed Changes

The bill provides a 0.30 full-time equivalent (FTE) add-on bonus amount to be generated by students that graduate with the AP Capstone Diploma.

B. SECTION DIRECTORY:

Section 1. Amends 1011.62, Florida Statutes, revising the annual allocation to school districts to include an additional calculation of full-time equivalent membership for students who earn a College Board Advanced Placement (AP) Capstone Diploma.

Section 2: Provides an effective date of July 1, 2019.

There were 871 AP Capstone diplomas awarded to Florida AP students in Fiscal Year 2017-2018. Based on this data, and applying the Fiscal Year 2017-2018 base student allocation of \$4,203.95 multiplied by 0.30 FTE and then multiplied by the 871 students equals \$1,098,492. Based on the number of AP Capstone diplomas awarded in Fiscal Year 2019-2020, the Florida Education Finance Program would be redistributed to accommodate these students.
