

1 A bill to be entitled
 2 An act relating to transportation facility
 3 designations; providing honorary designations of
 4 certain transportation facilities in specified
 5 counties; amending ch. 2014-228, Laws of Florida;
 6 revising an honorary designation of a certain
 7 transportation facility in a specified county;
 8 directing the Department of Transportation to erect
 9 suitable markers; providing an effective date.

 11 Be It Enacted by the Legislature of the State of Florida:

 13 Section 1. Transportation facility designations;
 14 Department of Transportation to erect suitable markers.-

15 (1) That portion of I-75 (26260000) between mile markers
 16 399 and 404 in Alachua County is designated as "Sergeant William
 17 T. Bishop Memorial Highway."

18 (2) That portion of I-10 (27090000) between mile markers
 19 327 and 332 in Baker County is designated as "Trooper Sherman L.
 20 Scott, Jr., Memorial Highway."

21 (3) That portion of Babcock Street (70012000) between
 22 Malabar Road and Palm Bay Road in Brevard County is designated
 23 as "Trooper Joseph Sawtell, Jr., Memorial Highway."

24 (4) That portion of U.S. 1 (70030000) between E. Main
 25 Street and Parrish Road in Brevard County is designated as

26 "Trooper Halley Strickland Memorial Highway."

27 (5) That portion of I-95 (86070000) between the N.E. 48th
 28 Street overpass and S.W. 10th Street in Broward County is
 29 designated as "Trooper Phillip Black and Corporal Donald Irwin
 30 Memorial Highway."

31 (6) That portion of I-75 (03175000) between mile markers
 32 100 and 102 in Collier County is designated as "Trooper Lindell
 33 J. Gibbons Memorial Highway."

34 (7) That portion of I-75 (29180000) between mile markers
 35 418 and 423 in Columbia County is designated as "Sergeant George
 36 A. Brown, III, Memorial Highway."

37 (8) That portion of U.S. 19 (30010000) between C.R. 351A
 38 and S.W. 307th Avenue in Dixie County is designated as
 39 "Patrolman Royston E. Walker Memorial Highway."

40 (9) That portion of U.S. 90 (72010000) between Yellow
 41 Water Road and Log Road in Duval County is designated as
 42 "Trooper Robert P. McDermon Memorial Highway."

43 (10) That portion of U.S. 301 (72140000) between U.S. 90
 44 and Summer Field Lane in Duval County is designated as "Trooper
 45 Edwin J. Gasque Memorial Highway."

46 (11) That portion of U.S. 29/S.R. 95 (48040000) between
 47 Neal Road and Nine Mile Road in Escambia County is designated as
 48 "Trooper Milan D. Hendrix Memorial Highway."

49 (12) The interchange on I-10 (55320023) at U.S. 90/S.R.
 50 10/Mahan Drive in Leon County is designated as "Trooper William

51 'Bill' H. Dyer Memorial Interchange."

52 (13) That portion of U.S. 41 (13121000) between Tallevast
 53 Road in Manatee County and the Sarasota County line is
 54 designated as "Sergeant John C. Baxter, Jr., Memorial Highway."

55 (14) That portion of I-75 (36210000) between mile markers
 56 340 and 344 in Marion County is designated as "Trooper Chelsea
 57 Richard Memorial Highway."

58 (15) That portion of U.S. 1/S.R. 5 (87020000) between S.R.
 59 821/Homestead Extension of Florida's Turnpike and S.W. 216th
 60 Street in Miami-Dade County is designated as "Trooper Luther P.
 61 Daniel Memorial Highway."

62 (16) That portion of S.R. 821/Homestead Extension of
 63 Florida's Turnpike (87471000) between mile markers 13 and 16 in
 64 Miami-Dade County is designated as "Trooper Alvin V. Kohler
 65 Memorial Highway."

66 (17) That portion of S.R. 836 (87200000) between N.W. 12th
 67 Avenue and N.W. 27th Avenue in Miami-Dade County is designated
 68 as "Trooper Bradley S. Glascock Memorial Highway."

69 (18) That portion of S.R. 836 (87200000) between N.W. 42nd
 70 Avenue and N.W. 72nd Avenue in Miami-Dade County is designated
 71 as "Trooper Elmer C. Barnett Memorial Highway."

72 (19) The interchange at I-195 (87004000) and S.R.
 73 907/Alton Road in Miami-Dade County is designated as "Trooper
 74 Owen K. Bender Memorial Interchange."

75 (20) That portion of U.S. 441 (75010000) between

76 Landstreet Road and Taft Vineland Road in Orange County is
 77 designated as "Trooper Richard Howell Memorial Highway."
 78 (21) That portion of S.R. 91/Florida's Turnpike (93470000)
 79 between mile markers 100 and 105 in Palm Beach County is
 80 designated as "Troopers Herman T. Morris and Frederick J.
 81 Groves, Jr., Memorial Highway."
 82 (22) That portion of I-4 (16320000) between mile markers
 83 36 and 44 in Polk County is designated as "Trooper John C.
 84 Hagerty Memorial Highway."
 85 (23) That portion of W. 1st Street (77030000) between
 86 French Avenue and S. Mellonville Avenue in Seminole County is
 87 designated as "Patrolman Leroy Bender Memorial Highway."
 88 (24) That portion of I-95 (78080000) between mile markers
 89 332 and 327 in St. Johns County is designated as "Trooper
 90 Wilburn A. Kelly Memorial Highway."
 91 (25) That portion of U.S. 1 (78010000) between S.R. 207
 92 and the Matanzas River in St. Johns County is designated as
 93 "Troopers Merle J. Cook, Robert L. Pruitt, and Cleo L.
 94 Tomlinson, Jr., Memorial Highway."
 95 (26) That portion of I-75 (12075000) between mile markers
 96 130 and 133 in Lee County is designated as "Lieutenant Daniel
 97 Hinton Memorial Highway."
 98 (27) Upon completion of construction, the interchange at
 99 I-95 and S.R. 200 in Nassau County is designated as "Fallen Hero
 100 Specialist Kelly J. Mixon Interchange."

101 (28) That portion of South Street between U.S. 1 and S.R.
 102 50 in Brevard County is designated as "Martin Luther King, Jr.,
 103 Boulevard."

104 (29) That portion of U.S. 41/S.W. 8th Street between S.W.
 105 82nd Avenue and S.R. 973/87th Avenue in Miami-Dade County is
 106 designated as "Manuel H. 'Manny' Piedra Memorial Highway."

107 (30) That portion of 37th Avenue between N.W. 11th Street
 108 and N.W. 2nd Street in Miami-Dade County is designated as
 109 "Florence Hecht Lane."

110 (31) That portion of S.R. A1A between Bridge Road and
 111 Fountain Street in Miami-Dade County is designated as "Robert L.
 112 Shevin Way."

113 (32) Upon completion of construction, the interchange at
 114 the Homestead Extension of Florida's Turnpike/S.R. 821 and N.W.
 115 170th Street in Miami-Dade County is designated as "Countyline
 116 Parkway."

117 (33) The intersection of S.W. 8th Street and S.W. 14th
 118 Avenue in Miami-Dade County is designated as "Manuel A. Gonzalez
 119 Plaza."

120 (34) That portion of S.W. 1st Street/S.R. 968 between 21st
 121 Avenue and 20th Avenue in Miami-Dade County is designated as
 122 "Jorge P. Castano Way."

123 (35) That portion of the Coast-to-Coast Connector in
 124 Brevard County is designated as "Kurt Eichin Memorial Trail."

125 (36) That portion of I-75 between mile markers 23 and 27

126 (Alligator Alley) in Broward County is designated as "Sergeant
 127 Steven G. Greco Memorial Highway."

128 (37) That portion of N.W. 53rd Street between Hiatus Road
 129 and N.W. 103rd Avenue in Broward County is designated as "Edith
 130 Lederberg Lane."

131 (38) That portion of S.R. 535 between S.R. 526 in Orange
 132 County and the Osceola County line is designated as "Robert L.
 133 'Bob' Billingslea Highway."

134 (39) The Department of Transportation is directed to erect
 135 suitable markers designating the transportation facilities as
 136 described in this section.

137 Section 2. Section 7 of chapter 2014-228, Laws of Florida,
 138 is amended to read:

139 Section 7. Brigadier General ~~Colonel~~ Bud Day Overpass
 140 designated; Department of Transportation to erect suitable
 141 markers.—

142 (1) The Hurlburt Field Air Force Base overpass on U.S. 98
 143 in Okaloosa County is designated as "Brigadier General ~~Colonel~~
 144 Bud Day Overpass."

145 (2) The Department of Transportation is directed to erect
 146 suitable markers designating Brigadier General ~~Colonel~~ Bud Day
 147 Overpass as described in subsection (1).

148 Section 3. This act shall take effect July 1, 2019.
