Section 1. Paragraph (a) of subsection (3) of section 119.071, Florida Statutes, is amended to read:

- 119.071 General exemptions from inspection or copying of public records.—
 - (3) SECURITY AND FIRESAFETY.-
- (a)1. As used in this paragraph, the term "security or firesafety system plan" includes all:
 - a. Records, information, photographs, audio and visual

presentations, schematic diagrams, surveys, recommendations, or consultations or portions thereof relating directly to the physical security or firesafety of the facility or revealing security or firesafety systems;

- b. Threat assessments conducted by any agency or any private entity;
 - c. Threat response plans;
 - d. Emergency evacuation plans;
 - e. Sheltering arrangements; or
- f. Manuals for security or firesafety personnel, emergency equipment, or security or firesafety training.
- 2. A security or firesafety system plan or portion thereof for:
- a. Any property owned by or leased to the state or any of its political subdivisions; or
 - b. Any privately owned or leased property

held by an agency is confidential and exempt from s. 119.07(1) and s. 24(a), Art. I of the State Constitution. This exemption is remedial in nature, and it is the intent of the Legislature that this exemption apply to security or firesafety system plans held by an agency before, on, or after April 6, 2018 the effective date of this paragraph.
