# SPECIAL ORDER CALENDAR FOR WEDNESDAY, APRIL 6, 2011

### SB 2000 (SO) by the Committee on Budget-

**Appropriations;** Provides moneys for the annual period beginning July 1, 2011, and ending June 30, 2012, to pay salaries, and other expenses, capital outlay - buildings, and other improvements, and for other specified purposes of the various agencies of state government. Effective Date: 07/01/2011 OR except as otherwise provided

### SB 2002 (SO) by the Committee on Budget—

Implementing 2011-2012 General Appropriations Act; Incorporates by reference certain calculations of the Florida Education Finance Program for the 2011-2012 fiscal year. Authorizes the transfer of funds between appropriation categories to fund fixed capital outlay projects for public schools upon certain approval. Provides allocation requirements for specified funds appropriated for forensic mental health services. Provides requirements relating to implementing phase 3 of the Department of Health's Florida Onsite Sewage Nitrogen Reduction Strategies Study, etc. Effective Date: 06/29/2011 OR except as otherwise provided

### SB 2120 (SO) by the Committee on Budget—

K-12 Education Funding; Authorizes the Department of Revenue to provide certain information regarding the gross receipts tax to the State Board of Education, the Division of Bond Finance, and the Office of Economic and Demographic Research. Requires that, for purposes of servicing public education capital outlay bonds, the State Board of Education disregard the effects on the gross receipts tax revenues collected during a tax period of a refund resulting from a specified settlement agreement, etc. Effective Date: upon becoming a law, except as otherwise provided

### SB 2150 (SO) by the Committee on Budget—

Postsecondary Education Funding; Authorizes the Department of Revenue to provide certain information regarding the gross receipts tax to the State Board of Education, the Division of Bond Finance, and the Office of Economic and Demographic Research. Requires that, for purposes of servicing public education capital outlay bonds, the State Board of Education disregard the effects on the gross receipts tax revenues collected during a tax period of a refund resulting from a specified settlement agreement, etc. Effective Date: upon becoming a law, except as otherwise provided

### SB 2114 (SO) by the Committee on Budget—

Juvenile Justice; Provides legislative intent. Defines the term "regional coordinating agency." Provides requirements for a regional coordinating agency. Requires the Department of Juvenile Justice to contract with regional coordinating agencies for specified services relating to juvenile justice. Gives hiring preference to current department employees who meet provider qualifications if they apply for employment with the regional coordinating agencies, etc. Effective Date: 07/01/2011

### SB 2116 (SO) by the Committee on Budget—

State Judicial System; Creates the Judicial Caseload Incentive Plan. Prescribes the purpose of the plan. Provides for performance goals for each judicial circuit. Authorizes financial awards to certain judges based on the performance of the circuit in meeting the goals. Authorizes each office of criminal conflict and civil regional counsel to create a direct-support organization. Prescribes requirements related to the creation and operation of the direct-support organization, etc. Effective Date: 07/01/2011

### SB 2118 (SO) by the Committee on Budget—

Criminal Justice; Repeals provisions relating to the Cybercrime Office within the Department of Legal Affairs. Limits the number of hours in the basic recruit training program required for correctional officers, unless the officer is otherwise exempt. Creates the Cybercrime Office within the Department of Law Enforcement to investigate certain violations of state law pertaining to the sexual exploitation of children. Repeals provisions relating to the basic training program for youthful offenders within the Department of Corrections, etc. Effective Date: 07/01/2011

### SB 2112 (SO) by the Committee on Budget—

Juvenile Detention Facilities; Exempts a county that covers the costs of detention care for pre-adjudicated juveniles within its jurisdiction or other jurisdictions from certain requirements for sharing the costs for juvenile detention. Provides that a county or county sheriff that meets certain prerequisites with respect to the operation of its juvenile detention facility is exempt from certain requirements of law governing the administration of such facilities. Authorizes a county or county sheriff to operate regional detention facilities, etc. Effective Date: 07/01/2011

### SB 2144 (SO) by the Committee on Budget—

**Medicaid;** Provides for funding the Medicaid reimbursement for certain persons age 65 or older while the optional program is being phased out. Renames the "medically needy" program as the "Medicaid nonpoverty medical subsidy." Limits certain categories of persons eligible for the subsidy to only physician services after a certain date. Deletes the hospitalist program. Revises the factors for calculating the maximum allowable fee for pharmaceutical ingredient costs. Directs the AHCA to establish reimbursement rates for the next fiscal year, etc. Effective Date: 06/30/2011

### SB 2146 (SO) by the Committee on Budget—

Department of Children and Family Services; Revises provisions relating to the department's duties with respect to domestic violence. Provides that annual certification of domestic violence centers depends on a favorable review by the Florida Coalition Against Domestic Violence. Authorizes the coalition to enter and inspect centers for monitoring purposes. Requires the department to contract with the coalition for the management of domestic violence service delivery and the monitoring of centers, etc. Effective Date: 07/01/2011

### SB 2148 (SO) by the Committee on Budget—

Agency for Persons With Disabilities; Prohibits the agency from expending funds above the amount appropriated in the General Appropriations Act. Requires that the agency monitor monthly program expenditures and provide quarterly reports to the Governor and Legislature. Effective Date: upon becoming a law

### SB 2122 (SO) by the Committee on Budget-

Consumer Protection; Removes the Division of Dairy Industry within the Department Agriculture and Consumer Services. Requires the Department of Legal Affairs, rather than the Department of Agriculture and Consumer Services, to distribute free of charge a motor vehicle consumer's rights pamphlet. Provides for the state attorneys and the Department of Legal Affairs, rather than the Department of Agriculture and Consumer Services, to enforce the law prohibiting price gouging, etc. Effective Date: 07/01/2011

### SB 2124 (SO) by the Committee on Budget—

**Department of Revenue**; Extends from once every 2 years to once every 3 years the requirement that the department conduct an in-depth review of the assessment roll of each county. Provides for a study of certain classifications constituting 5 percent or more of the total assessed value of real property on the previous assessment roll. Imposes a tax on the charges for the use of coin-operated amusement machines operated on the licensed premises of a pari-mutuel facility located in certain cities or counties, etc. Effective Date: 07/01/2011

### SB 2126 (SO) by the Committee on Budget-

Department of Management Services; Provides for the reimbursement to the department of actual costs for coordinating the Florida State Employee's Charitable Campaign. Requires the cost factors for a fixed capital outlay project to include an estimate for the finishing of interiors. Requires that cost savings realized when actual costs are less than the projected costs for a fixed capital outlay project be used to reduce the overall construction costs. Prohibits the purchase of art using public funds except as authorized by law, etc. Effective Date: 07/01/2011

### SB 2128 (SO) by the Committee on Budget—

**Public Employees Relations Commission;** Requires that the commission be composed of a chair and two part-time members rather than two full-time members. Provides for the chair of the commission to remain as a full-time appointment. ### SB 2130 (SO) by the Committee on Budget—

**Pollution Control**; Revises requirements for the deposit of funds used in providing financial assistance for water pollution control. Requires that such funds be deposited into the department's Federal Grants Trust Fund rather than the department's Grants and Donations Trust Fund. Specifies additional uses of moneys deposited into the Federal Grants Trust Fund. Effective Date: 07/01/2011

### SB 2132 (SO) by the Committee on Budget—

Department of Financial Services; Repeals provisions relating to the Chief Financial Officer's authorization to operate a personal check-cashing service or a remote financial service unit at the capitol and to employ additional persons to assist in performing such services. Abolishes appropriations from the General Revenue Fund to pay the salaries of the additional employees. Revises the duties of the Division of Consumer Services. Revises the criteria for premiums charged to agencies and departments for purposes of the State Risk Management Trust Fund, etc. Effective Date: 07/01/2011

### SB 2134 (SO) by the Committee on Budget-

Citizens Property Insurance Corporation; Repeals provisions relating to the procurement of goods and services by the corporation. Provides standards for procurements by Citizens Property Insurance Corporation. Requires the corporation's legal department and purchasing department to jointly prepare a contract for the procurement of goods or services. Includes a board member or an employee of the corporation within the definition of the term "public servant" as it relates to the crime of bribery and the misuse of public office, etc. Effective Date: 01/01/2012

### SB 2136 (SO) by the Committee on Budget—

Federal Grants Trust Fund/DBPR; Creates the Federal Grants Trust Fund within the Department of Business and Professional Regulation. Provides for the purpose of the trust fund and sources of funds. Provides for future review and termination or re-creation of the trust fund. Effective Date: July 1, 2011, if enacted by three-fifths vote of membership of Legislature

### SB 2142 (SO) by the Committee on Budget—

Water Management Districts; Provides requirements with respect to revenues received by each water management district and the unexpended balances of a district's local account. Requires that each district's expenditure of funds be as provided in the General Appropriations Act. Provides for a contingency if a court finds such restriction to be invalid. Provides that the Legislature may annually set the amount of revenue a district may raise through its ad valorem tax authority, etc. Effective Date: upon becoming a law

### SB 2152 (SO) by the Committee on Budget—

**Transportation**; Provides additional funds for 5 years to fund certain projects through the Florida Deepwater Seaport Program. Specifies that certain statutory provisions related to special matters to be considered in rule adoption do not apply to the adjustment of toll rates. Transfers control of the Tampa-Hillsborough County Expressway Authority, the Orlando-Orange County Expressway Authority, and the Mid-Bay Bridge Authority systems to the Florida Turnpike Enterprise, etc. Effective Date: 07/01/2011

### SB 2154 (SO) by the Committee on Budget—

Florida Housing Finance Corporation; Deletes provisions on the distributions of documentary stamp tax revenues to the State Housing Trust Fund and the Local Government Housing Trust Fund. Replaces references to the Department of Community Affairs with Jobs Florida. Provides for the deposit of certain moneys into the State Housing Trust Fund within the State Treasury. Replaces references to the Secretary of the Department of Community Affairs with the Commissioner of Jobs Florida. Provides for certain moneys to be deposited into the State Housing Trust Fund, etc. Effective Date: 07/01/2011

### SB 2156 (SO) by the Committee on Budget-

Governmental Reorganization; Transfers the functions and trust funds of the Agency for Workforce Innovation to other agencies. Transfers the Office of Early Learning Services to the Department of Education. Transfers the Office of Unemployment Compensation to Jobs Florida. Transfers the Office of Workforce Services to Jobs Florida. Transfers the functions and trust funds of the Department of Community Affairs to other agencies. Transfers the Florida Housing Finance Corporation to Jobs Florida, etc. Effective Date: 07/01/2011

### SB 2160 (SO) by the Committee on Budget-

Department of Highway Safety and Motor Vehicles; Requires the department rather than the Division of Motor Vehicles to issue special motor vehicle license plates. Creates motor carrier weight inspection as an area of program responsibility within the Department of Transportation, which replaces motor carrier compliance. Revises the divisions within the Department of Highway Safety and Motor Vehicles. Creates the Office of Motor Carrier Compliance of the Division of the Florida Highway Patrol within the Department of Highway Safety and Motor Vehicles, etc. Effective Date: 07/01/2011

### SB 2162 (SO) by the Committee on Budget—

Welfare Transition Trust Fund/DOE; Creates the Welfare Transition Trust Fund within the Department of Education. Provides for sources of funds and purposes. Provides for the annual carryforward of funds. Provides for future review and termination or re-creation of the trust fund. Effective Date: July 1, 2011, if enacted by three-fifths vote of membership of Legislature

### SB 2094 (SO) by the Committee on Budget—

**State Employees;** Provides for the resolution of collective bargaining issues at impasse between the state and certified bargaining units of state employees. Effective Date: 07/01/2011

# CS/SB 1738 (SO) by the Committee on Governmental Oversight and Accountability and Senator Alexander—

State Financial Information; Requires the Auditor General to annually provide to the Legislature a list of school districts that have failed to comply with certain financial transparency requirements, as identified pursuant to audit. Establishes the Agency for Enterprise Business Services within the Department of Financial Services. Provides that the agency is headed by the Governor and Cabinet acting as the Financial Management Information Board. Establishes the Enterprise Financial Business Operations Council to act in an advisory capacity to the agency, etc. Effective Date: upon becoming a law

Reported favorably as a committee substitute by the Committee on Governmental Oversight and Accountability; and the Committee on Budget reports the committee substitute favorably

### SB 2096 (SO) by the Committee on Budget—

State Financial Information; Requires the Auditor General to annually provide to the Legislature a list of school districts and water management districts that have failed to comply with certain financial transparency requirements, as identified pursuant to audit. Amends provisions relating to the Transparency Florida Act. Requires the Chief Financial Officer to develop and maintain the transparency website. Requires the fiscal year of each water management district to be July 1 to June 30, etc. Effective Date: upon becoming a law

### SB 2098 (SO) by the Committee on Budget—

Consolidation/State Information Technology Services; Establishes the Agency for Enterprise Information Technology in the Department of Management Services rather than the Executive Office of the Governor. Revises the duties of the agency to include the planning, project management, and implementation of the enterprise information technology services. Requires the agency to submit a plan to the Legislative Budget Commission for aggregating information technology purchases, etc. Effective Date: 07/01/2011

### SB 2100 (SO) by the Committee on Budget—

Retirement; Requires employee and employer contributions to the retirement system by a certain date. Redefines the terms "system," "prior service," "compensation," "average final compensation," "normal retirement date," "termination," "benefit," and "payee." Defines the term "division." Provides that special risk employee contributions be used, if applicable, when purchasing credit for past service. Revises the cost-of-living adjustment depending on the date of retirement, etc. Effective Date: 06/30/2011

### SB 2102 (SO) by the Committee on Budget—

Health Insurance Benefits for State Employees; Deletes references to TRICARE supplemental insurance plans. Deletes the Department of Management Services' authorization to contract with health maintenance organizations for participation in the state group insurance program. Authorizes the Department of Management Services to establish health maintenance incentive programs. Deletes the authority of state agencies to allow certain former personnel and their eligible dependents the option of continuing to participate in certain group insurance plans or self-insurance plans, etc. Effective Date: 07/01/2011

# CS/CS/SB 1292 (SO) by the Committees on Budget, Governmental Oversight and Accountability and Senator Alexander—

Chief Financial Officer; Requires the Chief Financial Officer to conduct workshops with state agencies, local governments, educational entities, and entities of higher education to gather information pertaining to uniform reporting requirements. Requires the Chief Financial Officer to accept comments from state agencies, local governments, educational entities, entities of higher education, and interested parties regarding proposed charts of account by a certain date, etc. Effective Date: 07/01/2011

Reported favorably as a committee substitute by the Committee on Governmental Oversight and Accountability; and reported favorably as a committee substitute by the Committee on Budget

### SB 2104 (SO) by the Committee on Budget—

Office of Drug Control; Relocates the Statewide Office for Suicide Prevention into the Department of Children and Family Services. Requires the director of the Statewide Office for Suicide Prevention to employ a coordinator for the office. Requires revenues from grants accepted by the Statewide Office for Suicide Prevention to be deposited into the Grants and Donations Trust Fund within the Department of Children and Family Services rather than the Executive Office of the Governor, etc. Effective Date: 07/01/2011

### SB 2106 (SO) by the Committee on Budget-

Florida Energy and Climate Commission; Eliminates the Florida Energy and Climate Commission and transfers its duties with respect to a tax credit, an incentive program, and the state's renewable energy policy to the Department of Environmental Protection. Repeals provisions relating to Florida Energy and Climate Commission. Transfers the duties of the Florida Energy and Climate Commission with respect to planning and developing the state's energy policy and its duties under the Florida Energy and Climate Protection Act to the Department of Environmental Protection, etc. Effective Date: 07/01/2011

### SB 2108 (SO) by the Committee on Budget-

Welfare of Children; Repeals provisions relating to the Office of Adoption and Child Protection within the Executive Office of the Governor. Requires all state, county, and local agencies to cooperate, assist, and provide information to the Department of Children and Family Services rather than the Office of Adoption and Child Protection. Repeals provisions relating to the definition of the term "office" as it relates to the Office of Adoption and Child Protection, etc. Effective Date: 07/01/2011

### SB 2110 (SO) by the Committee on Budget—

**Auditor General;** Requires that the Auditor General conduct operational audits at least every 3 years of certain additional state entities and district school boards and report on the activities of the ad valorem tax program of the Department of Revenue. Revises the duties of the Auditor General with respect to responsibilities for auditing certain reports made to the State Supreme Court and the operations of the Florida Clerks of Court Operations Corporation, respectively. Revises requirements to issue rules for surplus property, etc. Effective Date: 07/01/2011

# CS/CS/SB 1314 (SO) by the Committees on Budget, Governmental Oversight and Accountability and Senator Alexander—

State Financial Matters; Prohibits an agency or branch of state government, without legislative authority, from contracting to pay liquidated damages or early termination fees resulting from the breach or early termination of a contract or agreement, from paying interest because of insufficient budget authority to pay an obligation in the current year, from obligating the state to make future payments to cover unpaid payments, or from granting a party the right to collect fees or other revenues from nonparties. Provides that certain contracts are subject to transaction fees, etc. Effective Date: 07/01/2011

## CS/SB 400 (CC) by the Committee on Criminal Justice, Senator Wise and others—

Treatment-based Drug Court Programs; Requires all offenders sentenced to a postadjudicatory drug court program who are drug court participants and who are the subject of a violation of probation or community control hearing under specified provisions to have the violation of probation or community control heard by the judge presiding over the drug court program. Increases the number of Criminal Punishment Code scoresheet total sentence points that a defendant may have and be eligible for a postadjudicatory treatment-based drug court program, etc. Effective Date: 07/01/2011

Reported favorably as a committee substitute by the Committee on Criminal Justice; and the Committees on Judiciary; and Budget reports the committee substitute favorably

### SB 240 (CC) by Senator Joyner—

Violations of Injunctions for Protection; Adds circumstances that violate an injunction for protection against repeat violence, sexual violence, or dating violence. Effective Date: 07/01/2011

Reported favorably by the Committees on Criminal Justice; Judiciary; and Budget

### CS/SB 782 (CC) by the Committee on Transportation, Senator Latvala and others—

Fallen Officers Memorial/Road Designations; Designates the Sgt. Thomas J. Baitinger, Officer Jeffrey A. Yaslowitz, and Officer David S. Crawford Memorial Highway in Pinellas County. Designates the Officer Jeffrey A. Kocab and Officer David J. Curtis Memorial Highway in Hillsborough County. Effective Date: 07/01/2011

Reported favorably as a committee substitute by the Committee on Transportation; and the Committees on Budget Subcommittee on Transportation, Tourism, and Economic Development Appropriations; Budget; and Rules reports the committee substitute favorably

### CS/CS/SB 244 (CC) by the Committees on Health Regulation, Transportation and Senator Bennett—

Motor Vehicles/Highway Safety Act; Provides legislative intent relating to road rage and aggressive careless driving. Requires an operator of a motor vehicle to yield the left lane when being overtaken on a multilane highway. Specifies the amount of the fine and the allocation of moneys received from the increased fine imposed for aggressive careless driving. Requires the HSMV to provide information about the Highway Safety Act in driver's license educational materials, etc. Effective Date: 10/01/2011

### SB 330 (CC) by Senator Gaetz—

Requires that the commission adopt rules to provide for an expedited hearing for complaints filed with the commission. Requires that the Director of the Division of Administrative Hearings assign an administrative law judge to provide an expedited hearing in certain cases, etc. Effective Date: 07/01/2011

### SB 634 (CC) by Senator Simmons—

### CS/CS/SB 170 (CC) by the Committees on Budget Subcommittee on Criminal and Civil Justice Appropriations, Judiciary and Senator Bennett—

Electronic Filing and Receipt of Court Documents; Requires each state attorney and public defender to electronically file court documents with the clerk of the court and receive court documents from the clerk of the court. # CS/SB 382 (CC) by the Committee on Budget Subcommittee on Finance and Tax and Senator Bogdanoff—

## CS/SB 312 (CC) by the Committee on Health Regulation, Senator Richter and others—

**Practice of Dentistry;** Requires persons who apply for licensure renewal as a dentist or dental hygienist to furnish certain information to the Department of Health in a dental workforce survey. Requires the department to maintain a database regarding the state's dental workforce. ### CS/SB 968 (CC) by the Committee on Environmental Preservation and Conservation and Senator Dean—

**Boating Safety;** Provides an exemption from the requirement that certain persons must possess a boating safety identification card while operating a motor vessel of a specified horsepower or greater. Requires liveries to require that a person present a valid boater safety identification card or provide proof that the person passed the boating education safety course or examination. Effective Date: 07/01/2011

Reported favorably as a committee substitute by the Committee on Environmental Preservation and Conservation; and the Committees on Community Affairs; and Budget reports the committee substitute favorably

### CS/SB 960 (CC) by the Committee on Environmental Preservation and Conservation and Senator Bennett—

Liquefied Petroleum Gas; Prohibits the Department of Agriculture and Consumer Services and other state agencies from requiring compliance with certain national standards for liquefied petroleum gas tanks unless the department or agencies require compliance with a specified edition of the national standards. Provides for future expiration of such requirements. Revises the term "propane" for purposes of the Florida Propane Gas Education, Safety, and Research Act, to incorporate changes to certain national standards in a reference thereto. Effective Date: 07/01/2011

Reported favorably as a committee substitute by the Committee on Environmental Preservation and Conservation; and the Committees on Commerce and Tourism; and Budget reports the committee substitute favorably

## CS/SB 650 (CC) by the Committee on Regulated Industries, Senator Jones and others—

Mobile Home Park Lot Tenancies; Provides for local code and ordinance violations to be cited to the responsible party. Prohibits liens, penalties, fines, or other administrative or civil proceedings against one party or that party's property for a duty or responsibility of the other party. Revises procedures for mobile home owners being provided eviction notice due to a change in use of the land comprising the mobile home park or the portion thereof from which mobile homes are to be evicted, etc. Effective Date: upon becoming a law

### SB 1142 (CC) by Senator Dockery—

Adverse Possession; Specifies that occupation and maintenance of property satisfies the requirements for possession for purposes of gaining title to property via adverse possession without color of title. Requires that the property appraiser add certain information related to the adverse possession claim to the parcel information on the tax roll and prescribing conditions for removal of that information. Excludes property subject to adverse possession claims without color of title from provisions authorizing the tax collector not to send a tax notice for minimum tax bills, etc. Effective Date: 07/01/2011

### SB 702 (CC) by Senator Flores—

Umbilical Cord Blood Banking; Requires the Department of Health to post on its website certain resources and a website link to specified materials regarding umbilical cord blood banking. Requires the department to encourage certain health care providers to make available to their pregnant patients information related to umbilical cord blood banking. Provides that a health care provider or health care facility and its employees or agents are not liable for damages in a civil action, etc. Effective Date: 07/01/2011

## CS/SB 246 (CC) by the Committee on Health Regulation, Senator Joyner and others—

Human Trafficking; Requires operators of massage establishments to maintain valid work authorization documents on the premises for each employee who is not a United States citizen. Provides a limitation on the payment of fees and costs, etc. Effective Date: upon becoming a law

### SB 22 (2R) by Senator Hill-

Relief/Estate of Cesar Solomon/JTA; Compensates the Estate of Cesar Solomon for Mr. Solomon's death, which was the result of negligence by a bus driver of the Jacksonville Transportation Authority. Provides a limitation on the payment of fees and costs, etc. Effective Date: upon becoming a law

Recommended favorably by the Special Master on Claim Bills; and reported favorably by the Committee on Rules

### CS/SB 34 (2R) by the Committee on Rules and Senator

Relief/Angela Isham/City of Ft. Lauderdale; Compensates Angela Isham, individually, and as co-personal representative of the Estate of David Isham, deceased, for the death of Mr. Isham, which was due to the negligence of employees of the City of Ft. Lauderdale. Provides a limitation on the payment of fees and costs, etc. Effective Date: upon becoming a law

Recommended favorably, with one amendment, by the Special Master on Claim Bills; and reported favorably as a committee substitute by the Committee on Rules

### CS/SB 46 (2R) by the Committee on Rules and Senator Haridopolos—

Relief/William Dillon/State of Florida; Compensates William Dillon, who was wrongfully incarcerated for 27 years and exonerated by a court after DNA testing. Directs the Chief Financial Officer to draw a warrant for the purchase of an annuity. Provides for a waiver of certain tuition and fees. Provides conditions for payment. Provides that the act does not waive certain defenses or increase the state's liability, etc. Effective Date: upon becoming a law

Recommended favorably, with one amendment, by the Special Master on Claim Bills; and reported favorably as a committee substitute by the Committee on Rules

### CS/SB 70 (2R) by the Committee on Rules and Senator Negron—

### Relief/Carl Abbott/Palm Beach County School Board;

Compensates Carl Abbott for injuries sustained as a result of the negligence of the Palm Beach County School District. Provides a limitation on the payment of fees and costs, etc. Effective Date: upon becoming a law

Provides a limitation on the payment of fees and costs, etc. Effective Date: upon becoming a law

Recommended favorably by the Special Master on Claim Bills; and reported favorably by the Committee on Rules

### CS/SB 324 (2R) by the Committee on Rules and Senator Flores—

#### Relief/James D. Feurtado. III/Miami-Dade County:

Compensates James D. Feurtado, III, for injuries sustained as a result of the negligence of an employee of Miami-Dade County. Provides a limitation on the payment of fees and costs, etc. Effective Date: upon becoming a law

Recommended favorably by the Special Master on Claim Bills; and reported favorably as a committee substitute by the Committee on Rules

### SB 418 (2R) by Senator Flores-

**State Lotteries**; Requires each retailer of lottery tickets to provide assistance to any individual who is blind or visually impaired and has requested assistance in filling out his or her lottery ticket. Provides that a retailer or an employee of the retailer is not liable under certain circumstances, etc. Effective Date: 07/01/2011

Reported favorably by the Committees on Regulated Industries; Commerce and Tourism; and Rules

### SB 514 (2R) by Senator Garcia-

Vehicle Crashes Involving Death; Cites this act as the "Ashley Nicole Valdes Act." Requires a defendant who was arrested for leaving the scene of a crash involving death be held in custody until brought before a judge for admittance to bail in certain circumstances. Reenacts provision relating to the Criminal Punishment Code, to incorporate the amendments made to provision in a reference thereto. Effective Date: 10/01/2011

Reported favorably by the Committees on Criminal Justice; Judiciary; and Budget

### SB 626 (2R) by Senator Thrasher and others-

Shands Teaching Hospital and Clinics, Inc.; Clarifies provisions relating to references to the corporation known as Shands Teaching Hospital and Clinics, Inc. Clarifies provisions regarding the purpose of the corporation. Authorizes the corporation to create corporate subsidiaries and affiliates. Provides that Shands Teaching Hospital and Clinics, Inc., Shands Jacksonville Medical Center, Inc., Shands Jacksonville Healthcare, Inc., and any not-for-profit subsidiary of such entities are instrumentalities of the state for purposes of sovereign immunity. Effective Date: 07/01/2011

Reported favorably by the Committees on Health Regulation; Higher Education; and Budget

### SM 1344 (2R) by Senator Flores-

**U.S. Treasury/Deposits by Nonresident Aliens;** Urges the Congress of the United States to direct the Department of the Treasury to withdraw a proposed rule on deposits made by nonresident aliens and to examine the proposed rule for negative effects.

CS/CS/SB 1292 (2R1) by the Committees on Budget, Governmental Oversight and Accountability and Senator Alexander—

Chief Financial Officer; Requires the Chief Financial Officer to conduct workshops with state agencies, local governments, educational entities, and entities of higher education to gather information pertaining to uniform reporting requirements. Requires the Chief Financial Officer to accept comments from state agencies, local governments, educational entities, entities of higher education, and interested parties regarding proposed charts of account by a certain date, etc. Effective Date: 07/01/2011

Reported favorably as a committee substitute by the Committee on Governmental Oversight and Accountability; and reported favorably as a committee substitute by the Committee on Budget

### CS/CS/SB 1314 (2R1) by the Committees on Budget, Governmental Oversight and Accountability and Senator Alexander—

State Financial Matters; Prohibits an agency or branch of state government, without legislative authority, from contracting to pay liquidated damages or early termination fees resulting from the breach or early termination of a contract or agreement, from paying interest because of insufficient budget authority to pay an obligation in the current year, from obligating the state to make future payments to cover unpaid payments, or from granting a party the right to collect fees or other revenues from nonparties. Provides that certain contracts are subject to transaction fees, etc. Effective Date: 07/01/2011

Reported favorably as a committee substitute by the Committee on Governmental Oversight and Accountability; and reported favorably as a committee substitute by the Committee on Budget

### SB 2000 (2R1) by the Committee on Budget-

**Appropriations**; Provides moneys for the annual period beginning July 1, 2011, and ending June 30, 2012, to pay salaries, and other expenses, capital outlay - buildings, and other improvements, and for other specified purposes of the various agencies of state government. Effective Date: 07/01/2011 OR except as otherwise provided

### SB 2002 (2R1) by the Committee on Budget-

Implementing 2011-2012 General Appropriations Act; Incorporates by reference certain calculations of the Florida Education Finance Program for the 2011-2012 fiscal year. Authorizes the transfer of funds between appropriation categories to fund fixed capital outlay projects for public schools upon certain approval. Provides allocation requirements for specified funds appropriated for forensic mental health services. Provides requirements relating to implementing phase 3 of the Department of Health's Florida Onsite Sewage Nitrogen Reduction Strategies Study, etc. Effective Date: 06/29/2011 OR except as otherwise provided

### SB 2094 (2R1) by the Committee on Budget-

**State Employees;** Provides for the resolution of collective bargaining issues at impasse between the state and certified bargaining units of state employees. Effective Date: 07/01/2011

### SB 2096 (2R1) by the Committee on Budget-

State Financial Information; Requires the Auditor General to annually provide to the Legislature a list of school districts and water management districts that have failed to comply with certain financial transparency requirements, as identified pursuant to audit. Amends provisions relating to the Transparency Florida Act. Requires the Chief Financial Officer to develop and maintain the transparency website. Requires the fiscal year of each water management district to be July 1 to June 30, etc. Effective Date: upon becoming a law

### SB 2098 (2R1) by the Committee on Budget—

Consolidation/State Information Technology Services; Establishes the Agency for Enterprise Information Technology in the Department of Management Services rather than the Executive Office of the Governor. Revises the duties of the agency to include the planning, project management, and implementation of the enterprise information technology services. Requires the agency to submit a plan to the Legislative Budget Commission for aggregating information technology purchases, etc. Effective Date: 07/01/2011

### SB 2100 (2R1) by the Committee on Budget-

Retirement; Requires employee and employer contributions to the retirement system by a certain date. Redefines the terms "system," "prior service," "compensation," "average final compensation," "normal retirement date," "termination," "benefit," and "payee." Defines the term "division." Provides that special risk employee contributions be used, if applicable, when purchasing credit for past service. Revises the cost-of-living adjustment depending on the date of retirement, etc. Effective Date: 06/30/2011

### SB 2102 (2R1) by the Committee on Budget-

Health Insurance Benefits for State Employees; Deletes references to TRICARE supplemental insurance plans. Deletes the Department of Management Services' authorization to contract with health maintenance organizations for participation in the state group insurance program. Authorizes the Department of Management Services to establish health maintenance incentive programs. Deletes the authority of state agencies to allow certain former personnel and their eligible dependents the option of continuing to participate in certain group insurance plans or self-insurance plans, etc. Effective Date: 07/01/2011

### SB 2104 (2R1) by the Committee on Budget-

Office of Drug Control; Relocates the Statewide Office for Suicide Prevention into the Department of Children and Family Services. Requires the director of the Statewide Office for Suicide Prevention to employ a coordinator for the office. Requires revenues from grants accepted by the Statewide Office for Suicide Prevention to be deposited into the Grants and Donations Trust Fund within the Department of Children and Family Services rather than the Executive Office of the Governor, etc. Effective Date: 07/01/2011

### SB 2106 (2R1) by the Committee on Budget-

Florida Energy and Climate Commission; Eliminates the Florida Energy and Climate Commission and transfers its duties with respect to a tax credit, an incentive program, and the state's renewable energy policy to the Department of Environmental Protection. Repeals provisions relating to Florida Energy and Climate Commission. Transfers the duties of the Florida Energy and Climate Commission with respect to planning and developing the state's energy policy and its duties under the Florida Energy and Climate Protection Act to the Department of Environmental Protection, etc. Effective Date: 07/01/2011

### SB 2108 (2R1) by the Committee on Budget-

Welfare of Children; Repeals provisions relating to the Office of Adoption and Child Protection within the Executive Office of the Governor. Requires all state, county, and local agencies to cooperate, assist, and provide information to the Department of Children and Family Services rather than the Office of Adoption and Child Protection. Repeals provisions relating to the definition of the term "office" as it relates to the Office of Adoption and Child Protection, etc. Effective Date: 07/01/2011

### SB 2110 (2R1) by the Committee on Budget-

Auditor General; Requires that the Auditor General conduct operational audits at least every 3 years of certain additional state entities and district school boards and report on the activities of the ad valorem tax program of the Department of Revenue. Revises the duties of the Auditor General with respect to responsibilities for auditing certain reports made to the State Supreme Court and the operations of the Florida Clerks of Court Operations Corporation, respectively. Revises requirements to issue rules for surplus property, etc. Effective Date: 07/01/2011

#### SB 2112 (2R1) by the Committee on Budget-

Juvenile Detention Facilities; Exempts a county that covers the costs of detention care for pre-adjudicated juveniles within its jurisdiction or other jurisdictions from certain requirements for sharing the costs for juvenile detention. Provides that a county or county sheriff that meets certain prerequisites with respect to the operation of its juvenile detention facility is exempt from certain requirements of law governing the administration of such facilities. Authorizes a county or county sheriff to operate regional detention facilities, etc. Effective Date: 07/01/2011

### SB 2114 (2R1) by the Committee on Budget-

Juvenile Justice; Provides legislative intent. Defines the term "regional coordinating agency." Provides requirements for a regional coordinating agency. Requires the Department of Juvenile Justice to contract with regional coordinating agencies for specified services relating to juvenile justice. Gives hiring preference to current department employees who meet provider qualifications if they apply for employment with the regional coordinating agencies, etc. Effective Date: 07/01/2011

### SB 2116 (2R1) by the Committee on Budget-

State Judicial System; Creates the Judicial Caseload Incentive Plan. Prescribes the purpose of the plan. Provides for performance goals for each judicial circuit. Authorizes financial awards to certain judges based on the performance of the circuit in meeting the goals. Authorizes each office of criminal conflict and civil regional counsel to create a direct-support organization. Prescribes requirements related to the creation and operation of the direct-support organization, etc. Effective Date: 07/01/2011

### SB 2118 (2R1) by the Committee on Budget-

Criminal Justice; Repeals provisions relating to the Cybercrime Office within the Department of Legal Affairs. Limits the number of hours in the basic recruit training program required for correctional officers, unless the officer is otherwise exempt. Creates the Cybercrime Office within the Department of Law Enforcement to investigate certain violations of state law pertaining to the sexual exploitation of children. Repeals provisions relating to the basic training program for youthful offenders within the Department of Corrections, etc. Effective Date: 07/01/2011

### SB 2120 (2R1) by the Committee on Budget-

K-12 Education Funding; Authorizes the Department of Revenue to provide certain information regarding the gross receipts tax to the State Board of Education, the Division of Bond Finance, and the Office of Economic and Demographic Research. Requires that, for purposes of servicing public education capital outlay bonds, the State Board of Education disregard the effects on the gross receipts tax revenues collected during a tax period of a refund resulting from a specified settlement agreement, etc. Effective Date: upon becoming a law, except as otherwise provided

### SB 2122 (2R1) by the Committee on Budget-

Consumer Protection; Removes the Division of Dairy Industry within the Department Agriculture and Consumer Services. Requires the Department of Legal Affairs, rather than the Department of Agriculture and Consumer Services, to distribute free of charge a motor vehicle consumer's rights pamphlet. Provides for the state attorneys and the Department of Legal Affairs, rather than the Department of Agriculture and Consumer Services, to enforce the law prohibiting price gouging, etc. Effective Date: 07/01/2011

#### SB 2124 (2R1) by the Committee on Budget-

**Department of Revenue**; Extends from once every 2 years to once every 3 years the requirement that the department conduct an in-depth review of the assessment roll of each county. Provides for a study of certain classifications constituting 5 percent or more of the total assessed value of real property on the previous assessment roll. Imposes a tax on the charges for the use of coin-operated amusement machines operated on the licensed premises of a pari-mutuel facility located in certain cities or counties, etc. Effective Date: 07/01/2011

### SB 2126 (2R1) by the Committee on Budget-

Department of Management Services; Provides for the reimbursement to the department of actual costs for coordinating the Florida State Employee's Charitable Campaign. Requires the cost factors for a fixed capital outlay project to include an estimate for the finishing of interiors. Requires that cost savings realized when actual costs are less than the projected costs for a fixed capital outlay project be used to reduce the overall construction costs. Prohibits the purchase of art using public funds except as authorized by law, etc. Effective Date: 07/01/2011

### SB 2128 (2R1) by the Committee on Budget-

**Public Employees Relations Commission;** Requires that the commission be composed of a chair and two part-time members rather than two full-time members. Provides for the chair of the commission to remain as a full-time appointment. Prohibits the part-time members from engaging in any business, vocation, or employment that conflicts with their duties while in such office. Effective Date: 07/01/2011

### SB 2130 (2R1) by the Committee on Budget-

**Pollution Control**; Revises requirements for the deposit of funds used in providing financial assistance for water pollution control. Requires that such funds be deposited into the department's Federal Grants Trust Fund rather than the department's Grants and Donations Trust Fund. Specifies additional uses of moneys deposited into the Federal Grants Trust Fund. Effective Date: 07/01/2011

### SB 2132 (2R1) by the Committee on Budget-

Department of Financial Services; Repeals provisions relating to the Chief Financial Officer's authorization to operate a personal check-cashing service or a remote financial service unit at the capitol and to employ additional persons to assist in performing such services. Abolishes appropriations from the General Revenue Fund to pay the salaries of the additional employees. Revises the duties of the Division of Consumer Services. Revises the criteria for premiums charged to agencies and departments for purposes of the State Risk Management Trust Fund, etc. Effective Date: 07/01/2011

### SB 2134 (2R1) by the Committee on Budget—

Citizens Property Insurance Corporation; Repeals provisions relating to the procurement of goods and services by the corporation. Provides standards for procurements by Citizens Property Insurance Corporation. Requires the corporation's legal department and purchasing department to jointly prepare a contract for the procurement of goods or services. Includes a board member or an employee of the corporation within the definition of the term "public servant" as it relates to the crime of bribery and the misuse of public office, etc. Effective Date: 01/01/2012

#### SB 2136 (2R1) by the Committee on Budget-

Federal Grants Trust Fund/DBPR; Creates the Federal Grants Trust Fund within the Department of Business and Professional Regulation. Provides for the purpose of the trust fund and sources of funds. Provides for future review and termination or re-creation of the trust fund. Effective Date: July 1, 2011, if enacted by three-fifths vote of membership of Legislature

### SB 2142 (2R1) by the Committee on Budget-

Water Management Districts; Provides requirements with respect to revenues received by each water management district and the unexpended balances of a district's local account. Requires that each district's expenditure of funds be as provided in the General Appropriations Act. Provides for a contingency if a court finds such restriction to be invalid. Provides that the Legislature may annually set the amount of revenue a district may raise through its ad valorem tax authority, etc. Effective Date: upon becoming a law

### SB 2144 (2R1) by the Committee on Budget-

**Medicaid**; Provides for funding the Medicaid reimbursement for certain persons age 65 or older while the optional program is being phased out. Renames the "medically needy" program as the "Medicaid nonpoverty medical subsidy." Limits certain categories of persons eligible for the subsidy to only physician services after a certain date. Deletes the hospitalist program. Revises the factors for calculating the maximum allowable fee for pharmaceutical ingredient costs. Directs the AHCA to establish reimbursement rates for the next fiscal year, etc. Effective Date: 06/30/2011

### SB 2146 (2R1) by the Committee on Budget-

Department of Children and Family Services; Revises provisions relating to the department's duties with respect to domestic violence. Provides that annual certification of domestic violence centers depends on a favorable review by the Florida Coalition Against Domestic Violence. Authorizes the coalition to enter and inspect centers for monitoring purposes. Requires the department to contract with the coalition for the management of domestic violence service delivery and the monitoring of centers, etc. Effective Date: 07/01/2011

### SB 2148 (2R1) by the Committee on Budget-

Agency for Persons With Disabilities; Prohibits the agency from expending funds above the amount appropriated in the General Appropriations Act. Requires that the agency monitor monthly program expenditures and provide quarterly reports to the Governor and Legislature. Effective Date: upon becoming a law

### SB 2150 (2R1) by the Committee on Budget-

Postsecondary Education Funding; Authorizes the Department of Revenue to provide certain information regarding the gross receipts tax to the State Board of Education, the Division of Bond Finance, and the Office of Economic and Demographic Research. Requires that, for purposes of servicing public education capital outlay bonds, the State Board of Education disregard the effects on the gross receipts tax revenues collected during a tax period of a refund resulting from a specified settlement agreement, etc. Effective Date: upon becoming a law, except as otherwise provided

### SB 2152 (2R1) by the Committee on Budget-

**Transportation;** Provides additional funds for 5 years to fund certain projects through the Florida Deepwater Seaport Program. Specifies that certain statutory provisions related to special matters to be considered in rule adoption do not apply to the adjustment of toll rates. Transfers control of the Tampa-Hillsborough County Expressway Authority, the Orlando-Orange County Expressway Authority, and the Mid-Bay Bridge Authority systems to the Florida Turnpike Enterprise, etc. Effective Date: 07/01/2011

### SB 2154 (2R1) by the Committee on Budget-

Florida Housing Finance Corporation; Deletes provisions on the distributions of documentary stamp tax revenues to the State Housing Trust Fund and the Local Government Housing Trust Fund. Replaces references to the Department of Community Affairs with Jobs Florida. Provides for the deposit of certain moneys into the State Housing Trust Fund within the State Treasury. Replaces references to the Secretary of the Department of Community Affairs with the Commissioner of Jobs Florida. Provides for certain moneys to be deposited into the State Housing Trust Fund, etc. Effective Date: 07/01/2011

### SB 2156 (2R1) by the Committee on Budget-

Governmental Reorganization; Transfers the functions and trust funds of the Agency for Workforce Innovation to other agencies. Transfers the Office of Early Learning Services to the Department of Education. Transfers the Office of Unemployment Compensation to Jobs Florida. Transfers the Office of Workforce Services to Jobs Florida. Transfers the functions and trust funds of the Department of Community Affairs to other agencies. Transfers the Florida Housing Finance Corporation to Jobs Florida. etc. Effective Date: 07/01/2011

### SB 2160 (2R1) by the Committee on Budget-

Department of Highway Safety and Motor Vehicles; Requires the department rather than the Division of Motor Vehicles to issue special motor vehicle license plates. Creates motor carrier weight inspection as an area of program responsibility within the Department of Transportation, which replaces motor carrier compliance. Revises the divisions within the Department of Highway Safety and Motor Vehicles. Creates the Office of Motor Carrier Compliance of the Division of the Florida Highway Patrol within the Department of Highway Safety and Motor Vehicles, etc. Effective Date: 07/01/2011

### SB 2162 (2R1) by the Committee on Budget—

Welfare Transition Trust Fund/DOE; Creates the Welfare Transition Trust Fund within the Department of Education. Provides for sources of funds and purposes. Provides for the annual carryforward of funds. Provides for future review and termination or re-creation of the trust fund. Effective Date: July 1, 2011, if enacted by three-fifths vote of membership of Legislature
