Harris, Sr., individually, for injuries sustained as a result of the negligence of the North Broward Hospital District, d/b/a Coral Springs Medical Center. Provides a limitation on the payment of fees and costs, etc. Effective Date: upon becoming a law

Recommended favorably by the Special Master on Claim Bills; and reported favorably by the Committee on Rules

SB 22 (2R) by Senator Hill—

Requires that the blue alert be disseminated on the emergency alert system through television, radio, and highway signs. 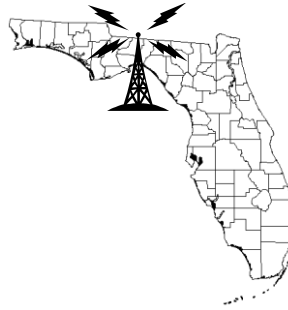
