State Lotteries; Requires each retailer of lottery tickets to provide assistance to any individual who is blind or visually impaired and has requested assistance in filling out his or her lottery ticket. Provides that a retailer or an employee of the retailer is not liable under certain circumstances, etc. Effective Date: 07/01/2011

Reported favorably by the Committees on Regulated Industries; Commerce and Tourism; and Rules

SB 420 (2R) by the Committee on Health Regulation—

OGSR/Florida Center for Brain Tumor Research; Provides that personal identifying information pertaining to a donor to the central repository for brain tumor biopsies or the brain tumor registry of the Florida Center for Brain Tumor Research is confidential and exempt from public records requirements. Provides an exception under certain conditions for information disclosed to a person engaged in bona fide research. SB 464 (2R) by Senator Latvala—

Requires that the blue alert be disseminated on the emergency alert system through television, radio, and highway signs. Provides that emergency traffic information may take precedence over blue alert information. Effective Date: 10/01/2011

SB 514 (2R) by Senator Garcia—

Vehicle Crashes Involving Death; Cites this act as the "Ashley Nicole Valdes Act." 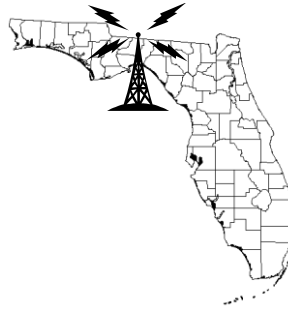
