### BILLS ON THIRD READING

## CS/CS/SB 818, 1st Eng. (3R) by the Committees on Criminal Justice, Health Regulation, Senator Fasano and others—

Controlled Substances; Authorizes certain health care practitioners to complete a continuing education course relating to the prescription drug monitoring program. Creates a felony of the third degree for any person to register or attempt to register a pain-management clinic through misrepresentation or fraud. Authorizes the DOH to revoke the certificate of registration of a pain-management clinic based upon a finding by a probable cause panel of a board that the clinic does not meet certain requirements, etc. Effective Date: 10/01/2011

Read the second time on April 27, 2011 and amended on April 28, 2011

Compare to CS/CS/HB 7095, 2nd Eng.(HC) in the Committees on Health Regulation; Criminal Justice; and Budget

### SB 762 (3R) by Senator Hays and others—

**Florida Climate Protection Act;** Repeals provisions relating to a cap-and-trade regulatory program to reduce greenhouse gas emissions from electric utilities. Conforms a cross-reference. Effective Date: 07/01/2011

Read the second time on May 2, 2011

### CS/HB 913 (3R) by the Committee on Government Operations Subcommittee and Representative Horner—

Pub. Rec./Records Held by Public Airports; Provides exemption from public records requirements for proprietary confidential business information & trade secrets held by public airport & for any proposal or counterproposal exchanged between public airport & nongovernmental entity relating to sale, use, development, or lease of airport facilities; provides for expiration of exemptions & review & repeal thereof; provides finding of public necessity. Effective Date: 07/01/2011

Read the second time on May 2, 2011

## CS/CS/HB 1255, 1st Eng. (3R) by the Committees on Education Committee, K-20 Competitiveness Subcommittee and Representative Adkins—

Education Accountability; Revises numerous provisions relating to K-12 public education system; revises provisions relating to virtual instruction courses, school board member acceptance of gifts, Opportunity Scholarship Program, McKay Scholarships, Voluntary Prekindergarten Education Program, special education services, requirements for middle grades promotion & high school graduation, digital curriculum, career & professional academies, use of restraint & seclusion on students with disabilities, assistive technology, statewide assessments, college readiness, school improvement, etc. Effective Date: 07/01/2011

Read the second time and amended on May 2, 2011

## CS/CS/SB 1824, 1st Eng. (3R) by the Committees on Transportation, Regulated Industries and Senator Hays—

Regulated Professions and Occupations; Authorizes the Department of Highway Safety and Motor Vehicles to release certain digital images to the Department of Business and Professional Regulation to identify certain persons. Authorizes the Department of Business and Professional Regulation to grant waivers of renewal fees under certain circumstances. Revises continuing education requirements for certain license reactivations. Repeals provisions relating to Uniform Standards of Professional Appraisal Practice, etc Effective Date: upon becoming a law, except as otherwise provided

Read the second time and amended on May 2, 2011

## CS/SB 1590, 1st Eng. (3R) by the Committee on Banking and Insurance, Senator Hays and others—

**Medical Malpractice**; Requires the Department of Health to issue expert witness certificates to certain physicians and dentists licensed outside the state. Provides application and certification requirements. Requires the Board of Medicine and the Board of Osteopathic Medicine to adopt within a specified period certain patient forms specifying cataract surgery risks. Provides that a volunteer team physician is not liable for civil damages unless treatment was rendered in a wrongful manner, etc. Effective Date: 07/01/2011

Read the second time and amended on May 2, 2011

Similar to CS/CS/CS/CS/HB 479, 1st Eng.(HC) in the Committees on Health Regulation; Banking and Insurance; and Budget

### SPECIAL ORDER CALENDAR FOR TUESDAY, MAY 3, 2011

## CS/SB 90 (SO) by the Committee on Education Pre-K - 12 and Senator Gaetz—

**Financial Emergencies**; Requires a plan of a county or municipality to improve the efficiency, accountability, and coordination of the delivery of local government services to include a plan for the consolidation of all administrative direction and support services if the county or municipality is subject to review and oversight by the Governor. Authorizes a financial emergency review board for a local government entity or district school board to consult with other governmental entities for the consolidation of all administrative direction and support services, etc. Effective Date: 07/01/2011

Reported favorably, with two amendments, by the Committee on Community Affairs; reported favorably as a committee substitute by the Committee on Education Pre-K - 12; the Committees on Governmental Oversight and Accountability; and Budget Subcommittee on Education Pre-K - 12 Appropriations reports the committee substitute favorably; and withdrawn from the Committee on Budget

### SB 118 (SO) by Senator Bullard and others—

**Bicycle Safety**; Revises safety standard requirements for bicycle helmets that must be worn by certain riders and passengers. Provides for enforcement of requirements for bicycle lighting equipment. Provides penalties for violations. Provides for dismissal of the charge following a first offense under certain circumstances. Effective Date: 10/01/2011

Reported favorably by the Committees on Transportation; Criminal Justice; and Budget

### SB 238 (SO) by Senator Altman and others—

Child Safety Devices in Motor Vehicles; Provides child-restraint requirements for children ages 4 through 7 years of age who are less than a specified height. Provides certain exceptions. Redefines the term "motor vehicle" to exclude certain vehicles from such requirements. Provides a grace period. Effective Date: July 1, 2011, except as otherwise provided

Reported favorably by the Committees on Transportation; Criminal Justice; and Budget

## CS/CS/SB 450 (SO) by the Committees on Judiciary, Military Affairs, Space, and Domestic Security, Senator Bennett and others—

Emergency Management; Cites this act as the "Postdisaster Relief Assistance Act." Provides immunity from civil liability for providers of temporary housing and aid to emergency first responders and their immediate family members following a declared emergency. Provides definitions. Provides nonapplicability. Authorizes specified registration with a county emergency management agency as a provider of housing and aid for emergency first responders. Effective Date: 07/01/2011

Reported favorably as a committee substitute by the Committee on Military Affairs, Space, and Domestic Security; reported favorably as a committee substitute by the Committee on Judiciary; and the Committee on Rules reports the committee substitute favorably

## CS/SB 480 (SO) by the Committee on Community Affairs and Senator Wise—

Florida Endowment for Vocational Rehabilitation; Removes a provision that requires the State Board of Administration to invest and reinvest moneys in the endowment fund for the Florida Endowment for Vocational Rehabilitation. Requires that a specified percent of the remainder of all civil penalties received by a county court and after distribution pursuant to ch. 318, F.S., be remitted to the Department of Revenue on a monthly basis, etc. Effective Date: upon becoming a law

Reported favorably as a committee substitute by the Committee on Community Affairs; the Committees on Higher Education; Governmental Oversight and Accountability; and Budget Subcommittee on Higher Education Appropriations reports the committee substitute favorably; and withdrawn from the Committee on Budget

Compare to **CS/HB 811(HC)** in the Committees on Community Affairs; Higher Education; Governmental Oversight and Accountability; Budget Subcommittee on Higher Education Appropriations; and Budget

### SB 548 (SO) by Senator Hays—

**Obsolete Health Care Provisions;** Repeals provisions relating to the designation of separate restrooms and separate dressing rooms for males and females, Florida Healthy People 2010 Program, and the MedAccess program within the Agency for Health Care Administration. Effective Date: 07/01/2011

Reported favorably by the Committee on Health Regulation; and withdrawn from the Committee on Budget

Identical to **HB 4027(HC)** in the Committees on Health Regulation; and Budget

## CS/CS/SB 632 (SO) by the Committees on Community Affairs, Higher Education and Senator Oelrich—

**Postsecondary Education;** Revises provisions relating to the disposal of personal property lost or abandoned on a university or Florida College System institution campus and the disposition of proceeds from the sale of such property. Repeals a provision relating to an exemption for students who earn 9 or more credits from one or more of the articulated acceleration mechanisms from any requirement of a public postsecondary educational institution which mandates enrollment during a summer term, etc. Effective Date: 07/01/2011

Reported favorably as a committee substitute by the Committee on Higher Education; reported favorably as a committee substitute by the Committee on Community Affairs; and the Committee on Budget reports the committee substitute favorably

### SB 688 (SO) by Senator Richter-

**Assisted Living Facilities;** Repeals a provision authorizing the Department of Elderly Affairs to collect information regarding the cost of providing certain services in facilities and to conduct field visits and audits. Repeals a provision authorizing a local subsidy. Effective Date: 07/01/2011

Reported favorably by the Committees on Children, Families, and Elder Affairs; and Health Regulation; and withdrawn from the Committee on Community Affairs

### SB 690 (SO) by Senator Richter—

**Assisted Living Facilities**; Removes an obsolete provision requiring the Department of Elderly Affairs to submit to the Legislature for review and comment a copy of proposed department rules establishing standards for resident care. Effective Date: 07/01/2011

Reported favorably by the Committees on Children, Families, and Elder Affairs; and Health Regulation; and withdrawn from the Committee on Rules

## CS/SB 746 (SO) by the Committee on Criminal Justice and Senator Altman—

Open House Parties; Provides that a person who violates the open house party statute a second or subsequent time commits a misdemeanor of the first degree. Provides that a person commits a misdemeanor of the first degree if the violation of the open house party statute causes or contributes to causing serious bodily injury or death to the minor, or causes or contributes to causing serious bodily injury or death to another person as a result of the minor's consumption of alcohol or drugs at the open house party. Provides criminal penalties. Effective Date: 07/01/2011

Reported favorably by the Committee on Regulated Industries; reported favorably as a committee substitute by the Committee on Criminal Justice; and the Committee on Budget reports the committee substitute favorably

Identical to CS/HB 105, 1st Eng.(HC) in the Committees on Regulated Industries; Criminal Justice; and Budget

### SB 788 (SO) by Senator Diaz de la Portilla—

Public School Educational Instruction; Requires district school boards to designate one month of the school year to celebrate the Founding Fathers of the United States of America and the principles inherent in the country's founding documents. Specifies the focus of instruction during the designated month. Provides that instruction may be integrated into the existing school curriculum. Effective Date: 07/01/2011

Reported favorably by the Committee on Education Pre-K - 12; and withdrawn from the Committee on Budget

### SB 870 (SO) by Senator Storms—

Compensation of County Officials; Authorizes each member of a board of county commissioners, each clerk of the circuit court, county comptroller, each sheriff, each supervisor of elections, each property appraiser, and each tax collector to reduce his or her salary on a voluntary basis. Effective Date: 07/01/2011

Reported favorably by the Committee on Community Affairs; and withdrawn from the Committee on Budget

Identical to **HB 19(HC)** in the Committees on Community Affairs; and Budget

## CS/SB 880 (SO) by the Committee on Budget and Senator Garcia—

Value Adjustment Boards; Requires a petitioner challenging the assessed value of property before the value adjustment board to pay a specified percentage of the taxes by a certain date. Requires a petitioner challenging the denial of a classification or exemption, or the assessment on specified grounds, before the value adjustment board to pay the amount of tax which the taxpayer admits in good faith to be owing by a certain date. Requires the payment of interest on certain unpaid taxes, etc. Effective Date: July 1, 2011

Reported favorably by the Committee on Community Affairs; and reported favorably as a committee substitute by the Committee on Budget

Similar to CS/CS/CS/HB 281(HC) in the Committees on Community Affairs; and Budget

### CS/SB 886 (SO) by the Committee on Transportation and Senator Oelrich—

**Motor Vehicles**; Revises penalties for unlawful operation of a soundmaking device in a motor vehicle. Provides that a second or subsequent violation is a moving violation and includes the assessment of points against the driver's license. Provides increased penalties for repeat violations within a certain time period. Effective Date: 07/01/2011

Reported favorably as a committee substitute by the Committee on Transportation; and the Committees on Budget; and Rules reports the committee substitute favorably

## CS/CS/SB 888 (SO) by the Committees on Communications, Energy, and Public Utilities, Judiciary and Senator Dean—

Offense of Sexting; Provides that a minor commits the offense of sexting if he or she knowingly uses a computer, or any other device capable of electronic data transmission or distribution, to transmit or distribute to another minor any photograph or video of any person which depicts nudity and is harmful to minors. Provides noncriminal and criminal penalties. Provides that the act does not prohibit prosecution of a minor for conduct relating to material that includes the depiction of sexual conduct or sexual excitement or for stalking, etc. Effective Date: 10/01/2011

Reported favorably, with one amendment, by the Committee on Criminal Justice; reported favorably as a committee substitute by the Committee on Judiciary; reported favorably as a committee substitute by the Committee on Communications, Energy, and Public Utilities; and the Committee on Budget reports the committee substitute favorably

Similar to CS/CS/HB 75, 1st Eng.(HC) in the Committees on Criminal Justice; Judiciary; Communications, Energy, and Public Utilities; and Budget

## CS/CS/SB 1180 (SO) by the Committees on Budget, Transportation and Senator Latvala—

**Transportation;** Provides that the Florida Statewide Passenger Rail Commission has the primary and exclusive authority to monitor certain designated functions related to passenger rail systems. Removes from the Florida Transportation Commission the responsibility and duty to monitor the efficiency, productivity, and management of all publicly funded passenger rail systems in the state, etc. Effective Date: 07/01/2011

Reported favorably as a committee substitute by the Committee on Transportation; reported favorably, with twelve amendments, by the Committee on Budget Subcommittee on Transportation, Tourism, and Economic Development Appropriations; and reported favorably as a committee substitute by the Committee on Budget

Similar to CS/CS/CS/HB 1363, 1st Eng.(HC) in the Committees on Transportation; Budget Subcommittee on Transportation, Tourism, and Economic Development Appropriations; and Budget

## CS/SB 1182 (SO) by the Committee on Budget and Senator Ring—

State Board of Administration; Authorizes the board to invest the assets of a governmental entity in the Local Government Surplus Funds Trust Fund without a trust agreement with that governmental entity. Provides that certain investments made by the board under a trust agreement are subject only to the restrictions and limitations contained in the trust agreement. Reduces the number of members on the Investment Advisory Council. Corrects cross-references. Clarifies provisions prohibiting certain conflicts of interest by investment advisers and managers retained by the board. Effective Date: 07/01/2011

Reported favorably, with one amendment, by the Committee on Governmental Oversight and Accountability; and reported favorably as a committee substitute by the Committee on Budget

## CS/CS/SB 1194 (SO) by the Committees on Children, Families, and Elder Affairs, Higher Education and Senator Oelrich—

Postsecondary Education; Deletes provisions relating to the use of test scores for assessment of college-level communication and computation skills. Requires the establishment of the Articulation Coordinating Committee and provides its responsibilities. Deletes provisions that exclude students with intellectual disabilities from eligibility for substitute requirements for admission to or graduation from a public postsecondary educational institution. Abrogates the repeal of provisions which created the 21st Century World Class Scholars Program, etc. Effective Date: upon becoming a law

Reported favorably as a committee substitute by the Committee on Higher Education; reported favorably as a committee substitute by the Committee on Children, Families, and Elder Affairs; and the Committees on Budget Subcommittee on Higher Education Appropriations; and Budget reports the committee substitute favorably

## CS/SB 1226 (SO) by the Committee on Criminal Justice, Senator Joyner and others—

Health Care Fraud; Revises the grounds under which the Department of Health or corresponding board is required to refuse to admit a candidate to an examination and refuse to issue or renew a license, certificate, or registration of a health care practitioner. Provides an exception. Requires a delinquent licensee whose license becomes delinquent before the final resolution of a case regarding Medicaid fraud to affirmatively apply by submitting a complete application for active or inactive status during the licensure cycle in which the case achieves final resolution, etc. Effective Date: 07/01/2011

Reported favorably by the Committee on Health Regulation; reported favorably as a committee substitute by the Committee on Criminal Justice; and the Committee on Budget reports the committee substitute favorably

### SB 1584 (SO) by Senator Sobel—

Deaf and Hard-of-hearing Children; Creates the "Deaf and Hard-of-Hearing Children's Education Bill of Rights." Provides findings and purpose. Recognizes the unique communication needs of deaf and hard-of-hearing children and encourages the development of a communication-driven and language-driven educational delivery system in the state. Requires the Department of Education to develop a communication model to become part of the individual education plan process for deaf and hard-of-hearing students. Effective Date: 07/01/2011

Reported favorably by the Committee on Education Pre-K - 12; and withdrawn from the Committee on Budget

### SB 1624 (SO) by Senator Lynn-

**Outdoor Theaters**; Repeals provisions relating to access to public roads from outdoor theaters. Removes provisions for entrances, exits, enclosures, vehicle storage, screen orientation, tower location, and driveway lighting. Removes requirements for a qualifying certificate to prove compliance with agency regulations prior to issuance of an occupational license by the tax collector. Effective Date: 07/01/2011

Reported favorably by the Committee on Transportation

Identical to **HB 4009(HC)** in the Committee on Transportation

## CS/SB 1626 (SO) by the Committee on Commerce and Tourism and Senator Lynn—

**Television Picture Tubes**; Repeals provisions relating to television picture tubes. Effective Date: 07/01/2011

Reported favorably as a committee substitute by the Committee on Commerce and Tourism

Identical to **CS/HB 4013(HC)** in the Committee on Commerce and Tourism

## CS/SB 1650 (SO) by the Committee on Military Affairs, Space, and Domestic Security, Senator Storms and others—

Child Custody; Provides that a parent's activation, deployment, or temporary assignment to military service and the resultant temporary disruption to the child may not be the sole factor in granting a petition for or modification of time-sharing and parental responsibility. Provides that a time-sharing and parental responsibility order in effect before a temporary change due to a parent's military service shall automatically be reinstated after a specified period after return and notice by the returning parent, etc. Effective Date: 07/01/2011

Reported favorably by the Committee on Judiciary; reported favorably as a committee substitute by the Committee on Military Affairs, Space, and Domestic Security; and the Committees on Children, Families, and Elder Affairs; and Budget reports the committee substitute favorably

## CS/SB 1676 (SO) by the Committee on Judiciary, Senator Thrasher and others—

Sovereign Immunity; Provides that specified provisions relating to sovereign immunity for health care providers do not apply to certain affiliation agreements or contracts to provide certain comprehensive health care services. Provides that the portion of the not-for-profit entity deemed to be an agent of the state for purpose of indemnity is also an agency of the state for purpose of public records laws, etc. Effective Date: upon becoming a law, and applies to all claims accruing on or after that date

Reported favorably by the Committee on Health Regulation; reported favorably as a committee substitute by the Committee on Judiciary; and withdrawn from the Committee on Budget

### CS/CS/SB 1732 (SO) by the Committees on Budget Subcommittee on Higher Education Appropriations, Higher Education and Senator Lynn—

Postsecondary Education; Requires the Higher Education Coordinating Council to recommend plans and submit a report to the Governor and the Legislature relating to core responsibilities of postsecondary education institutions, performance outputs and outcomes, articulation policies, workforce development education, and baccalaureate degree authorization. Requires the Department of Education (DOE) to use student performance data to determine appropriate credit-by-examination scores and courses, etc. Effective Date: 07/01/2011

Reported favorably as a committee substitute by; reported favorably as a committee substitute by the Committee on Budget Subcommittee on Health and Human Services Appropriations; and withdrawn from the Committee on Budget

Compare to **CS/HB 7151, 2nd Eng.(HC)** in the Committees on Higher Education; Budget Subcommittee on Higher Education Appropriations; and Budget

### SM 1762 (SO) by Senator Smith—

**Methylenedioxypyrovalerone (MDVP);** Urges the Congress of the United States to ban the sale, distribution, and possession of methylenedioxypyrovalerone (MDVP).

Reported favorably, with one amendment, by the Committee on Health Regulation

### SB 1788 (SO) by Senator Bogdanoff-

**Bicycle Regulations**; Removes a requirement to keep one hand on the handlebars while operating a bicycle. Conforms a cross-reference to changes made by the act. Effective Date: 07/01/2011

Reported favorably by the Committees on Transportation; Community Affairs; and Health Regulation

## CS/CS/CS/SB 1816 (SO) by the Committees on Budget, Budget Subcommittee on Finance and Tax, Banking and Insurance, Senator Fasano and others—

Surplus Lines Insurance; Requires a surplus lines agent to file quarterly on or before a specified time an affidavit stating that all surplus lines insurance transacted during the preceding quarter has been submitted to the Florida Surplus Lines Service Office. Authorizes the Department of Financial Services and the Office of Insurance Regulation to enter into a specified type of agreement with other states pursuant to federal law for the collection and allocation of certain nonadmitted insurance taxes, etc. Effective Date: upon becoming a law

Reported favorably as a committee substitute by the Committee on Banking and Insurance; reported favorably as a committee substitute by the Committee on Budget Subcommittee on Finance and Tax; and reported favorably as a committee substitute by the Committee on Budget

## CS/SB 1886 (SO) by the Committee on Budget, Senator Wise and others—

**Controlled Substances**; Includes certain hallucinogenic substances on the list of controlled substances in Schedule I. Reenacts provisions relating to prohibited acts and penalties regarding controlled substances and the offense severity chart of the Criminal Punishment Code, to incorporate the amendment to s. 893.03, F.S., in references thereto. Effective Date: 07/01/2011

Reported favorably, with one amendment, by the Committee on Criminal Justice; and reported favorably as a committee substitute by the Committee on Budget

Identical to **CS/HB 1039(HC)** in the Committees on Criminal Justice; and Budget

## CS/SB 1974 (SO) by the Committee on Budget and Senator Hill—

**Driver's License Examinations**; Provides requirements for examination questions pertaining to traffic regulations relating to blind pedestrians. Requires the curricula of driver improvement schools to include instruction on the dangers of driving while distracted. Requires the curricula of traffic law and substance abuse education courses to include instruction on the dangers of driving while distracted. Effective Date: 07/01/2011

Reported favorably by the Committee on Transportation; and reported favorably as a committee substitute by the Committee on Budget

Similar to CS/CS/HB 689, 1st Eng.(HC) in the Committees on Transportation; and Budget

Authorizes a county court to order the conditional release of a defendant for the provision of outpatient care and treatment. Creates the Forensic Hospital Diversion Pilot Program, etc. Effective Date: 07/01/2011

Provides that in a hearing relating to waiving the requirement for parental notice, the court consider certain additional factors, including whether the minor's decision to terminate her pregnancy was due to undue influence. Provides a procedure for appeal if judicial waiver of notice is not granted, etc. Effective Date: upon becoming a law

#### Condominium/Cooperative/Homeowners' Associations;

Authorizes a claim of lien to secure reasonable expenses for collection services rendered by a community association manager or community management firm on behalf of a community association for a delinquent account. Exempts certain residential buildings from a requirement to install a manual fire alarm system. Revises provisions relating to the official records of condominium associations. Authorizes the board of a condominium association to install impact glass or other code-compliant windows under certain circumstances, etc. Effective Date: 07/01/2011

Authorizes an institution to delegate to an external agent the management and investment of an institutional fund, etc. Effective Date: 07/01/2012

#### SB 2102 (2R) by the Committee on Budget-

Health Insurance Benefits for State Employees; Deletes references to TRICARE supplemental insurance plans. Deletes the Department of Management Services' authorization to contract with health maintenance organizations for participation in the state group insurance program. Authorizes the Department of Management Services to establish health maintenance incentive programs. Deletes the authority of state agencies to allow certain former personnel and their eligible dependents the option of continuing to participate in certain group insurance plans or self-insurance plans, etc. Effective Date: 07/01/2011

CS/SB 414 (2R1) by the Committee on Health Regulation and Senator Oelrich—

Prostate Cancer Awareness Program; Revises the structure and objectives of the Prostate Cancer Awareness Program. Authorizes the University of Florida Prostate Disease Center, in collaboration with other organizations and institutions, to increase community education and public awareness of prostate cancer. Requires the University of Florida Prostate Disease Center to establish an advisory council to replace the existing advisory committee. Provides for membership and duties of the advisory council. Requires an annual report to the Governor, Legislature, and State Surgeon General. Effective Date: 07/01/2011

Reported favorably as a committee substitute by the Committee on Health Regulation; the Committees on Budget Subcommittee on Higher Education Appropriations; and Budget reports the committee substitute favorably; and withdrawn from the Committee on Rules

#### SB 446 (2R1) by Senator Hays and others-

Dentistry and Dental Hygiene; Revises the locations at which dental hygienists may perform dental charting. Authorizing dental hygienists to perform certain duties without supervision or authorization by a dentist. Provides exceptions. Requires that dental hygienists in a health access setting provide a certain disclaimer to patients before a procedure is performed. Provides that a health access setting may bill for certain services, etc. Effective Date: upon becoming a law

Reported favorably by the Committees on Health Regulation; and Budget Subcommittee on Health and Human Services Appropriations; and withdrawn from the Committees on Budget; and Rules

### CS/CS/SB 488 (2R1) by the Committees on Judiciary, Criminal Justice, Senator Fasano and others—

Sexual Offenses; Cites this act as the "Walk in Their Shoes Act." Revises offenses that are considered "child molestation" for purposes of admitting evidence of other crimes, wrongs, or acts in a criminal case involving child molestation. Massage Therapy; Requires applicants to apply for a temporary permit upon forms prepared and furnished by the Department of Health in accordance with the Board of Massage Therapy's rules. Authorizes the Board of Massage Therapy to issue temporary permits to applicants who meet certain qualifications to practice massage therapy. Provides for the expiration of temporary permits. Provides limitations. Provides for a temporary permit fee. Effective Date: 01/03/2012

Reported favorably as a committee substitute by the Committee on Health Regulation; the Committee on Budget Subcommittee on Health and Human Services Appropriations reports the committee substitute favorably; and withdrawn from the Committees on Budget; and Rules

### CS/CS/SJR 658 (2R1) by the Committees on Judiciary, Community Affairs, Senator Fasano and others—

Homestead/Nonhomestead Property; Proposes amendments to the State Constitution to allow the Legislature by general law to prohibit increases in the assessed value of homestead and specified nonhomestead property if the just value of the property decreases, reduce the limitation on annual assessment increases applicable to nonhomestead real property, provide an additional homestead exemption for owners of homestead property who have not owned homestead property for a specified time before purchase of the current homestead property, etc.

#### SB 912 (2R1) by Senator Bennett-

Requires that in order to renew a mortgage lender license a mortgage lender must authorize the Nationwide Mortgage Licensing System and Registry to obtain an independent credit report on each of the mortgage lender's control persons, etc. Effective Date: 07/01/2011

### CS/SB 1388 (2R1) by the Committee on Education Pre-K - 12 and Senator Flores—

Department of Revenue; Authorizes the department to release certain taxpayers' names and addresses to certain scholarshipfunding organizations. Deletes a limitation on the amount of tax credit allowable for contributions made to certain scholarshipfunding organizations. Extends the carry-forward period for the use of certain tax credits resulting from contributions to the Florida Tax Credit Scholarship Program. Deletes a restriction on a taxpayer's ability to rescind certain tax credits resulting from contributions to the program. Effective Date: 07/01/2011

Reported favorably as a committee substitute by the Committee on Education Pre-K - 12; and withdrawn from the Committees on Budget; and Rules

### CS/SB 1428 (2R1) by the Committee on Regulated Industries and Senator Latvala—

Veterinary Practice; Defines the term "limited service veterinary vaccination clinic." Revises terminology. Requires that the Board of Veterinary Medicine establish minimum standards for limited service veterinary vaccination clinics rather than limited service veterinary medical practices. Deletes provisions that limit the practice privileges of out-of-state or foreign health care professionals or veterinarians who are in this state for a specific sporting event. Effective Date: 07/01/2011

Licensed Security Officers; Provides that a person who engages in any activity for which a specified provision requires a license, but acts without having a license, commits a misdemeanor of the first degree. Authorizes the Department of Agriculture and Consumer Services to impose a civil penalty not to exceed a specified amount. Ad Valorem Taxation; Reduces the amount that any change in the value of certain real property resulting from an annual reassessment may exceed the assessed value of the property for the prior year under specified circumstances. Provides a first-time Florida homesteader with an additional homestead exemption. Requires the Legislature to appropriate funds to fiscally constrained counties to offset reductions in ad valorem tax revenue as the result of the implementation of certain proposed revisions to the State Constitution, etc. Effective Date: Contingent

### CS/SB 1744 (2R1) by the Committee on Health Regulation and Senator Storms—

**Abortions**; Requires that an ultrasound be performed on a woman obtaining an abortion. Requires that the ultrasound be reviewed with the patient before the woman gives informed consent for the abortion procedure. Requires that the woman certify in writing that she declined to review the ultrasound and did so of her own free will and without undue influence. Provides an exemption from the requirement to view the ultrasound for women who are the victims of rape, incest, domestic violence, or human trafficking or for women who have a serious medical condition, etc. Effective Date: 07/01/2011

Reported favorably as a committee substitute by the Committee on Health Regulation; and withdrawn from the Committees on Budget; and Rules

### SB 1770 (2R1) by Senator Hays and others-

Provides that in a hearing relating to waiving the requirement for parental notice, the court consider certain additional factors, including whether the minor's decision to terminate her pregnancy was due to undue influence. Provides a procedure for appeal if judicial waiver of notice is not granted, etc. Effective Date: upon becoming a law

Reported favorably by the Committee on Health Regulation; reported favorably, with one amendment, by the Committee on Judiciary; and withdrawn from the Committee on Budget

Similar to **HB 1247, 1st Eng.(HC)** in the Committees on Health Regulation; Judiciary; and Budget

### CS/SB 1772 (2R1) by the Committee on Commerce and Tourism and Senator Hays—

Self-service Storage Facilities; Redefines the term "last known address," to conform to changes made by the act. Revises notice requirements related to enforcing an owner's lien. Allows postal notice by first-class mail, along with a certificate of mailing. Allows electronic mail notice. Clarifies provisions relating to the right to create contractual liens or limitations on liability. Effective Date: 07/01/2011

Reported favorably as a committee substitute by the Committee on Commerce and Tourism; and withdrawn from the Committees on Community Affairs; and Judiciary

#### SB 1826 (2R1) by Senator Hays-

Workers' Compensation; Repeals provisions relating to the Workers' Compensation Administrator, to abolish the position. Deletes an obsolete transitional requirement for certain policies of the Florida Workers' Compensation Joint Underwriting Association. Effective Date: 07/01/2011

Reported favorably by the Committees on Banking and Insurance; and Budget Subcommittee on General Government Appropriations; and withdrawn from the Committees on Budget; and Rules

CS/CS/SB 2076 (2R1) by the Committees on Budget Subcommittee on General Government Appropriations, Agriculture, and Agriculture—

Department of Agriculture and Consumer Services; Deletes the Division of Dairy within the Department of Agriculture and Consumer Services. Exempts certain direct-support organizations and citizen support organizations for the Department of Agriculture and Consumer Services from obtaining an independent audit. Provides for the grantee of easements for electrical transmission to pay the lead manager of the state-owned lands or, when there is no lead manager, the Department of Environmental Protection, if suitable replacement uplands cannot be identified, etc. Effective Date: 10/01/2011

Reported favorably as a committee substitute by the Committee on Agriculture; reported favorably as a committee substitute by the Committee on Budget Subcommittee on General Government Appropriations; the Committee on Budget reports the committee substitute favorably; and withdrawn from the Committee on Rules
