### BILLS ON THIRD READING

#### **CS/CS/SB 818, 1st Eng. (3R) by the Committees on Criminal Justice, Health Regulation, Senator Fasano and others—**

**Controlled Substances;** Authorizes certain health care practitioners to complete a continuing education course relating to the prescription drug monitoring program. Creates a felony of the third degree for any person to register or attempt to register a pain-management clinic through misrepresentation or fraud. Authorizes the DOH to revoke the certificate of registration of a pain-management clinic based upon a finding by a probable cause panel of a board that the clinic does not meet certain requirements, etc. Effective Date: 10/01/2011

*Read the second time on April 27, 2011 and amended on April 28, 2011*

*Compare to CS/CS/HB 7095, 2nd Eng.(HC) in the Committees on Health Regulation; Criminal Justice; and Budget*

---

#### **CS/CS/HB 1255, 1st Eng. (3R) by the Committees on Education Committee, K-20 Competitiveness Subcommittee and Representative Adkins—**

**Education Accountability;** Revises numerous provisions relating to K-12 public education system; revises provisions relating to virtual instruction courses, school board member acceptance of gifts, Opportunity Scholarship Program, McKay Scholarships, Voluntary Prekindergarten Education Program, special education services, requirements for middle grades promotion & high school graduation, digital curriculum, career & professional academies, use of restraint & seclusion on students with disabilities, assistive technology, statewide assessments, college readiness, school improvement, etc. Effective Date: 07/01/2011

*Substituted for CS/CS/SB 1696(SUB) (Wise), read the second time, and amended on May 2, 2011*

---

#### **SB 788 (3R) by Senator Diaz de la Portilla—**

**Public School Educational Instruction;** Requires district school boards to designate one month of the school year to celebrate the Founding Fathers of the United States of America and the principles inherent in the country's founding documents. Specifies the focus of instruction during the designated month. Provides that instruction may be integrated into the existing school curriculum. Effective Date: 07/01/2011

#### **CS/CS/HB 965, 1st Eng. (3R) by the Committees on Appropriations Committee, Finance and Tax Committee, Representative Horner and others—**

**Florida Tax Credit Scholarship Program;** Revises provisions relating to amount of tax credit allowed for contribution made to eligible nonprofit scholarship-funding organization; revises provisions relating to carryforward of unused amount of tax credit & rescindment of all or part of tax credit under Florida Tax Credit Scholarship Program. Effective Date: 07/01/2011

*Substituted for CS/SB 1388(SUB) (Flores) and read the second time on May 3, 2011*

---

#### **CS/CS/HB 1355, 1st Eng. (3R) by the Committees on State Affairs Committee, Government Operations Subcommittee, Representative Baxley and others—**

**Elections;** Expands list of responsibilities of Secretary of State when acting in his or her capacity as chief election officer; requires that third-party voter registration organizations register with Division of Elections and provide division with certain information; requires that division or supervisor of elections make voter registration forms available to third-party voter registration organizations; requires that such forms contain certain information, etc. Effective Date: 07/01/2011

*Substituted for CS/CS/SB 2086(SUB) (Diaz de la Portilla), read the second time, and amended on May 4, 2011*

**HB 1247, 1st Eng. (3R) by Representative Stargel and others—**

**Parental Notice of Abortion;** Revises definition of term "constructive notice"; revises notice requirements relating to termination of pregnancy of minor; provides exceptions to notice requirements; revises procedure for judicial waiver of notice; provides for minor to petition for hearing within specified time; provides that in hearing relating to waiving requirement for parental notice, court consider certain additional factors, including whether minor's decision to terminate her pregnancy was due to undue influence; provides procedure for appeal if judicial waiver of notice is not granted, etc. Effective Date: 10/1/2011 or upon adoption of rules and forms by Supreme Court

*Substituted for **SB 1770(SUB)** (Hays) and read the second time on May 4, 2011*

---

**CS/HB 1127 (3R) by the Committee on Health and Human Services Committee, Representative Porter and others—**

**Abortions;** Requires that ultrasound be performed on woman obtaining abortion; requires that ultrasound be reviewed with patient before woman gives informed consent for abortion procedure; requires that woman certify in writing that she declined to review ultrasound & did so of her own free will & without undue influence; provides exemption from requirement to view ultrasound for women who are victims of rape, incest, domestic violence, or human trafficking or for women who have serious medical condition necessitating abortion, etc. Effective Date: 07/01/2011

*Substituted for **CS/SB 1744(SUB)** (Storms) and read the second time on May 4, 2011*

---

**CS/CS/CS/CS/HB 353, 1st Eng. (3R) by the Committees on Health and Human Services Committee, Judiciary Committee, Rulemaking and Regulation Subcommittee, Health and Human Services Access Subcommittee, Representative Smith and others—**

**Drug Screening/Beneficiaries of TANF;** Requires DCFS to perform drug test on applicant for Temporary Assistance for Needy Families benefits; requires such individual to bear cost of drug test; requires department to provide, & applicant to acknowledge receipt of, notice of drug-screening policy; requires department to increase amount of initial TANF benefit by amount paid by individual for drug testing; provides procedures for testing & retesting; requires department to provide information concerning local substance abuse treatment programs to individual who tests positive, etc. Effective Date: 07/01/2011

*Substituted for **CS/CS/SB 556(SUB)** (Oelrich) and read the second time on May 4, 2011*

**HB 7101 (3R) by the Committee on Civil Justice Subcommittee and Representative Gaetz—**

**Judicial Nominating Commissions;** Repeals provisions relating to judicial nominating commissions; provides for commissions; specifies membership & composition; provides for appointment of members by Governor; provides for terms; requires Governor to consider racial, ethnic, gender, & geographic diversity in making appointments; provides for suspension of member of judicial nominating commission; establishes quorum; provides for administrative support; abolishes prior offices; permits reappointment of former officeholders. Effective Date: upon becoming a law

*Substituted for **CS/SB 2170(SUB)** (Flores), read the second time, and amended on May 4, 2011*

---

**CS/SB 1246, 1st Eng. (3R) by the Committee on Agriculture, Senator Norman and others—**

**Farms;** Prohibits a person from entering onto a farm and making any audio record, photograph, or video record at the farm without the owner's written consent. Provides exceptions. Provides definitions. Provides penalties. Effective Date: 07/01/2011

*Read the second time and amended on May 4, 2011*

---

**CS/SB 584 (3R) by the Committee on Health Regulation and Senator Flores—**

**Massage Therapy;** Requires applicants to apply for a temporary permit upon forms prepared and furnished by the Department of Health in accordance with the Board of Massage Therapy's rules. Authorizes the Board of Massage Therapy to issue temporary permits to applicants who meet certain qualifications to practice massage therapy. Provides for the expiration of temporary permits. Provides limitations. Provides for a temporary permit fee. Effective Date: 01/03/2012

*Read the second time on May 4, 2011*

**SPECIAL ORDER CALENDAR FOR

**CS/CS/SB 632 (SO) by the Committees on Community Affairs, Higher Education and Senator Oelrich—**

**Postsecondary Education;** Revises provisions relating to the disposal of personal property lost or abandoned on a university or Florida College System institution campus and the disposition of proceeds from the sale of such property. Repeals a provision relating to an exemption for students who earn 9 or more credits from one or more of the articulated acceleration mechanisms from any requirement of a public postsecondary educational institution which mandates enrollment during a summer term, etc. Effective Date: 07/01/2011

*Reported favorably as a committee substitute by the Committee on Higher Education; reported favorably as a committee substitute by the Committee on Community Affairs; and the Committee on Budget reports the committee substitute favorably*

## **CS/CS/SB 1180 (SO) by the Committees on Budget, Transportation and Senator Latvala—**

**Transportation;** Provides that the Florida Statewide Passenger Rail Commission has the primary and exclusive authority to monitor certain designated functions related to passenger rail systems. Removes from the Florida Transportation Commission the responsibility and duty to monitor the efficiency, productivity, and management of all publicly funded passenger rail systems in the state, etc. Effective Date: 07/01/2011

*Reported favorably as a committee substitute by the Committee on Transportation; reported favorably, with twelve amendments, by the Committee on Budget Subcommittee on Transportation, Tourism, and Economic Development Appropriations; and reported favorably as a committee substitute by the Committee on Budget*

*Similar to **CS/CS/CS/HB 1363, 1st Eng.(HC)** in the Committees on Transportation; Budget Subcommittee on Transportation, Tourism, and Economic Development Appropriations; and Budget*

---

## **CS/CS/SB 1194 (SO) by the Committees on Children, Families, and Elder Affairs, Higher Education and Senator Oelrich—**

**Postsecondary Education;** Deletes provisions relating to the use of test scores for assessment of college-level communication and computation skills. Requires the establishment of the Articulation Coordinating Committee and provides its responsibilities. Deletes provisions that exclude students with intellectual disabilities from eligibility for substitute requirements for admission to or graduation from a public postsecondary educational institution. Abrogates the repeal of provisions which created the 21st Century World Class Scholars Program, etc. Effective Date: upon becoming a law

*Reported favorably as a committee substitute by the Committee on Higher Education; reported favorably as a committee substitute by the Committee on Children, Families, and Elder Affairs; and the Committees on Budget Subcommittee on Higher Education Appropriations; and Budget reports the committee substitute favorably*

---

## **SB 1398 (SO) by Senator Bogdanoff—**

**Judiciary;** Repeals provisions relating to regular terms of the Supreme Court, compensation of the marshal, census commissions for the judicial circuits, and terms of the circuit courts. Repeals provisions relating to terms of the First Judicial Circuit through the Twentieth Judicial Circuit. Repeals provisions relating to requiring a judge to attend the first day of each term of the circuit court. Repeals provisions relating to requiring a judge to state a reason for nonattendance. Repeals provisions relating to guardians of incapacitated world war veterans, etc. Effective Date: 07/01/2011

*Reported favorably, with one amendment, by the Committee on Judiciary; and withdrawn from the Committee on Rules*

## **CS/CS/CS/SB 1972 (SO) by the Committees on Budget, Budget Subcommittee on Health and Human Services Appropriations, Health Regulation, Senator Negron and others—**

**Health and Human Services;** Exempts hospital districts from the requirement to provide funding to a community redevelopment agency. Provides for medical assistance for children in out-of-home care and adopted children. Revises provisions relating to conditions for Medicaid eligibility. Establishes the Medicaid managed care program as the statewide, integrated managed care program for medical assistance and long-term care services. Requires all Medicaid recipients to be enrolled in Medicaid managed care. Establishes regions for separate procurement of plans, etc. Effective Date: upon becoming a law

*Reported favorably as a committee substitute by the Committee on Health Regulation; reported favorably as a committee substitute by the Committee on Budget Subcommittee on Health and Human Services Appropriations; and reported favorably as a committee substitute by the Committee on Budget*

*Compare to **CS/HB 7107, 2nd Eng.(HC)** in the Committees on Health Regulation; Budget Subcommittee on Health and Human Services Appropriations; and Budget*

---

## **CS/HB 7109, 2nd Eng. (SO) by the Committees on Appropriations Committee, Health and Human Services Committee and Representative Schenck—**

**Medicaid;** Requires APD to establish transition plan for current Medicaid recipients to iBudget system by specified date; requires AHCA to develop transition plan for current Medicaid recipients to managed care plans, set reimbursements rates for hospitals that provide Medicaid services, contract on prepaid or fixed-sum basis with certain dental health plans, develop opt-out process for recipients with access to employer-sponsored coverage, maintain Medicaid Encounter Data System, establish designated payment for specified Medicare Advantage Special Needs members, etc. Effective Date: 07/01/2011

*Withdrawn from the Committees on Health Regulation; Budget Subcommittee on Health and Human Services Appropriations; and Budget*

**CS/CS/SB 1122 (SO) by the Committees on Environmental Preservation and Conservation, Community Affairs and Senator Bennett—**

**Growth Management;** Redesignates the "Local Government Comprehensive Planning and Land Development Regulation Act" as the "Community Planning Act." Revises and provides duties of local governments and municipalities relating to comprehensive plans. Revises provisions relating to the Century Commission for a Sustainable Florida. Revises the findings and intent to include the necessity for a specific strategic plan addressing the state's growth management system, etc. Effective Date: upon becoming a law, except as otherwise provided

*Reported favorably as a committee substitute by the Committee on Community Affairs; reported favorably as a committee substitute by the Committee on Environmental Preservation and Conservation; and withdrawn from the Committee on Budget*

*Similar to **CS/HB 7129, 2nd Eng.(HC)** in the Committees on Community Affairs; Environmental Preservation and Conservation; and Budget*

---

**SB 996 (SO) by Senator Simmons—**

**Communications Among Branches of State Government;** Cites this act as the "Communication of Judicial Opinions Act." Requires the clerks of the State Supreme Court and district courts of appeal to transmit certain judicial opinions to the Governor, the President of the Senate, and the Speaker of the House of Representatives within a specified time. Effective Date: 07/01/2011

*Reported favorably by the Committees on Judiciary; Governmental Oversight and Accountability; and Budget*

---

**CS/CS/SB 830 (SO) by the Committees on Rules, Community Affairs, Senator Thrasher and others—**

**Labor and Employment;** Prohibits a state agency from deducting from employee wages funds for political activity. Prohibits a county, municipality, or other local governmental entity from deducting from employee wages funds for political activity. Prohibits labor organizations from collecting dues, assessments, fines, or penalties for the purposes of political activity without written authorization. Requires that the labor organization provide notice of such contributions and expenditures, etc. Effective Date: July 1, 2011

*Reported favorably as a committee substitute by the Committee on Community Affairs; the Committee on Budget reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Rules*

*Compare to **CS/HB 1021(HC)** in the Committees on Community Affairs; Budget; and Rules*

---

**CS/CS/SB 666 (SO) by the Committees on Governmental Oversight and Accountability, Regulated Industries and Senator Ring—**

**Governmental Reorganization;** Transfers and reassigns certain functions and responsibilities, including records, personnel, property, and unexpended balances of appropriations and other resources, from the Division of Pari-mutuel Wagering of the Department of Business and Professional Regulation to the Department of Gaming Control. Requires the department to issue advisory opinions under certain circumstances. Provides for the Department of Gaming Control or the Department of Legal Affairs, to prosecute a fair association for illegal gambling activities, etc. Effective Date: 10/01/2011

*Reported favorably as a committee substitute by the Committee on Regulated Industries; reported favorably as a committee substitute by the Committee on Governmental Oversight and Accountability; and the Committee on Budget reports the committee substitute favorably*

---

**CS/SB 1176 (SO) by the Committee on Judiciary and Senator Ring—**

**High School Athletic Trainers;** Revises membership requirements for the Board of Athletic Training. Revises requirements for licensure by examination for athletic trainers. Requires certification requirements for license renewal. Revises continuing education requirements for licensure renewal. Encourages school districts to employ or contract with certified athletic trainers at certain high schools in this state. Requires athletic trainers to be certified by the Board of Certification of the National Athletic Trainers' Association, etc. Effective Date: 07/01/2011

*Reported favorably by the Committee on Education Pre-K - 12; reported favorably as a committee substitute by the Committee on Judiciary; and the Committee on Budget reports the committee substitute favorably*

*Compare to **CS/CS/HB 831(HC)** in the Committees on Education Pre-K - 12; Judiciary; and Budget*

---

**SB 1792 (SO) by Senator Diaz de la Portilla—**

**Growth Policy;** Repeals provisions relating to the Urban Infill and Redevelopment Assistance Grant Program, to terminate the program. Conforms cross-references to changes made by the act. Effective Date: 07/01/2011

*Reported favorably by the Committees on Community Affairs; Budget Subcommittee on Transportation, Tourism, and Economic Development Appropriations; and Budget*

*Identical to **HB 4001(HC)** in the Committees on Community Affairs; Budget Subcommittee on Transportation, Tourism, and Economic Development Appropriations; and Budget*

---

## **CS/CS/SB 476 (SO) by the Committees on Judiciary, Regulated Industries and Senator Evers—**

**Public Lodging Establishments;** Prohibits local governments from regulating vacation rentals based solely on their classification or use. Provides that public lodging establishments formerly classified as resort condominiums and resort dwellings are classified as vacation rentals. Provides additional penalties for the offense of unlawfully distributing handbills in a public lodging establishment, etc. Effective Date: upon becoming a law

*Reported favorably as a committee substitute by the Committee on Regulated Industries; reported favorably as a committee substitute by the Committee on Judiciary; and withdrawn from the Committee on Budget*

*Similar to **CS/HB 63, 2nd Eng.(HC)** in the Committees on Regulated Industries; Judiciary; and Budget; and Similar to **CS/CS/CS/HB 883, 2nd Eng.(HC)** in the Committees on Regulated Industries; Judiciary; and Budget*

---

## **CS/SB 1622 (SO) by the Committee on Children, Families, and Elder Affairs and Senator Flores—**

**Family Support;** Designates the courts and other entities as the tribunals of the state and designates the Department of Revenue as the support enforcement agency of the state. Clarifies that the Uniform Interstate Family Support Act is not the exclusive method to establish or enforce a support order in this state. Provides procedures for determining which child support order is recognized as the controlling support order, etc. Effective Date: contingent

*Reported favorably by the Committee on Judiciary; reported favorably as a committee substitute by the Committee on Children, Families, and Elder Affairs; the Committee on Budget Subcommittee on General Government Appropriations reports the committee substitute favorably; and withdrawn from the Committee on Budget*

*Similar to **CS/CS/CS/HB 1111, 2nd Eng.(HC)** in the Committees on Judiciary; Children, Families, and Elder Affairs; Budget Subcommittee on General Government Appropriations; and Budget*

---

## **CS/SB 730 (SO) by the Committee on Education Pre-K - 12, Senator Flores and others—**

**Youth and Student Athletes;** Requires independent sanctioning authorities to adopt policies to inform youth athletes and their parents of the nature and risk of certain head injuries. Requires that a signed consent form be obtained before the youth participates in athletic practices or competitions. Requires that a youth athlete be immediately removed from an athletic activity following a suspected head injury. Requires written clearance from a medical professional before the youth resumes athletic activities, etc. Effective Date: 07/01/2011

*Reported favorably as a committee substitute by the Committee on Education Pre-K - 12; the Committee on Health Regulation reports the committee substitute favorably; and withdrawn from the Committee on Rules*

*Similar to **CS/CS/HB 301, 1st Eng.(HC)** in the Committees on Education Pre-K - 12; Health Regulation; and Rules*

## **CS/CS/SB 2076 (SO) by the Committees on Budget Subcommittee on General Government Appropriations, Agriculture, and Agriculture—**

**Department of Agriculture and Consumer Services;** Deletes the Division of Dairy within the Department of Agriculture and Consumer Services. Exempts certain direct-support organizations and citizen support organizations for the Department of Agriculture and Consumer Services from obtaining an independent audit. Provides for the grantee of easements for electrical transmission to pay the lead manager of the state-owned lands or, when there is no lead manager, the Department of Environmental Protection, if suitable replacement uplands cannot be identified, etc. Effective Date: 10/01/2011

*Reported favorably as a committee substitute by the Committee on Agriculture; reported favorably as a committee substitute by the Committee on Budget Subcommittee on General Government Appropriations; the Committee on Budget reports the committee substitute favorably; and withdrawn from the Committee on Rules*

*Similar to **CS/CS/HB 7215, 2nd Eng.(HC)** in the Committees on Agriculture; Budget Subcommittee on General Government Appropriations; and Budget*

---

## **SB 1822 (SO) by Senator Benacquisto—**

**School Choice;** Revises legislative intent and eligibility requirements for participation in the Opportunity Scholarship Program. Deletes provisions that authorize an opportunity scholarship for attendance at a private school. Requires that an opportunity scholarship remain in force until the student graduates from high school. Revises school district obligations and deletes provisions relating to private schools to conform to changes made by the act. Deletes an obsolete provision relating to the John M. McKay Scholarships for Students with Disabilities Program, etc. Effective Date: 07/01/2011

*Reported favorably by the Committees on Education Pre-K - 12; and Budget*

*Identical to **CS/HB 1331(HC)** in the Committees on Education Pre-K - 12; and Budget*

---

## **CS/SB 506 (SO) by the Committee on Community Affairs and Senator Bogdanoff—**

**Economic Development;** Authorizes the board of county commissioners of a charter county to call and hold a referendum to determine whether to grant economic development ad valorem tax exemptions. Revises the language of ballot questions relating to the authority to grant economic development tax exemptions. Provides for application of a provision limiting the calling of another referendum within a certain time period, etc. Effective Date: 07/01/2011

*Reported favorably as a committee substitute by the Committee on Community Affairs; the Committee on Commerce and Tourism reports the committee substitute favorably, with one amendment; and withdrawn from the Committee on Budget*

*Compare to **CS/CS/HB 287(HC)** in the Committees on Community Affairs; and Commerce and Tourism*

Authorizing dental hygienists to perform certain duties without supervision or authorization by a dentist. Provides exceptions. Requires that dental hygienists in a health access setting provide a certain disclaimer to patients before a procedure is performed. Provides that a health access setting may bill for certain services, etc. Effective Date: upon becoming a law

**Sentences of Inmates;** Removes all references to imposing mandatory minimum sentences for defendants convicted of trafficking in controlled substances. Directs the DOC to develop and administer a reentry program for nonviolent offenders which is intended to divert nonviolent offenders from long periods of incarceration. Deletes a requirement that the Office of Insurance Regulation of the Department of Financial Services annually report to the Governor and the Legislature concerning the Small Employers Access Program. Effective Date: 07/01/2011

**CS/SB 1428 (2R) by the Committee on Regulated Industries and Senator Latvala—**

**Veterinary Practice;** Defines the term "limited service veterinary vaccination clinic." Revises terminology. Requires that the Board of Veterinary Medicine establish minimum standards for limited service veterinary vaccination clinics rather than limited service veterinary medical practices. Deletes provisions that limit the practice privileges of out-of-state or foreign health care professionals or veterinarians who are in this state for a specific sporting event. Provides for the validity of an onsite sewage treatment and disposal system permit if rules change before final approval of the constructed system, etc. Effective Date: upon becoming a law

**SJR 1704 (2R) by Senator Hays—**

**Judicial Qualifications Commission;** Proposes an amendment to the State Constitution to require that certain proceedings, records, and materials of the Judicial Qualifications Commission be open to the public and to require the commission to notify the Speaker of the House of Representatives of complaints received or initiated, investigations conducted, and complaints concluded.

**Health Insurance Benefits for State Employees;** Deletes references to TRICARE supplemental insurance plans. Deletes the Department of Management Services' authorization to contract with health maintenance organizations for participation in the state group insurance program. Authorizes the Department of Management Services to establish health maintenance incentive programs. Deletes the authority of state agencies to allow certain former personnel and their eligible dependents the option of continuing to participate in certain group insurance plans or self-insurance plans, etc. Effective Date: 07/01/2011

**SB 404 (2R) by Senator Wise—**

**Transition-to-adulthood Services;** Provides legislative intent concerning transition-to-adulthood services for youth in the custody of the Department of Juvenile Justice (DJJ). Provides for eligibility for services for youth served by the DJJ who are legally in the custody of the Department of Children and Family Services (DCFS). Provides that an adjudication of delinquency does not disqualify a youth in foster care from certain services from the DCFS. Provides powers and duties of the DJJ for transition services. Provides for assessments, etc. Effective Date: 07/01/2011

*Reported favorably by the Committee on Children, Families, and Elder Affairs; reported favorably, with one amendment, by the Committee on Criminal Justice; and withdrawn from the Committee on Budget*

**CS/SB 606 (2R) by the Committee on Agriculture and Senator Evers—**

**Fertilizer;** Deletes legislative findings relating to the implementation by local governments of certain fertilizer management practices. Deletes authority for certain counties and municipalities to adopt fertilizer management practices more stringent than standards of a specified model ordinance. Requires the Department of Agriculture and Consumer Services to regulate the sale, composition, formulation, packaging, use, application, and distribution of fertilizer. Preempts such regulation of fertilizer to the state and the department, etc. Effective Date: 07/01/2011

**CS/SB 770 (2R) by the Committee on Environmental Preservation and Conservation and Senator Siplin—**

**Unclaimed Deposits Held By Utilities;** Requires that any unclaimed deposits held by a utility be deposited annually into the Ecosystem Management and Restoration Trust Fund in the Department of Environmental Protection to improve the water quality in Silver Springs and into the Grants and Donations Trust Fund in the Department of Community Affairs, or its successor agency, to supplement the Low-Income Home Energy Assistance Program. Effective Date: 07/01/2011

**SB 962 (2R) by Senator Detert—**

**SB 974 (2R) by Senator Detert—**

**SB 982 (2R) by Senator Norman—**

**Wage Protection for Employees;** Cites this act as the "Florida Wage Protection Act." Provides legislative findings. Prohibits a county, municipality, or political subdivision of the state from adopting a wage theft ordinance or regulation that exceeds certain state and federal laws. Preempts such activities to the state. Effective Date: 07/01/2011

**SB 1052 (2R) by Senator Altman—**

**Crisis Stabilization Units;** Increases the number of client beds a crisis stabilization unit is authorized to provide. Effective Date: 07/01/2011

**CS/SB 1384 (2R) by the Committee on Commerce and Tourism and Senator Altman—**

**Transfer of Tax Liability;** Revises provisions relating to tax liability when a person transfers or quits a business. Provides that the transfer of the assets of a business or stock of goods of a business under certain circumstances is considered a transfer of the business. Provides that transferees of the business are liable for certain taxes unless specified conditions are met. Provides methods for calculating the fair market value or total purchase price of specified business transfers to determine maximum tax liability of transferees, etc. Effective Date: 07/01/2011

*Reported favorably as a committee substitute by the Committee on Commerce and Tourism; the Committee on Judiciary reports the committee substitute favorably; and withdrawn from the Committee on Budget*

**CS/CS/SB 1460 (2R) by the Committees on Communications, Energy, and Public Utilities, Commerce and Tourism and Senator Bennett—**

**Energy Economic Zones;** Revises the date by which the Department of Community Affairs, with the assistance of the Office of Tourism, Trade, and Economic Development, must submit a report to the Governor and Legislature evaluating whether the Energy Economic Zone Pilot Program has demonstrated success. Requires that all incentives and benefits provided to enterprise zones be made available to energy economic zones by a specified date. Provides that certain developments in an energy economic zone are exempt from review as a development of regional impact, etc. Effective Date: 07/01/2011

*Reported favorably as a committee substitute by the Committee on Commerce and Tourism; reported favorably as a committee substitute by the Committee on Communications, Energy, and Public Utilities; and withdrawn from the Committees on Community Affairs; and Budget*

**SB 1508 (2R) by Senator Wise—**

**Costs of Prosecution;** Requires the clerk of the court to distribute the funds received from a defendant according to a specified order of priority when the defendant makes a partial payment to the clerk of costs of prosecution. Requires that a portion of the costs of prosecution be remitted to the State Attorneys Revenue Trust Fund. Imposes certain costs on persons whose cases are disposed of under a pretrial intervention program or pretrial substance abuse intervention program, etc. Effective Date: 07/01/2011

*Reported favorably by the Committee on Criminal Justice; reported favorably, with one amendment, by the Committee on Judiciary; and withdrawn from the Committee on Budget*

**CS/SM 1598 (2R) by the Committee on Governmental Oversight and Accountability and Senator Siplin—**

**Tax Increase Prevention and Reconciliation Act;** Urges the Congress of the United States to support repeal of Section 511 of the Tax Increase Prevention and Reconciliation Act, which requires governments that annually spend more than \$100 million to withhold a 3 percent federal tax on payments made for certain goods and services.

**CS/SB 1748 (2R) by the Committee on Health Regulation and Senator Flores—**

**Abortions;** Defines the term "viability" as it relates to the termination of a pregnancy. Restricts the circumstances in which an abortion may be performed in the third trimester or after viability. Requires an abortion clinic to provide conspicuous notice on any form or medium of advertisement that the abortion clinic is prohibited from performing abortions in the third trimester or after viability. Prohibits a termination of pregnancy from being performed in a location other than a validly licensed hospital, abortion clinic, or physician's office, etc. Effective Date: 10/01/2011

*Reported favorably as a committee substitute by the Committee on Health Regulation; and withdrawn from the Committees on Criminal Justice; and Budget*

**CS/SB 1808 (2R) by the Committee on Criminal Justice and Senator Diaz de la Portilla—**

**Assault or Battery;** Increases the mandatory minimum term of imprisonment for battery of a law enforcement officer or firefighter while possessing a firearm or destructive device. Increases the mandatory minimum term of imprisonment for such a battery while possessing a semiautomatic firearm and its high-capacity detachable box magazine or a machine gun. Effective Date: 10/01/2011

*Reported favorably as a committee substitute by the Committee on Criminal Justice; and withdrawn from the Committee on Budget*

**SB 2056 (2R) by the Committee on Rules Subcommittee on Ethics and Elections—**

**OGSR/Commission on Ethics;** Amends provisions which provide exemptions from public records and public meeting requirements for records and meetings related to audits and investigations conducted by the Commission on Ethics of alleged violations of certain lobbyist registration and reporting requirements. Saves the exemptions from repeal under the Open Government Sunset Review Act. Removes the scheduled repeal of the exemptions. Effective Date: 07/01/2011

*Reported favorably by the Committee on Rules Subcommittee on Ethics and Elections; and withdrawn from the Committees on Rules; and Governmental Oversight and Accountability*

**CS/SB 2062 (2R) by the Committees on Judiciary, and Children, Families, and Elder Affairs—**

**Persons with Developmental Disabilities;** Prohibits monitoring requirements that mandate pornographic materials be available in residential facilities that serve clients of the Agency for Persons with Disabilities. Requires the court to order a person involuntarily admitted to residential services to be released to the agency for appropriate residential services. Forbids the court from ordering that such person be released directly to a residential service provider. Authorizing the agency to transfer a person from one residential setting to another, etc. Effective Date: 07/01/2011

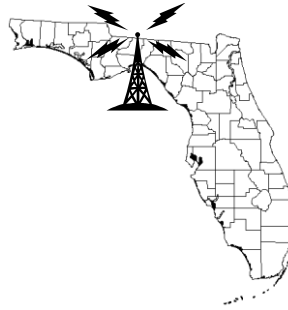
