## SJR 2 by Haridopolos

**Health Care Services;** Proposes an amendment to the State Constitution to prohibit laws or rules from compelling any person, employer, or health care provider to participate in any health care system. Permits a person or an employer to purchase lawful health care services directly from a health care provider. Permits a health care provider to accept direct payment from a person or an employer for lawful health care services, etc.

## SB 78 by Lynn

**Environmental Surcharge On Bottled Water;** Establishes a surcharge on bottled water sold at retail in this state. Provides an exception. Requires that moneys collected from the surcharge be deposited into the Ecosystem Management and Restoration Trust Fund. Effective Date: 10/01/2011.


