Canned or Perishable Food Distributed Free of Charge; Limiting the liability of public schools with respect to canned or perishable food donated to charitable or nonprofit organizations, etc. Effective Date: 07/01/2014

Similar to **HB 23(HC)** in the Committees on Education; Children, Families, and Elder Affairs; and Judiciary

CS/SB 1024, 1st Eng. (3R) by the Committee on Transportation and Senator Dean—

Off-highway Vehicles; Revising the terms "ATV" and "ROV"; revising a violation for carrying an operator and more than a single passenger on certain off-highway vehicles to prohibit carrying more passengers than the vehicle is designed to carry; amending a penalty provision to apply to off-highway vehicles; revising the term "all-terrain vehicle", etc. Effective Date: 07/01/2014

Read the second time and amended on April 11, 2014

CS/CS/SB 1070 (3R) by the Committees on Transportation, Community Affairs and Senator Simpson—

Fuel Terminals; Prohibiting a local government from amending its local comprehensive plan, land use map, zoning districts, or land development regulations to make a fuel terminal a nonconforming use under the provisions thereof; requiring a local government to allow the repair of a fuel terminal damaged or destroyed by a natural disaster or other catastrophe, etc. Effective Date: 07/01/2014

Insurance; Authorizing an insurer's designee to provide certain coverage information to an insurance administrator; prohibiting a person from acting as an insurance administrator without a specific written agreement; requiring an insurance administrator to furnish fiduciary account records to an insurer or its designee; revising provisions for unfair methods of competition and unfair or deceptive acts relating to conducting certain insurance transactions through credit card facilities, etc. Effective Date: 07/01/2014

Estates; Providing that certain restrictions on gifts to lawyers and other disqualified persons apply to written instruments executed on or after a specified date; clarifying circumstances under which a burden of proof shifts in cases involving undue influence; requiring that a directive to apply certain death benefits for the payment of claims and administration expenses be specified in certain instruments; establishing which party bears the burden of proof in an action to contest the validity or revocation of a trust, etc. Effective Date: Upon becoming a law

Certificates of Title; Revising the required statement that is stamped on a certificate of title upon issuance of the certificate; requiring the Department of Highway Safety and Motor Vehicles to provide a report regarding certificates of title for rebuilt motor vehicles; revising requirements for the department to declare certain mobile homes and motor vehicles unrebuildable and to issue a certificate of destruction; requiring an owner of, or an insurance company for, a motor vehicle that is worth less than a specified amount or is above a certain age to obtain a certificate of destruction under certain circumstances; providing a criminal penalty, etc. Effective Date: 07/01/2014

SB 374 (3R) by Senator Detert-

Growth Management; Revising restrictions on an initiative or referendum process with regard to local comprehensive plan amendments and map amendments, etc. Effective Date: Upon becoming a law

CS/HB 7035, 1st Eng. (3R) by the Committees on Judiciary Committee, Criminal Justice Subcommittee, Representative Grant and others—

Juvenile Sentencing; Provides criminal penalties applicable for certain serious felonies by juveniles; requires judge to consider specified factors before determining if life imprisonment is appropriate; provides review of sentences for specified offenders; provides for proceedings for determining if life imprisonment is appropriate for offender convicted of certain offenses; provides sentence review proceedings after specified period by original sentencing court for certain offenders; provides for subsequent reviews; requires DOC to notify offender of eligibility for sentence review; entitles offender to counsel; provides factors to be considered in sentence review; requires court to modify sentence if certain factors found; requires court to impose probation if sentence modified; requires written findings if court declines to modify sentence. Background Screening; Authorizing the Department of Highway Safety and Motor Vehicles to share reproductions of driver license images with the Department of Health and the Agency for Health Care Administration for specified purposes; revising provisions relating to the exemption of certain membership organizations affiliated with national organizations from certain child care facility licensing requirements; exempting a person whose fingerprints are already enrolled in a certain Federal Bureau of Investigation program from the requirement that such fingerprints be forwarded to the bureau, etc. Effective Date: 07/01/2014

Service of Process; Requires sheriffs to charge uniform fee for service of process; requires employer to permit authorized individual to make service on employee in private area designated by employer; provides civil fine; authorizes substitute service during first attempt of service at sole proprietorship under certain circumstances; requires person requesting service or person authorized to serve process to file return-of-service form; revises provision on service of corporation; authorizes sheriff to rely on affidavit submitted by levying creditor & apply for instructions from court regarding distribution of proceeds from sale of levied property. Effective Date: 07/01/2014

Substituted for SB 620(SUB) (Detert) and read the second time on April 11, 2014

CS/SB 1002 (3R) by the Committee on Banking and Insurance and Senator Hays—

Public Records/Office of Financial Regulation; Providing a public records exemption for information held by the Office of Financial Regulation pursuant to an investigation or examination of consumer collection agencies; providing for future repeal and legislative review of the exemption under the Open Government Sunset Review Act; providing a statement of public necessity, etc. Effective Date: On the same date that SB 1006 or substantially similar legislation takes effect, if such legislation is adopted in the same legislative session or an extension thereof and becomes a law

SB 1108 (3R) by the Committee on Community Affairs (Simpson)—

OGSR/Children of Agency Officers and Employees/Identifying Information; Amending provisions relating to an exemption from public record requirements for personal identifying information of certain dependent children of current or former agency officers or employees; removing the scheduled repeal of the exemption, etc. Effective Date: 10/01/2014

CS/CS/SB 1300, 1st Eng. (3R) by the Committees on Governmental Oversight and Accountability, Banking and Insurance and Senator Simmons—

Municipal Governing Body Meetings; Authorizing the governing body of a municipality to hold joint meetings with the governing body of the county within which the municipality is located or the governing body of another municipality; authorizing the governing body of a municipality to prescribe the time and place of joint meetings by ordinance or resolution, etc. Effective Date: 07/01/2014

HB 513 (3R) by Representative Raulerson and others—

State Poet Laureate; Assigns duties to Florida Council on Arts & Culture relating to promotion of poetry & recommendations for appointment of State Poet Laureate; creates honorary position of State Poet Laureate within DOS; establishes procedures for acceptance of nominations, qualifications & recommendation of nominees, & appointment of State Poet Laureate; provides for filling vacancies; specifies that former poet laureate becomes State Poet Laureate Emeritus or Emerita; provides that State Poet Laureate, State Poet Laureate Emerita serve without compensation; authorizes department to adopt rules. Effective Date: 07/01/2014

Substituted for **SB 290(SUB)** (Hukill) and read the second time on April 11, 2014

Notaries Public; Requiring a notary public to record specified information in a notarial journal when performing certain notarial acts; requiring that a notary public retain a notarial journal for a specified period; requiring a notary public to notify the Notary Section of the Executive Office of the Governor if a notarial journal is lost, stolen, misplaced, destroyed, erased, compromised, rendered unusable, or becomes otherwise inaccessible during the retention period; exempting certain acts of specified law enforcement and correctional officers from the notarial journal requirements, etc. Effective Date: 01/01/2015

Reported favorably as a committee substitute by the Committee on Commerce and Tourism; and reported favorably as a committee substitute by the Committee on Regulated Industries

SB 724 (SO) by Senator Dean and others—

Military Veterans; Revising references from the "Korean Conflict" and the "Vietnam Era" to the "Korean War" and the "Vietnam War," respectively, and from "Korean Conflict Veteran" to "Korean War Veteran"; authorizing the issuance of a Combat Medical Badge license plate; revising references; establishing a method of proof of eligibility for certain specialty license plates, etc. Effective Date: 07/01/2014

Reported favorably by the Committee on Military and Veterans Affairs, Space, and Domestic Security; reported favorably by the Committee on Transportation; and reported favorably by the Committee on Appropriations

Identical to **HB 559(HC)** in the Committees on Military and Veterans Affairs, Space, and Domestic Security; Transportation; and Appropriations

CS/CS/CS/SB 722 (SO) by the Committees on Judiciary, Children, Families, and Elder Affairs, Health Policy, Senator Garcia and others—

Newborn Health Screening; Authorizing the State Public Health Laboratory to release the results of a newborn's hearing and metabolic tests or screenings to the newborn's health care practitioner; requiring an audiologist to provide an opportunity for the parent or legal guardian of an infant or toddler who is diagnosed with a hearing impairment to provide contact information so that he or she may receive information directly from specified service providers; requiring the Department of Health to post a list of certain service providers on the department website; requiring the audiologist or his or her designee to transmit a consent form to the providers listed on the department website, etc. Effective Date: 07/01/2014

CS/SB 726 (SO) by the Committee on Governmental Oversight and Accountability and Senator Detert—

Reemployment Assistance Appeals Commission; Revising membership requirements of the commission; removing a provision requiring payment of a daily stipend for certain commissioners, etc. Effective Date: 07/01/2014

Reported favorably by the Committee on Commerce and Tourism; reported favorably as a committee substitute by the Committee on Governmental Oversight and Accountability; and the Committee on Appropriations reports the committee substitute favorably

CS/SB 564 (SO) by the Committee on Banking and Insurance and Senator Richter—

Security for Public Deposits; Clarifying provisions relating to public deposits that are exempt from state security requirements; providing that a notice of the default or insolvency of a qualified public depository is not required if the Florida public deposits are acquired by a bank, savings bank, or savings association; providing that a bank, savings bank, or savings association that is not a qualified public depository and acquires Florida public deposits is subject to certain requirements; providing that a protection from loss is effective when a public depositor does not comply with certain provisions under specified circumstances, etc. Effective Date: 07/01/2014

Reported favorably as a committee substitute by the Committee on Banking and Insurance; Appropriations Subcommittee on General Government recommends the committee substitute favorably; and the Committee on Appropriations reports the committee substitute favorably

Similar to **HB 7009(HC)** in the Committees on Banking and Insurance; Appropriations Subcommittee on General Government; and Appropriations

CS/SB 762 (SO) by the Committee on Governmental Oversight and Accountability and Senator Detert—
