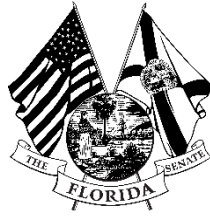

#### **SB 8 (SO) by Senator Benacquisto—**

**Florida Statutes;** Amending provisions to conform to the directive of the Legislature in section 9 of chapter 2012-116, Laws of Florida, codified as section 11.242(5)(j), Florida Statutes, to prepare a reviser's bill to omit all statutes and laws, or parts thereof, which grant duplicative, redundant, or unused rulemaking authority, etc. Effective Date: On the 60th day after adjournment sine die of the session of the Legislature in which enacted

#### **SB 180 (SO) by Senator Stargel and others—**

**Lost or Abandoned Personal Property;** Providing that certain provisions relating to lost or abandoned property do not apply to personal property lost or abandoned on the premises of certain complexes or facilities if certain conditions are met; providing for the disposal or donation of personal property lost or abandoned on the premises of certain complexes or facilities, in certain circumstances, etc. Effective Date: 07/01/2019

**CS/CS/CS/SB 182 (SO) by the Committees on Rules, Innovation, Industry, and Technology, Health Policy, Senator Brandes and others—**

**Medical Use of Marijuana;** Redefining the term “marijuana delivery device” to eliminate the requirement that such devices must be purchased from a medical marijuana treatment center; redefining the term “medical use” to include the possession, use, or administration of marijuana in a form for smoking; restricting the smoking of marijuana in enclosed indoor workplaces; prohibiting a physician from certifying a patient under 18 years of age to smoke marijuana for medical use unless the patient is diagnosed with a terminal condition and the physician makes a certain determination in concurrence with a second physician who is a pediatrician, etc. Effective Date: Upon becoming a law

**CS/SB 7006 (SO) by the Committees on Rules, and Judiciary (Simmons)—**

**Uniform Interstate Depositions and Discovery Act;** Designating the “Uniform Interstate Depositions and Discovery Act”; requiring a party to submit a foreign subpoena to a clerk of court in this state for the issuance of a subpoena in this state; requiring the clerk of court to promptly issue a subpoena for service upon the person to whom the foreign subpoena is directed; requiring that the service of the subpoena be served in compliance with the laws of this state and the Florida Rules of Civil Procedure, etc. Effective Date: 07/01/2019

**SB 7058 (SO) by the Committee on Appropriations (Bradley)—**

**Trust Funds/Administrative Trust Fund/Department of Highway Safety and Motor Vehicles;** Creating the Administrative Trust Fund within the Department of Highway Safety and Motor Vehicles; providing for the purpose of the trust fund and sources of funds; providing for future review and termination or re-creation of the trust fund, etc. Effective Date: 07/01/2020

**SB 7060 (SO) by the Committee on Appropriations (Bradley)—**

**Termination of the Working Capital Trust Fund within the Department of Highway Safety and Motor Vehicles;** Terminating the Working Capital Trust Fund within the Department of Highway Safety and Motor Vehicles; providing for the transfer of balances in and revenues of the trust fund; repealing provisions which saved the trust fund from termination, etc. Effective Date: 07/01/2019

**FIRST PUBLICATION ON SECOND READING**

**SB 186 (2R1) by Senator Lee and others—**

**Public Records/Victim of Mass Violence;** Defining the term “killing of a victim of mass violence”; expanding an existing exemption from public records requirements for a photograph or a video or audio recording held by an agency which depicts or records the killing of a law enforcement officer to include a photograph or a video or audio recording held by an agency which depicts or records the killing of a victim of mass violence; providing for future legislative review and repeal of the exemption; providing a statement of public necessity, etc. Effective Date: Upon becoming a law

**CS/SB 262 (2R1) by the Committee on Judiciary, Senator Albritton and others—**

**Child Welfare;** Providing for the name of a child’s guardian ad litem or attorney ad litem to be entered on court orders in dependency proceedings; requiring cooperation between certain parties and the court to achieve permanency for a child as soon as possible; requiring the court during an adjudicatory hearing to advise parents in plain language of certain requirements to achieve permanency with their child, etc. Effective Date: 10/01/2019

**SR 682 (2R1) by Senator Diaz and others—**
