CHAIR GALVANO: Okay, good evening. We will call to order the Conference on Reapportionment between the House and the Senate.

Chairman Oliva, welcome.

REPRESENTATIVE OLIVIA: Thank you, Chair Galvano, it is a pleasure to be here.

CHAIR GALVANO: Well, great. Well, we have, as you know, asked for this conference after receiving the House plan which is 9079 in terms of maps. And we -- I have had a chance to go through it as have most of our members and quite frankly it is very similar, very similar.

It was obviously based off the Senate proposal that went over to the House and there were some changes that I believe incorporated the Plaintiffs' changes as well as other things that made it more compact and in compliance with the metrics.

We did have -- have some questions that came up today and some continued concerns regarding South Florida in particular. And so, you know, I thought maybe to start we could --

if I could make a request and maybe we get an answer now or when we reconvene, but there were -- were some questions that I had regarding Lake County and how -- what the justification was on that -- that configuration.

REPRESENTATIVE OLIVIA: Thank you, Chair Galvano. I should say on the record that a quorum of two is present.

CHAIR GALVANO: Does that make one a quorum?

REPRESENTATIVE OLIVIA: I am not sure.

Does the tie go to the runner in this case?

That is based, that is a Trujillo joke. I have to give him credit for that.

So Mr. Jason Poreda is here with us. As you know, he is one of the map drawers on the House side. And so any questions that you may have we can certainly have him try to address now. Any questions that would require them to go back and look at any area in order to do, we can certainly instruct them to do that. So feel free to ask any questions.

CHAIR GALVANO: Okay, well, why don't -- why don't we do this. If we can just make a note of that in terms of any justification that

was asked and, you know, instead of going through the changes at this point why don't we make a recommendation to you and if you agree then it will give staff something to work on over the evening and come back to us.

And that recommendation would be for us to have the staff go back and look at South Florida, in particular, Miami-Dade, and what I would like to have done is for us to look back at the base map that have been proposed and see if there is a configuration within those base maps that could be juxtaposed into 9079 that might improve the overall metric. And, you know, then we could get some feedback on that and then decide where we go from there.

REPRESENTATIVE OLIVIA: I think that we are very open to taking a look at that and your concerns in that area, and to -- and to check on those other base maps that were put together and see if any one of those configurations would improve the map.

CHAIR GALVANO: Okay, well, if we can instruct House and Senate staff to do that along with the assistance of counsel, I think that -- that is the directive from this

1 conference committee at this point. And then we, once we have that and we reconvene if there 2 are any other questions then we can work that 3 4 through. Have we talked about time for 5 tomorrow? 6 REPRESENTATIVE OLIVA: We have not. 7 CHAIR GALVANO: I guess it would depend on 8 where the staff is and where our presiding officers think we can work it into the 9 10 schedule. 11 REPRESENTATIVE OLIVIA: Well, I concur. 12 CHAIR GALVANO: Okay, well, then that is 13 what we will do.
