33	26	DOC / CJEC BUDGET AMENDMENT. Amends s. 216.262, F.S. to allow the Executive Office of the Governor (EOG) to request additional positions and appropriations from unallocated general revenue during the 2016-2017 fiscal year for the Department of Corrections (DOC) if the actual inmate population of the DOC exceeds certain Criminal Justice Estimating Conference forecasts. The additional positions and appropriations may be used for essential staff, fixed capital improvements, and other resources to provide classification, security, food services, health services, and other variable expenses within the institutions to accommodate the estimated increase in the inmate population, and are subject to LBC review and approval. 34	27	DEPARTMENT OF LEGAL AFFAIRS. Authorizes DLA to expend appropriated funds in those specific appropriations on the same programs that were funded by the department pursuant to specific appropriations made in general appropriations acts in prior years.	House	House

Amends s. 932.7055, F.S. relating to the disbursement of proceeds from the sale of forfeited property to extend for another year the authorization for a municipality to expend funds in a special law enforcement trust fund to reimburse the general fund of the municipality for moneys advanced from the general fund to the special law enforcement trust fund prior to October 1, 2001. 36	29	COURT TRUST FUND LOAN. Amends s. 215.18, F.S. to provide chief justice the authority to request a trust fund loan.	House	House
37	30	DEPARTMENT OF CORRECTIONS - SALARIES & BENEFITS. Provides that Department of Corrections may not transfer funds from a salaries and benefits category to any other category within the department other than a salaries and benefits category without approval of the Legislative Budget Commission. NEW		DEPARTMENT OF CORRECTIONS - HEALTH SERVICES BUDGET AMENDMENTS. Authorizes DOC to seek authorization to move funds to Health Services through a 14-day budget amendment instead of the Legislative Budget Commission to avoid any delay in funding those services.	House	House
38	31	DEPARTMENT OF JUVENILE JUSTICE. Requires the Department of Revenue to review county juvenile detention payments to the Department of Juvenile Justice to ensure that counties are fulfilling their financial responsibilities. If the Department of Revenue determines that a county has not met its obligations, it must deduct the amount owed to the Department of Juvenile Justice from shared revenue funds provided to the county under s. 218.23, F.S. N/A	NEW	<p>LAW ENFORCEMENT CAREER DEVELOPMENT WORK PLAN GROUP. Section X. In order to implement Specific Appropriation ***** of the 2016-2017 General Appropriation Act, the Florida Department of Management Services (DMS) shall organize a special work group to develop a sworn law enforcement officers' career development plan for the Highway Patrol, Law Enforcement Officer, Lottery, and FDLE Special Agent bargaining units represented by the Florida Police Benevolent Association (PBA). The scope of the work group is to create a law enforcement officers' career development plan to attract and retain quality employees. The work group will create a work plan for all represented agencies that emphasizes job training, job skills, educational attainment, experience and retention.</p> <p>The work group shall consist of the following representatives: at least one agency management representative from each law enforcement agency; at least three representatives from DMS, one of whom will serve as the work group chair; a least one active law enforcement officer, as designated by the PBA from each agency represented by a bargaining unit, one of whom will serve as the work group's vice chair; and a least three representatives from the PBA.</p> <p>The work group will meet on or after July 1, 2016 and conduct meetings as necessary to complete a career development plan proposal by no later than November 30, 2016. Time spent in travel and attendance at the meeting shall be considered as time worked for the active law enforcement officers. The proposal shall be presented to the President of the Senate and the Speaker of the House of Representatives by December 1, 2016.</p>	Senate

Authorizes the Justice Administrative Commission to reimburse the clerks of the court for expenses necessary to pay compensation to jurors and for meals or lodging provided to jurors. In addition, authorizes the Justice Administrative Commission to reimburse clerks of the court for all jury-related personnel costs.	Senate
