



Sitewide


The website layout expands to fit wide screens; but minimally fits 1024 x 768.

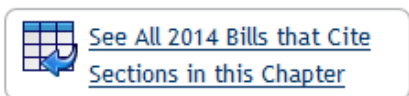

This calendar compiles Senate meeting information, video broadcasting, and meeting records for each day. Use the arrows or calendar icon to see data for past or future dates.

1. **Calendar** tab includes all Senate and Joint meetings and video broadcasts. Add the meeting to your calendar. Expand the meeting records links to see the pre-meeting records, such as the Expanded Agenda. For past meetings, video and audio are also available, including meetings from previous sessions.
2. **Filed Today** tab shows all bill versions, PCSs, and Amendments filed on that date.
3. **Bill Actions** tab displays all the Senate actions for that date.
4. **Floor Bills** tab will display during session and contain all bills on Senate Floor Calendars.
5. **Calendar Links** display additional meeting information.

Statute Citation Bill Search

On chapter or section pages within the Florida Statutes, a button enables users to quickly see all bills that cite that chapter or section. The search defaults to the current year, but that can be changed on the results page to any session on the site. Searching on a chapter number will also return bills that would create a new section in the chapter.

- Search for a word or phrase within the current version of bills, all bill version, and amendments.
- Search for bills by citation. Enter a chapter or section number for Statutes; enter an article or section number for the Florida Constitution.
- Additional filters were added for searching by bill type, effective date, location, filed between dates, committee references, in committee, and on a committee agenda.
