### SPECIAL ORDER CALENDAR FOR THURSDAY, FEBRUARY 29, 2024

#### **CS/SB 7072 (SO) by the Committee on Fiscal Policy, and the Appropriations Committee on Health and Human Services (Harrell)—**

**Cancer Funding;** Revising the purpose of the Casey DeSantis Cancer Research Program; revising duties of the Department of Health under the program; creating the Cancer Connect Collaborative, a council, within the department for a specified purpose; requiring the collaborative to advise the department on the awarding of grants issued through the Cancer Innovation Fund; requiring the collaborative to review grant applications and make recommendations to the department for awarding grants upon the appropriation of funds to the fund, etc. Effective Date: 07/01/2024

*Reported favorably as a committee substitute by the Committee on Fiscal Policy*

---

#### **SB 7078 (SO) by the Committee on Fiscal Policy (Hutson)—**

**Public Records and Meetings/Cancer Research Grant Applications;** Providing an exemption from public records requirements for proprietary business information included in cancer research grant applications submitted to the Cancer Connect Collaborative and records generated by the collaborative relating to the review of such information; providing an exemption from public meeting requirements for portions of collaborative meetings during which such proprietary business information is discussed; providing for legislative review and repeal of the exemptions; providing statements of public necessity, etc. Effective Date: On the same date that SB 7072 or similar legislation takes effect, if such legislation is adopted in the same legislative session or an extension thereof and becomes a law

#### **CS/SB 62 (SO) by the Committee on Education Postsecondary, Senator Osgood and others—**

**Resident Status for Tuition Purposes;** Providing that a person may not lose his or her resident status for tuition purposes due to incarceration, etc. Effective Date: 07/01/2024

*Reported favorably as a committee substitute by the Committee on Education Postsecondary; the Appropriations Committee on Education reports the committee substitute favorably; and the Committee on Fiscal Policy reports the committee substitute favorably*

---

#### **SB 1512 (SO) by Senator Brodeur—**

**Controlled Substances;** Adding tianeptine to the list of Schedule I controlled substances, etc. Effective Date: 07/01/2024

*Reported favorably by the Committee on Criminal Justice; reported favorably by the Appropriations Committee on Criminal and Civil Justice; and reported favorably by the Committee on Fiscal Policy*

---

#### **CS/CS/SB 1704 (SO) by the Committees on Rules, Community Affairs and Senator Yarborough—**

**Sheriffs in Consolidated Governments;** Authorizing sheriffs in a consolidated government, as well as all other sheriffs, to transfer funds after their budgets are approved by the board of county commissioners, city council, or budget commission, etc. Effective Date: 07/01/2024

*Reported favorably as a committee substitute by the Committee on Community Affairs; and reported favorably as a committee substitute by the Committee on Rules*

---

**CS/CS/SB 1456 (SO) by the Committees on Finance and Tax, Community Affairs and Senator Rodriguez—**

**Counties Designated as Areas of Critical State Concern;** Adding certain requirements to local comprehensive plans relating to a hurricane evacuation study; revising the powers of the land authority; excluding land designated as an area of critical state concern within a specified timeframe from award requirements made to specified sponsors or persons for the purpose of providing eligible housing as a part of a local housing assistance plan; requiring that the expenditure of certain funds be subject to approval by a majority vote of the board of county commissioners of an eligible county, etc. Effective Date: 07/01/2024

*Reported favorably as a committee substitute by the Committee on Community Affairs; reported favorably as a committee substitute by the Committee on Finance and Tax; and the Committee on Appropriations reports the committee substitute favorably*

---

**CS/CS/CS/SB 382 (SO) by the Committees on Rules, Governmental Oversight and Accountability, Regulated Industries and Senator Hooper—**

**Continuing Education Requirements;** Requiring, rather than authorizing, a board, or the Department of Business and Professional Regulation when there is no board, to allow by rule that distance learning may be used to satisfy continuing education requirements; revising the requirements that such continuing education must satisfy; requiring a board, or the department when there is no board, to exempt certain individuals from completing their continuing education requirements, etc. Effective Date: 07/01/2024

*Reported favorably as a committee substitute by the Committee on Regulated Industries; reported favorably as a committee substitute by the Committee on Governmental Oversight and Accountability; and reported favorably as a committee substitute by the Committee on Rules*

---

**CS/SB 676 (SO) by the Committee on Regulated Industries and Senator Bradley—**

**Food Delivery Platforms;** Prohibiting food delivery platforms from taking or arranging for the delivery or pickup of orders from a food service establishment without the food service establishment's consent; requiring food delivery platforms to provide food service establishments with a method of contacting and responding to consumers by a specified date; providing circumstances under which a food delivery platform must remove a food service establishment's listing on its platform; preempting regulation of food delivery platforms to the state, etc. Effective Date: Upon becoming a law

*Reported favorably as a committee substitute by the Committee on Regulated Industries; the Appropriations Committee on Agriculture, Environment, and General Government reports the committee substitute favorably; and the Committee on Fiscal Policy reports the committee substitute favorably*

---

**CS/SB 692 (SO) by the Committee on Regulated Industries and Senator Hutson—**

**Public Records/Florida Gaming Control Commission;** Providing an exemption from public records requirements for the personal identifying and location information of current or former commissioners of the Florida Gaming Control Commission and the spouses and children of such current or former commissioners; providing for retroactive application; providing for future legislative review and repeal of the exemption; providing a statement of public necessity, etc. Effective Date: 07/01/2024

*Reported favorably as a committee substitute by the Committee on Regulated Industries; the Committee on Governmental Oversight and Accountability reports the committee substitute favorably; and the Committee on Rules reports the committee substitute favorably*

---

**CS/CS/CS/SB 86 (SO) by the Committee on Fiscal Policy, the Appropriations Committee on Criminal and Civil Justice, the Committee on Judiciary, Senator Book and others—**

**Hope Cards for Persons Issued Orders of Protection;** Requiring the clerks of the circuit court, in consultation with the Office of the Attorney General, to develop and implement the Hope Card Program; requiring clerks' offices to create a Hope Card and provide such card to petitioners within a specified time frame; providing criminal penalties for the fraudulent use of a Hope Card, etc. Effective Date: 10/01/2024

*Reported favorably as a committee substitute by the Committee on Judiciary; the Appropriations Committee on Criminal and Civil Justice reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Fiscal Policy*

---

**CS/CS/SB 808 (SO) by the Committees on Appropriations, Criminal Justice, Senator DiCeglie and others—**

**Treatment by a Medical Specialist;** Authorizing firefighters, law enforcement officers, correctional officers, and correctional probation officers to receive medical treatment by a medical specialist for certain conditions under certain circumstances; requiring firefighters, law enforcement officers, correctional officers, and correctional probation officers to notify certain entities of their selection of a medical specialist, etc. Effective Date: 10/01/2024

*Reported favorably as a committee substitute by the Committee on Criminal Justice; the Appropriations Committee on Agriculture, Environment, and General Government reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Appropriations*

---

**CS/SB 274 (SO) by the Committee on Children, Families, and Elder Affairs and Senator Rodriguez—**

**Child Water Safety Requirements;** Citing this act as the "Kareem Angel Green Act"; providing that certain organizations that care for or supervise children must require parents or legal guardians to attest to certain information in writing before taking such children to public bathing places and public swimming pools; providing requirements for such organizations when they conduct certain activities in public bathing places or public swimming pools, etc. Effective Date: 07/01/2024

*Reported favorably by the Committee on Health Policy; reported favorably as a committee substitute by the Committee on Children, Families, and Elder Affairs; and the Committee on Rules reports the committee substitute favorably*

---

**CS/CS/SB 592 (SO) by the Committees on Fiscal Policy, Governmental Oversight and Accountability and Senator Burgess—**

**Historical Preservation Programs;** Requiring the Department of State to partner with the Florida African American Heritage Preservation Network for a specified purpose; specifying preservation efforts that may be undertaken through the partnership; requiring the network to submit a list of member museums to the department, etc. Effective Date: 07/01/2024

*Reported favorably as a committee substitute by the Committee on Governmental Oversight and Accountability; the Appropriations Committee on Transportation, Tourism, and Economic Development reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Fiscal Policy*

---

**CS/CS/SB 556 (SO) by the Committees on Rules, Banking and Insurance, Senator Rouson and others—**

**Protection of Specified Adults;** Authorizing financial institutions, under certain circumstances, to delay a disbursement or transaction from an account of a specified adult; specifying that a delay on a disbursement or transaction expires on a certain date; authorizing the financial institution to extend the delay under certain circumstances; authorizing a court of competent jurisdiction to shorten or extend the delay, etc. Effective Date: 01/01/2025

*Reported favorably as a committee substitute by the Committee on Banking and Insurance; the Committee on Children, Families, and Elder Affairs reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Rules*

---

**CS/SB 168 (SO) by the Committee on Health Policy and Senator Polsky—**

**Congenital Cytomegalovirus Screenings;** Requiring certain hospitals to administer congenital cytomegalovirus screenings on newborns admitted to the hospital under specified circumstances; providing coverage under the Medicaid program for the screenings and any medically necessary follow-up reevaluations; requiring that newborns diagnosed with congenital cytomegalovirus be referred to a primary care physician for medical management, treatment, and follow-up services, etc. Effective Date: 07/01/2024

*Reported favorably as a committee substitute by the Committee on Health Policy; the Appropriations Committee on Health and Human Services reports the committee substitute favorably; and the Committee on Fiscal Policy reports the committee substitute favorably*

---

**CS/CS/CS/SB 536 (SO) by the Committee on Fiscal Policy, the Appropriations Committee on Health and Human Services, the Committee on Children, Families, and Elder Affairs and Senator Garcia—**

**Community-based Child Welfare Agencies;** Revising requirements for contracts the Department of Children and Families has with community-based care lead agencies; requiring the lead agency's board of directors to disclose to the department any known actual or potential conflicts of interest; prohibiting a lead agency from entering into a contract or being a party to any transaction with related parties if a conflict of interest is not properly disclosed; requiring the contract with the department and the lead agency to specify the administrative functions and services that the lead agency may subcontract, etc. Effective Date: 07/01/2024

*Reported favorably as a committee substitute by the Committee on Children, Families, and Elder Affairs; reported favorably as a committee substitute by the Appropriations Committee on Health and Human Services; and reported favorably as a committee substitute by the Committee on Fiscal Policy*

---

**CS/SB 484 (SO) by the Committee on Judiciary and Senator Bradley—**

**Flood Disclosure in the Sale of Real Property;** Requiring a seller of residential real property to provide specified information to a prospective purchaser at or before the sales contract is executed; specifying how such information must be disclosed, etc. Effective Date: 10/01/2024

*Reported favorably as a committee substitute by the Committee on Judiciary; the Committee on Fiscal Policy reports the committee substitute favorably; and the Committee on Rules reports the committee substitute favorably*

---

**CS/SB 870 (SO) by the Committee on Governmental Oversight and Accountability and Senator Boyd—**

**Unsolicited Proposals for Public-private Partnerships;** Authorizing, rather than requiring, a responsible public entity to publish notice of an unsolicited proposal for a qualifying project in a specified manner and that other proposals for the same project will be accepted; authorizing a responsible public entity to proceed with an unsolicited proposal for a qualifying project without a public bidding process if the responsible public entity holds a public meeting that meets certain requirements and holds a subsequent public meeting at which it makes a certain determination; requiring the responsible public entity to consider certain factors; requiring the responsible public entity to publish a certain report in the Florida Administrative Register for a certain period of time in certain circumstances, etc. Effective Date: 07/01/2024

*Reported favorably as a committee substitute by the Committee on Governmental Oversight and Accountability; the Committee on Community Affairs reports the committee substitute favorably; and the Committee on Rules reports the committee substitute favorably*

---

## **SB 958 (SO) by Senator Martin and others—**

**Local Government Employees;** Revising the base salary used to calculate the compensation of county tax collectors; defining the term “tax collector employee”; providing that tax collector employees are eligible to receive specified monetary benefits from the state for adopting children within the child welfare system; revising the base salary used to calculate the compensation of district school superintendents, etc. Effective Date: 07/01/2024

*Reported favorably by the Committee on Community Affairs; reported favorably by the Appropriations Committee on Health and Human Services; and reported favorably by the Committee on Fiscal Policy*

---

## **CS/CS/SB 1084 (SO) by the Committee on Fiscal Policy, the Appropriations Committee on Agriculture, Environment, and General Government and Senator Collins—**

**Department of Agriculture and Consumer Services;** Preempting the regulation of electric vehicle charging stations to the state; prohibiting local governmental entities from enacting or enforcing such regulations; providing that a pest control operator’s certificate, a special identification card, and certain limited certifications for pesticide applicators, respectively, expire a specified length of time after issuance; authorizing the department to take disciplinary action against a person who swears to or affirms a false statement on certain applications, cheats on a required examination, or violates certain procedures under certain circumstances; authorizing Class “G” licensees to qualify for multiple calibers of firearms in one requalification class under certain circumstances; prohibiting the manufacture for sale, sale, holding or offering for sale, or distribution of cultivated meat in this state, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon this act becoming a law, this act shall take effect July 1, 2024

## **CS/SB 776 (SO) by the Committee on Children, Families, and Elder Affairs and Senator Powell—**

**Temporary Cash Assistance Eligibility;** Providing that benefits may not be denied to certain victims of human trafficking, etc. Effective Date: 07/01/2024

*Reported favorably as a committee substitute by the Committee on Children, Families, and Elder Affairs; the Appropriations Committee on Health and Human Services reports the committee substitute favorably; and the Committee on Fiscal Policy reports the committee substitute favorably*

---

## **CS/SJR 1560 (SO) by the Committee on Finance and Tax and Senator Collins—**

**Ad Valorem Taxation Exemptions;** Proposing amendments to the State Constitution to authorize the Legislature, by general law, to exempt certain tangible personal property from ad valorem taxation, etc.

*Reported favorably by the Committee on Agriculture; reported favorably as a committee substitute by the Committee on Finance and Tax; and the Committee on Appropriations reports the committee substitute favorably*

## **CS/CS/SB 1262 (SO) by the Committees on Rules, Military and Veterans Affairs, Space, and Domestic Security and Senator Collins—**

**Qualifications for County Emergency Management Directors;** Requiring county emergency management directors to meet specified qualifications; requiring such directors to meet such qualifications by a specified date, etc. Effective Date: 07/01/2024

*Reported favorably as a committee substitute by the Committee on Military and Veterans Affairs, Space, and Domestic Security; the Appropriations Committee on Agriculture, Environment, and General Government reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Rules*

---

## **CS/CS/CS/SB 1224 (SO) by the Committee on Fiscal Policy, the Appropriations Committee on Criminal and Civil Justice, the Committee on Children, Families, and Elder Affairs and Senator Burton—**

**Dependent Children;** Requiring the Statewide Guardian ad Litem Office and circuit guardian ad litem offices to participate in the development of a certain state plan; requiring the court to appoint a guardian ad litem for a child at the earliest possible time; requiring parents to consent to provide certain information to the guardian ad litem and attorney ad litem; requiring a court to give a guardian ad litem an opportunity to address the court in certain proceedings; requiring a court to appoint a guardian ad litem to represent a child in certain proceedings, etc. Effective Date: 07/01/2024

*Reported favorably as a committee substitute by the Committee on Children, Families, and Elder Affairs; reported favorably as a committee substitute by the Appropriations Committee on Criminal and Civil Justice; and reported favorably as a committee substitute by the Committee on Fiscal Policy*

---

## **CS/SB 1082 (SO) by the Committee on Rules and Senator Collins—**

**Housing for Legally Verified Agricultural Workers;** Defining the terms “legally verified agricultural worker” and “housing site”; prohibiting a governmental entity from adopting or enforcing any legislation to inhibit the construction of housing for legally verified agricultural workers on agricultural land operated as a bona fide farm; authorizing governmental entities to adopt local land use regulations that are less restrictive; authorizing the continued use of housing sites constructed before the effective date of the act if certain conditions are met, etc. Effective Date: 07/01/2024

*Reported favorably by the Committee on Community Affairs; reported favorably by the Committee on Agriculture; and reported favorably as a committee substitute by the Committee on Rules*

---

**CS/CS/SB 932 (SO) by the Committee on Appropriations, the Appropriations Committee on Agriculture, Environment, and General Government, Senator Berman and others—**

**Coverage for Diagnostic and Supplemental Breast Examinations;** Prohibiting the state group insurance program from imposing on an enrollee any cost-sharing requirement with respect to coverage for diagnostic breast examinations and supplemental breast examinations, etc. Effective Date: 01/01/2025

*Reported favorably by the Committee on Banking and Insurance; reported favorably as a committee substitute by the Appropriations Committee on Agriculture, Environment, and General Government; and reported favorably as a committee substitute by the Committee on Appropriations*

---

**CS/SB 968 (SO) by the Committee on Rules, Senator Calatayud and others—**

**Spaceport Territory;** Revising the definition of “spaceport discretionary capacity improvement projects”; revising spaceport territory to include certain property; authorizing the Department of Transportation to fund spaceport discretionary capacity improvement projects if important access and on-spaceport-territory space transportation capacity improvements are provided, etc. Effective Date: 07/01/2024

*Reported favorably by the Committee on Military and Veterans Affairs, Space, and Domestic Security; reported favorably by the Committee on Transportation; and reported favorably as a committee substitute by the Committee on Rules*

---

**CS/CS/CS/SB 738 (SO) by the Committees on Fiscal Policy, Judiciary, Environment and Natural Resources and Senator Burgess—**

**Environmental Management;** Requiring that nonindustrial stormwater management systems be designed with side slopes that meet certain minimum design requirements; revising construction relating to causes of action for damages to real or personal property directly resulting from certain discharges or other conditions of pollution, etc. Effective Date: 07/01/2024

*Reported favorably as a committee substitute by the Committee on Environment and Natural Resources; reported favorably as a committee substitute by the Committee on Judiciary; and reported favorably as a committee substitute by the Committee on Fiscal Policy*

---

**CS/CS/CS/SB 1180 (SO) by the Committee on Appropriations, the Appropriations Committee on Health and Human Services, the Committee on Children, Families, and Elder Affairs and Senator Harrell—**

**Substance Abuse Treatment;** Providing the levels of care at certified recovery residences and their respective levels of care for residents; defining the term “community housing”; extending the deadline for certified recovery residences to retain a replacement for a certified recovery residence administrator who has been removed from his or her position; authorizing certain Level IV certified recovery residences owned or controlled by a licensed service provider and managed by a certified recovery residence administrator approved for a specified number of residents to manage a specified greater number of residents, provided that certain criteria are met, etc. Effective Date: 07/01/2024

*Reported favorably as a committee substitute by the Committee on Children, Families, and Elder Affairs; reported favorably as a committee substitute by the Appropriations Committee on Health and Human Services; and reported favorably as a committee substitute by the Committee on Appropriations*

---

**CS/SB 260 (SO) by the Committee on Criminal Justice, Senator DiCeglie and others—**

**Refusal to Submit to a Breath, Urine, or Blood Test;** Requiring that a person arrested for driving or being in actual physical control of a motor vehicle while under the influence who refuses to submit to a lawful test of his or her breath incident to a lawful arrest be told that he or she is subject to mandatory placement, for a specified period, of an ignition interlock device on all vehicles that are individually or jointly leased or owned and routinely operated by the person; directing the department to require placement of an ignition interlock device before issuing a permanent or restricted driver license to a person who refused to submit to a lawful test of his or her breath, etc. Effective Date: 10/01/2024

*Reported favorably by the Committee on Transportation; reported favorably as a committee substitute by the Committee on Criminal Justice; and the Committee on Fiscal Policy reports the committee substitute favorably*

---

**CS/CS/SB 1140 (SO) by the Committees on Fiscal Policy, Regulated Industries and Senator Burton—**

**Mobile Homes;** Requiring that a petition for mediation be filed with the Division of Florida Condominiums, Timeshares, and Mobile Homes of the Department of Business and Professional Regulation to determine the adequacy and conformance of the homeowners' petition to initiate mediation; authorizing parties to disputes to jointly select a mediator and initiate mediation proceedings; requiring that specified live-in health care aides have ingress and egress to and from a mobile home owner's site without having to pay charges, etc. Effective Date: 07/01/2024

*Reported favorably as a committee substitute by the Committee on Regulated Industries; and reported favorably as a committee substitute by the Committee on Fiscal Policy*

---

## **SB 558 (SO) by Senator Rouson—**

**Homeless Service Professionals;** Providing qualifications for certification as a person with lived experience; requiring the Department of Children and Families to conduct background screening; specifying disqualifying offenses for a person applying for certification; authorizing a person who does not meet background screening requirements to request an exemption from disqualification from the department, etc. Effective Date: 07/01/2024
