# a. What specific purpose or goal will be achieved by the funds requested?

To support environmental resilience workforce development through EcoExplorers, a year-long paid education and training internship for 75 high school students from underserved communities. The project will support our region's resilience efforts by developing a better skilled and educated workforce able to support Florida's Statewide Resilience Action Plan and aligns with Governor DeSantis' goal for leading the nation in workforce education by 2030.

# b. What activities and services will be provided to meet the intended purpose of these funds?

MODS will support environmental resilience workforce development through a year-long paid education and training internship for 75 high school students from underserved communities. The project will support regional resilience efforts by developing a better skilled and educated workforce able to support Florida's Statewide Resilience Action Plan and pursue careers in the resilience field.

### c. What direct services will be provided to citizens by the appropriation project?

The project will broaden civic engagement in resilience issues, showcase the work of university researchers and sustainable industries, build community resilience by empowering the public to take personal action, inspire and train young people to pursue the demand for resilience jobs and develop a better skilled workforce that results in a more sustainable Florida.

### d. Who is the target population served by this project? How many individuals are expected to be served?

The project will serve 450,000 annual visitors, including adults, children, parents and grandparents from at least 50 Florida counties, as well as 90,000 students and teachers on field trips annually. 75 high school students, primarily from low-income families residing in underserved Broward communities, will participate in the EcoExplorers year-long paid resilience workforce development internship.

# e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

### be measured?

The project will develop a skilled and educated workforce of young adults, inspire them to pursue the demand for resilience jobs in high demand and empower them to bring about transformative change that results in a more sustainable Florida. As trained environmental educators interpreting the Museum's exhibits and programs, interns will increase public awareness and knowledge about critical climate change issues impacting Florida and compel citizens to make informed decisions and take action. Outcomes will be measured through attendance, program participation, surveys of interns and public feedback.

# for failing to meet deliverables or performance measures provided for the contract?

Funding will be withheld if MODS fails to meet its deliverables of implementing an environmental resilience workforce development internship for 75 high school students from underserved communities who are recruited and trained as environmental educators to interpret resilience exhibits and conduct resilience programs within the Museum's scope as Broward's Hub for Resilience Education to provide greater knowledge for Florida's citizens.
