#### 4. Project/Program Description

Sanibel's entire 12 mile coastline has been significantly eroded, altered and washed out from the storm surge associated with Hurricane Ian. Having well nourished and stabilized beaches/protective dunes on Sanibel are vital components of southwest Florida's economy and important resiliency features that protect upland structures. Sanibel's natural beaches provide important nesting habitat for sea turtles and migratory shore birds. The DEP Hurricane Ian and Nicole Recovery Plan for Florida's Beach and Dune System recommended \$23,793,000 for sand placement to restore Sanibel's beach and dune systems. While Sanibel's beaches will benefit greatly from the partial funding allocated in Senate Bill 4A, this request will supplement those dollars to allow for the complete renourishment and restoration of Sanibel's beaches and dunes.

Sanibel's beaches will again serve the public's outdoor recreation needs, restore economic vitality to Sanibel and SW Florida, provide important nesting habitat for sea turtles and migratory birds. Success will be measured by increased/sustained visitorship to Sanibel's beaches and active nesting seasons for wildlife.
