Funding is being requested for the construction and construction support for stormwater improvements to sub-basin 41. Improvements include building additional catch basins, manholes, culverts & exfiltration to connect the catch basins within this sub-basin. Improvements will reduce pollutant load contribution from 3 main pollutants from the sub-basin into Biscayne Bay Aquifer, control flooding during and after major storm events and improve surface water quality.

The village of Palmetto Bay is responsible for the maintenance of it's sub-basins although they may run under some County owned roads, we coordinate with the County on these matters.



b. What activities and services will be provided to meet the intended purpose of these funds?

A contractor and construction management staff will be sought using a public Invitation to Bid (ITB). A kick-off meeting will be held to go over the project and a start date will be set. Permits will be applied for by the selected contractor, regular project updates will be provided as stated in the final contract with the funding agency.

c. What direct services will be provided to citizens by the appropriation project?

No direct services will be provided, but all Miami-Dade citizens who may drive through the Palmetto Bay Sub-Basin #41 roadways will benefit from having a safe flood free roadway to travel.

d. Who is the target population served by this project? How many individuals are expected to be served?

The targeted population for this project are the residents of the approximately 30.13 acres of existing detached singlefamily residential development with approximately 4,560 linear feet of roadway. The expected number of individuals to be served is 100-200 homes along the impacted roadways and over 1,500 of daily drivers.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The expected outcome of this project is to limit or eliminate standing waster after a heavy storm or rain event. This outcome will be measured by the decreased pollutants recorded, number of complaints and calls to the Public Services Department and Village Hall about flooding in this area. [Pollutant Reduction Analysis: Phosphorus (currently 17.88 kg/yr to 1.31 kg/yr), Nitrogen (currently 140.87 kg/yr to 14.79 kg/yr), and Suspended Solids (currently 1,688.61 kg/yr to 159.57 kg/yr).]

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

Withholding of funds is a fair penalty for failing to meet deliverables.
