4. **Project/Program Description**

Oceanside Circle is a multi-year resiliency and floodwater mitigation project. The roadway is a dead end double chip seal surface with shell/dirt base connected to Versaggi Drive in St. Augustine Beach. The chip seal surface on Oceanside Circle has reached the end of its expected useful life. Oceanside Circle also has no drainage system and rainstorm runoff causes localized flooding. The roadway has been significantly impacted leading to base failure and potholes. Construction of a gravity or pumped drainage system compatible with existing utilities is essential prior to roadway reconstruction. The proposed Oceanside Circle floodwater mitigation system will flow to the existing Linda Mar stormwater pump station. Linda Mar stormwater pump station upgrades are encompassed in this project.
