St. Lucie County is seeking assistance to open the 33-acre preserve, purchased in 2015 for \$457,533 to the public and provide ADA and sensory friendly infrastructure including entrance signage, parking areas, kiosks, interpretive signage, trails, boardwalks, restroom, river observation areas, outdoor classroom, nature playground, kayak launch and picnic facilities. This site will be the County's first inclusive design preserve with river access and will provide amenities specially designed for people with unique abilities and special needs.

33 acre preserve, adjacent to the North Fork of the SL River, will be open to the public and provide an array of ADA accessible passive recreation (hiking, fishing, nature enjoyment, etc) & preserved/managed in perpetuity primarily for ecological health providing ecological services benefits (clean air, carbon sequestration, aquifer recharge, water quality improvements, wildlife habitat, etc).

### c. What direct services will be provided to citizens by the appropriation project?

ADA trails for walking, hiking, and biking, ADA river access for kayaking and fishing, areas specifically designed for sensory friendly needs (touch/tactile stimulation, quiet reflection areas away from stimuli, etc.) bird watching, playing, and general enjoyment of nature.
