Will improve transportation by alleviating traffic from a residential road and currently congested intersection. Provide a new venue for all age groups to get outside and improve health and fitness in the park or on the trails by walking, running or cycling.

**c. What direct services will be provided to citizens by the appropriation project?**

Increased parks and recreation opportunities. Economic development from the multi-billion dollar cycling industry in Florida.

**d. Who is the target population served by this project? How many individuals are expected to be served?**

>800 The multi-purpose aspect of the project will appeal to a wide spectrum of age groups. Parents with small children - trail head park. Teens - park and trail activities. Adults / seniors - walking, jogging, dog walking and cycling.

**e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?**

Improve physical health- Year by year comparison of emergency medical service calls. User count of the new park and trail.  
 Improve mental health - User count of the new entrance and trails.  
 Enrich cultural experience- The establishment of a western gateway to the City using public art, signage, and special lighting complemented by the proposed new park entrance.  
 Increase tourism- Count of users accessing the regional park.
