### 4. Project/Program Description

The Nancy Renyhart Center for Dementia Education (NRCDE) is a program of Hospice of Marion County. The NRCDE's mission is to educate caregivers and the general public about dementia so everyone has a better understanding of the daily struggles and challenges. The center is becoming north central Florida's hub for information, resources and support on Alzheimer's and dementia related diseases. Currently, the center is housed in the main office of Hospice of Marion County. The project proposed in this request is to erect a stand-alone building on the hospice campus to house the NRCDE. At approximately 6,000 square feet, the center will include an adult day care, a preschool, a memory café, a skills lab for caregivers, an education center and a dementia supportive care program.

Requested funds will be utilized to complete the site planning of the Nancy Renyhart Center for Dementia Education (NRCDE), a 6,000 square foot building in Marion County. A program of Hospice of Marion County, the NRCDE will have a caregiver skills lab, an adult day care center, a memory cafe, an education center, dementia supportive care program, and a certified preschool. NRCDE services will improve professional care and community care for individuals with Alzheimer's and dementia related disease in north central Florida.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

The activities associated with the site planning of the NRCDE include: a civil engineering firm will complete appropriate surveys, city and state ordinance zoning requirements, land clearing, and installation of underground utilities; an architectural firm will design the 6,000 square foot building; and a contractor will install a generator.

#### c. What direct services will be provided to citizens by the appropriation project?

Once construction is complete, the NRCDE will improve community-wide care for individuals with Alzheimer's and dementia related diseases through various programs and services. Educational trainings regarding the recognition and management of such diseases will be provided directly to caregivers, healthcare associates, community first responders, family members, and the general public. Internship, shadowing experiences, and volunteer opportunities will be provided to College of Central Florida medical/nursing students. Individuals with Alzheimer's and dementia related diseases will socialize in a memory café and interact in an adult day care. Finally, a certified preschool will operate for Hospice of Marion County employees.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

It is estimated that 47,268 residents in north central Florida (Marion, Lake, Sumter, Levy, Citrus, Alachua) are living with Alzheimer's and dementia related diseases. Alzheimer's disease is the top health priority in the State of Florida's 2022-2026 Health Improvement Plan. To directly serve these residents, the NRCDE will annually provide hands-on and virtual trainings to approximately 1,200 caregivers, healthcare professionals and other stakeholders, 100 community firstresponders, 50 medical/nursing students, 100 family members, and 200 general public residents.

# e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

#### be measured?

The NRCDE will educate caregivers, community first responders, medical/nursing college students, and the general public through hands-on and virtual educational trainings to better improve the professional care for individuals living with Alzheimer's and dementia related diseases. In addition to tracking the number of total educational trainings and total number of attendees and center visitors, attendees will complete pre-and-post- surveys to measure gained knowledge and understanding in aiding individuals with Alzheimer's and dementia related diseases.
