Elderly Hot meals program--This program aims to provide for the provision of a daily nutritionally balanced meal to the elderly. These meals are served at either a congregate site or home delivered. The program provides transportation to and from the center, breakfast, lunch, nutritional education, and activities that promote both cognitive and physical health as well as fine motor skills. Center staff provides social services such as translations, the completion of applications, and guidance. The program also provides telephone reassurance which entails phone calls between center staff and the elderly to insure that all needs are being met.
