4. Project/Program Description

The city will provide owners of vulnerable properties the opportunity to either elevate their homes in areas prone to flooding, or alternatively, allow the city to purchase their home so that they can relocate outside of the floodplain area. Any properties acquired by the city will be deed restricted to remain open space in perpetuity for stormwater management or water quality purposes. These efforts also reduce the need for additional funds from the National Flood Insurance Program.

The city has an Urban County Agreement with Lee County for CDBG Entitlement Funds. The city's HUD allocation for CDBG-CV funds was \$496,713. The city has partnered with local non-profit organizations for a food insecurity grant program. The program is designed to feed the local citizens in Bonita Springs either through a hot meal distribution or through the distribution of a food pantry program. The city's agreement with Lee County expires on September 30, 2023.

Should the homeowner decide to sell their home to the city, the city would acquire the home and then demolish the structure. The land will remain in the city's name in perpetuity.

The city will guide and assist property owners through all stages of the elevation and/or buyout process to allow residents an opportunity to relocate out of the flood-prone vulnerable areas.

c. What direct services will be provided to citizens by the appropriation project?

Assistance with due diligence processes, relocation, and other related activities.

d. Who is the target population served by this project? How many individuals are expected to be served?

Economically disadvantaged residents. Residents in vulnerable and flood-prone homes. 25-50 individuals will participate, and the community at large will benefit.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Reduced risk of storm surge and riverine flooding in residential homes For acquisitions, requirement for deed restrictions to preserve open space for stormwater management and water quality projects Relocates vulnerable residents into safer homes. Reduction of repetitive loss and severe repetitive loss of properties in the city and reduced number of NFIP claims.

Penalty could include repayment of funds.
