**c. What direct services will be provided to citizens by the appropriation project?**

Business recruitment, job creation and related economic opportunities will be enhanced for the State, and its adjacent municipalities, by providing a safer corridor. This construction project will employ nearly 40 Floridians within the next year, including all of the construction jobs, and permanent jobs in the nearby businesses.

SW 142 Avenue connects State Road 848 (Stirling Road) to Old Sheridan Street. The installation of guardrail along SW 142 Avenue will dramatically increase the safety of the thousands of motorists that traverse it each day, allowing the traveling public to conduct business with local merchants and companies that directly access this roadway.
