## a. What specific purpose or goal will be achieved by the funds requested?

The Whitaker & Hudson Bayous Water Quality Project will implement a water quality project prioritized by the Sarasota Bay Watershed Management Plan Update (April 2022) and the City of Sarasota's 20-year Stormwater Needs Analysis Report (June 2022) per Florida House Bill 53 signed into law in 2021 as Section 403.9302, Florida Statutes.



#### b. What activities and services will be provided to meet the intended purpose of these funds?

The project will provide design for the construction of a stormwater improvement project. Construction activities will include the replacement of stormwater infrastructure at end of useful life, along with resiliency features such as nutrient separating baffle boxes.

#### c. What direct services will be provided to citizens by the appropriation project?

Citizens will benefit from the implementation of resiliency capital improvement projects that will reduce water quality pollutant loads, increase flood protection, increase stormwater system capacity and address level of service deficiencies.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

The target population to be served is comprised of residents within the Sarasota Bay Watershed, specifically Hudson and Whitaker Bayous. More than 800 individuals are expected to be served.

# e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

#### be measured?

The following outcomes are expected: Improved water quality pollutant load conditions; Reduced flooding impacts from storm events; Structures removed from 100-year storm risk; Decreased roadway flooding level of service deficiencies; New jobs created for people designing and constructing the project; Increased stormwater management system capacity; Replaced stormwater infrastructure at end of useful life. The methodology by which these outcomes will be measured include: Routine water quality sampling and periodic operation and maintenance inspection reports.
