School Resource Officers will operate an eight-week summer camp for PAL youths. Three Hollywood Police officers operate a year-round police explorer program for fifteen youth police explorers. The services and activities that will be provided to youth members in the community are: Tutoring Program, Police Explorer Program, Hollywood PAL Summer Camp, Football Program, cheerleading Program, Back to School Giveaway, Thanksgiving Meal Giveaway, Holiday Toy Giveaway, Boxing Program and Awards Banquet.

## c. What direct services will be provided to citizens by the appropriation project?

Many of the youth members who are involved in athletics have shown improvement in self-esteem. PAL serves a diverse group of youths who may not speak English. Through sports, youth members can learn from their teammates, and feel a part of a team. This teamwork also transfers at school.

The measure of success in athletics is not measured in wins and losses. The confidence and improvement in self-esteem displayed in our youths measure the success in our athletic programs.

Many of the youth we service have no positive role models or positive contact with Law Enforcement Officers. This program bridges the gap and allows positive interaction between Police and potential "at-risk" youths. Most importantly, the Hollywood PAL provides a safe environment for children and teens to stay after school and into the early evening hours.
