LEGISLATIVE UPDATE

Bill Impacting Immigrants

On July 1st, HB1617/SB1718 Florida Immigration Law went into effect. Hispanic Unity of Florida (HUF) has been actively engaged informing clients, community partners, small and mid-sized businesses, stakeholders, elected officials, and the broader community the facts around the immigration law and its provisions.

New laws are sometimes difficult to understand, and we have received many questions about what this law may mean to immigrants. We have broken down to **what the law DOES NOT do** regarding some of the provisions we heard from the community to be most impactful:

- It will NOT be a crime to live, provide shelter, or rent space for family members, friends, or neighbors who have an irregular immigration status.
- It will NOT be a crime to provide transportation within the State of Florida to any person with an irregular immigration status.
- The E-Verify system will ONLY be required for employers with 25 employees or more.
- You do NOT need to provide your immigration status to hospitals. You have the right to decline to answer, regardless of your immigration status. No one should go without healthcare due to concerns about their immigration status.

At HUF, we firmly stand with immigrants and wholeheartedly support the immigrant community. We take great pride in recognizing their remarkable achievements and invaluable contributions to society and the economy. Furthermore, HUF remains committed to providing services to all immigrants and others in need of help. Our dedication to serving the community remains steadfast.

U.S. Department of Education

The Biden-Harris Administration recently approved \$39 billion in Federal student loans to be discharged for nearly 804,000 borrowers in the upcoming weeks. The decision is intended to address historical failures in the Federal student loan program related to income-driven repayment (IDR) plans that had left some borrowers' payments unaccounted for. This decision is part of the Biden-Harris Administration payment count adjustment announced last year to tackle inaccurate payment counts that have impacted borrowers working hard toward their payments and loan forgiveness. The Department of Education will reach out to eligible borrowers that qualify for loan forgiveness, and discharges are set to begin 30 days after emails are sent.

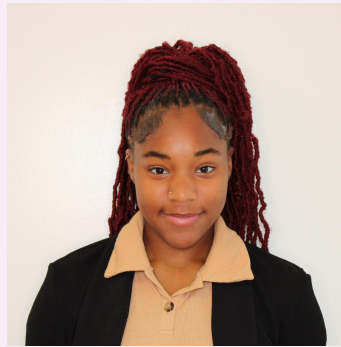

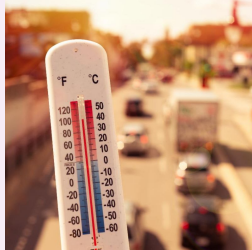
National Eye Exam Month

According to the Centers for Disease Control (CDC), 90 million Americans over 40 years old have vision and eye problems, and nearly 6.8 % of children below 18 years of age have a diagnosed eye and vision condition. Heat Safety



This summer season has brought record-breaking temperatures to South Florida. The National Weather Service has already issued heat alerts for the region, with some heat index values reaching 105 degrees!

Heat poses a significant threat to everyone, killing more Americans yearly than tornadoes and flooding. Extreme heat can result in heat exhaustion, heat stroke, organ failure, and even death. Some signs of heat exhaustion include excessive sweating, dizziness, muscle cramping,

and vomiting. If your symptoms persist for over an hour, the CDC recommends that you seek assistance. Staying indoors is essential, but if you don't have access to air conditioning, taking cool baths, hydrating regularly, and keeping a fan nearby can ease the heat. Schedule outdoor time during cooler parts of the day, including walks with your pets to avoid harm. Also, double-check your vehicle before exiting to ensure no children or pets are left behind, as indoor temperatures can be fatal for anyone unattended.
