The goal of these requested funds is to ensure the Gulf Beach Highway Drainage Outfall at Sunset \ Patton \ Elite \ Winthrop can be constructed by overcoming the recent material and labor cost increases. Much effort has been put forth to bring this project through construction. Based on recent bids in Escambia County of similar projects, this project is at risk of not being able to move into construction without these requested funds.

Escambia County will provide the procurement of the contract and the contract administration to meet the intended purposes of these funds.

This project will serve the residents of North Navy Point and consists of approximately 70 homes and properties constructed between 1948 - 1950 that are located just south of Gulf Beach Highway (SR 297A).

This project will reduce flooding. Flooding complaints are captured, after this area is expected to reduce to zero.

The contract between the County and Contractor will have penalties for not performing work within the time allotted in the contract. These penalties include liquidated damages, negative post design evaluations for the firm, and having the right to bid on future work revoked.
