4. Project/Program Description

To provide an internationally recognized, safe and accessible, outdoor educational exhibit, walking path, and classroom for Holocaust education and learning immersion. The goal of the Center is to educate all ages and all walks of life about the Holocaust, and be the premier location for educators and K-12 students to meet Florida's required Holocaust Education mandate. Utilizing innovative technology, participants will have greater understanding, empathy, and awareness of the issues described below. Each learning station will include a "What You Can Do" component – to learn more, to engage more – both individually, and with others – and to act. The content will be accurate, trusted, fresh, and clearly designated as appropriate for audiences of different ages. The outdoor classroom, Pavilion, will provide an immersive experience for tourists and Floridians, students and teachers, interfaith and civic groups, and families.

14. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?



The goal of the Jewish Federation's Holocaust Education Center is to educate and engage local, state and national communities about the Holocaust and its lessons for today. Through interactive technology, a fully equipped outdoor classroom (pavilion), and expert instruction, participants will learn about the past and ways ensure a safe future for all. Participants have greater understanding of the Holocaust and how it happened, and empathy and respect for those who suffered, were killed, or survived. Each learning station will include a "What You Can Do" component – to learn more, to engage more – both individually, and with others – and to act to combat hate and antisemitism today. The content will be accurate, trusted, fresh, and clearly designated as appropriate for audiences of different ages.

b. What activities and services will be provided to meet the intended purpose of these funds?

Education hardware - iPads (or equivalent) in kiosks, projector, smart-screens, touch-screens, to enable audio/visual instruction and engagement.

Education software - content online to prepare visitors (whether teachers or general visitors); a mobile self-guided tour while on the premises (QR codes / audio testimonies); content for post-visit follow-up, including activities and lesson plans; guided tour online

c. What direct services will be provided to citizens by the appropriation project?

d. Who is the target population served by this project? How many individuals are expected to be served?

While educators and students will constitute the largest audience, the Holocaust Education Center will be open to all, including families, tourists, youth groups, faith communities, civic and business leaders, etc. We hope to serve at least 5,000 local students annually, and expect to welcome several hundred more throughout the course of a year. Surveys show that effective Holocaust education, which involves experiential learning, may reduce violent acts of antisemitism and hate.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

Participants will leave the Holocaust Education Center having learned about the dangers of unchecked antisemitism and hate; how the Holocaust happened and its lessons for today; and with tools to act as an "upstander" rather than "bystander" to ensure such atrocities never happen again. The Jewish Federation of Sarasota-Manatee will continue to closely collaborate with regional School Districts to ensure the Center helps educators meet Florida's robust Holocaust Education mandate. Materials created and online tours will be accessible and attractive to educators and organizations across the state, country, and world. Outcomes will be measured through pre-&-post surveys, and the utilization of activities and learning modules.
