The Department of Mental Health Law and Policy at USF will lead a collaboration to develop opioid simulation modeling tools that specifically respond to the available resources, existing services, and desired new services for Florida counties to address location and distribution methods of Narcan and effects of various amounts and types of new treatment capacity. The USF team will leverage existing technical assistance relationships to identify five additional counties with data dashboards already in place as initial study sites. We will run simulation models based on these counties' resources and preferences and provide them with a computer modeling tool they can use as their resources and needs change over time.

Currently USF is collaborating with Stanford and Northwestern University to develop simulation modeling tools for counties across the country, including Pinellas County, where we have addressed questions about location and distribution methods of Narcan and effects of various amounts and types of new treatment capacity. USF will leverage these partnerships and technical assistance relationships to identify five additional counties with data dashboards already in place as initial study sites. We will run simulation models based on these counties' resources and preferences and provide them with a computer modeling tool they can use as their resources and needs change over time.

**b. What activities and services will be provided to meet the intended purpose of these funds?**

The funds will provide tools to develop simulation modeling, which will allow the USF team to engage our existing training and technical assistance networks to share the impact and outcomes of this innovation, disseminate the modeling tool, and train on best practices for implementing simulation modeling to build the capacity of all Florida counties for model-driven decision-making to strategically allocate resources to effective overdose reduction interventions.

**c. What direct services will be provided to citizens by the appropriation project?**

USF will work directly with Florida counties to provide data and simulation models on how to best allocate resources to more effectively reduce overdose interventions.

**d. Who is the target population served by this project? How many individuals are expected to be served?**

Persons with poor mental and/or physical health, drug users, economically disadvantaged. Thousands of individuals could be served by this predictive modeling tool.

The impact and outcomes of this innovation, disseminate the modeling tool, and train on best practices for implementing simulation modeling to build the capacity of all Florida counties for model-driven decision-making to strategically allocate resources to effectively reduce overdose incidents.
