The Final Design and Construction of the Peace River Regional Reservoir No. 3 (PR3) Project will provide the withdrawal, storage and conveyance components necessary to meet increasing regional drinking water needs through 2037 using an Alternative Water Supply. The PR3 Project components include a new intake and pump station to withdraw raw water from the Peace River, conveyance pipelines to a new 9 billion gallon above ground reservoir and conveyance pipelines back to the treatment facility.

b. What activities and services will be provided to meet the intended purpose of these funds?

Construction of approximately \$550 Million in capital infrastructure to provide an additional 18 million gallons of drinking water to the region to meet growing water supply demands with an Alternative Water Supply through 2037.

c. What direct services will be provided to citizens by the appropriation project?

This project provides a reliable and safe drinking water supply for public health, safety and welfare for the residents of the four-county service area of Charlotte, DeSoto, Manatee and Sarasota Counties.

d. Who is the target population served by this project? How many individuals are expected to be served?

The four-county region comprising the Authority's service area has a population of approximately 1,100,000 residents. The Authority's regional water supply system connects to utilities serving more than half of that population and in 2022 approximately 30 million gallons per day of drinking water was supplied to the region to support public health and economic growth. This project will provide and additional 18 million gallons per day to the region to meet potable water demands of our members through 2037.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

This project provides reliable water supply infrastructure to the region to meet future potable water supply demands for economic development and public health and safety. The project enhances regional water supply resiliency to disasters such as drought, floods, hurricanes, and climate change. The outcome will be measured through improving water supply availability and maintaining the current high standards for drinking water quality under all foreseeable conditions.
