Construct a new 6,000 square foot building for the Dixie County Sheriff's Department to upgrade the evidence facility, allow space for meetings during large investigations, add additional parking, and add fencing for a secure impound yard. The current evidence facility is in a portable structure, this project will construct a new evidence building that is up to Florida Building Standards to protect evidence.

Using the Perceived Stress scale, survey employees in the current evidence building then in the new evidence building to measure the reduction of stress. The new evidence facility will provide peace of mind for the public thus improving the mental well-being of the citizens. By providing benefits of project and surveys to the public to generate feedback, it will allow us to educate the public of our services to decrease stress of the population. It will help protect the general public by decreasing inadmissible evidence by increasing building standards, security, and adequate space for large evidence. This can be measured by evaluating inadmissible evidence before and after the completion of the evidence building.
