4. Project/Program Description

The Marion County Board of County Commissioners is actively building parallel and alternative corridors to I-75 and other state roads in the area. The funds requested will be used for road and utility design of a 3.7-mile portion of NW 80th Ave between SR 40 through US 27, which is one section of the 13.6 mile SW/NW 80th/70th Avenue/49th Street corridor project with a total expected cost of \$140,000,000. In addition, the county has invested \$749,604 for the preliminary engineering report and project development and \$12.1 million for right of way acquisition and design. Further, the county is programmed for \$23 million and is spending \$6.5 million for the intersection of NW 80th Ave & US 27. This project will help with traffic congestion on I-75 and around the World Equestrian Center (WEC).

14. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

As Marion County's population and subsequent traffic grows, roads within and through the county are becoming congested for both pass-through as well as intra-county traffic. The funds requested for this project will be used for road and utility project design on a 3.7-mile portion of NW 80th Ave between SR 40 through US 27, with the goal of eliminating traffic congestion both on I-75 and for those entering/exiting the World Equestrian Center.

b. What activities and services will be provided to meet the intended purpose of these funds?

The project will expand this segment of the road from 2 lanes to 4 lanes and relocate and interconnect water and sewer utilities at this same time to provide for much-needed septic-to-sewer connections.

c. What direct services will be provided to citizens by the appropriation project?

The project will allow Marion County residents and visitors to the county to utilize the SW/NW 80th/70th Avenue/49th Street corridor, instead of an already congested I-75 for travel within the county.

d. Who is the target population served by this project? How many individuals are expected to be served?

Travelers of the SW/NW 80th/70th Avenue/49th Street corridor will be served by the project. Many of the county's 385,000+ residents utilize I-75 for local travel, additionally, these road improvements will benefit the estimated 80,000 people daily I-75 moves through the county daily by reducing traffic and congestion caused by local travelers. It will also serve to reduce congestion for those entering/exiting the World Equestrian Center.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The project will provide relief to traffic and intersection congestion on I-75 in Marion County. We will measure traffic congestion, traffic count, and intersection performance at locations impacted by the project.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

Standard contract penalties including liquidated damages and the potential for failure to be awarded future contracts due to poor or lack of performance.
