The Task Force's mission includes partnering with the Florida Department of Education to be an advocate for Florida's K-12 teachers, students, and the community in developing instructional materials that highlight the history and accomplishments of African Americans. This project of the Florida Department of Education provides funding to the Florida Agricultural & Mechanical University to implement the activities, goals, and objectives of the AAHTF. The proposed work for this project will support the State Board of Education's Strategic mission in the implementation and adherence of the required instruction, to increase the proficiency of all students by allowing them the opportunity to expand their knowledge and skills through learning opportunities and research and goals of 1) Higher Student Achievement, 2) Seamless Articulation and Maximum Access, 3) Skilled Workforce and Economic Development, and 4) Quality Efficient Services.

The methodology will include but be limited to United States History EOC assessment results.
