The Powerhouse Youth Project offers on-campus instruction to students assisting them with identifying their passion and purpose after high school. Powerhouse provides a robust supplemental interactive curriculum that engages students and prepares them to take the next step in their career development. Powerhouse offers career assessment with each student through the DISC personality assessment for careers. Once the assessment is completed, students are then matched with mentors who are or who have been in that specific career field. Powerhouse is also utilizing the senior population over 55 who have vast experiences and wisdom with their "High-Tech/High Touch" mentoring aspect. Senior citizens can connect with students from their phones or computer without ever leaving their homes. This enables the mentor program to eliminate geographical barriers to mentoring and expand the possibilities of mentors being at any location. a. What specific purpose or goal will be achieved by the funds requested?

1. Reduction of High School Dropouts by providing a pathway to success. 2. Provide career assessment for each student with a clear path to their next steps. 3. Understanding of budgeting and life skills based on selected career path. 4. Provide a mentor to each student based on selected career path for accountability and accessibility to next steps needed to achieve the desired career. 5. Reduction of students entering the criminal justice system.

b. What activities and services will be provided to meet the intended purpose of these funds?

On campus classroom experiences that engage students by using creative interactive learning.

c. What direct services will be provided to citizens by the appropriation project?

Powerhouse will provide career and personal development for all students who engage within the strategy. Adults and senior citizens will also be provided training on mentorship and provided an opportunity to give back within each community served.

d. Who is the target population served by this project? How many individuals are expected to be served?

All youth ages 14-24. At-risk students who are currently in night school or participating in alternative schools. 2,000 students.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

1. Reduction of HS dropouts by creating a pathway to discover their career and steps to achieve it. This can be measured by pre/post testing on a student's responses to the strategy as well as active engagement with mentors during follow-up of each student. 2. Increase workforce development within the community. Each campus will host a career day as we provide a pathway for employers to connect with students after they have completed the experiences. Participation in career day and total hired will be a measuring device on the effective outcome of this benefit to the community. 3. Reduction of students entering the juvenile justice system. 80% of individuals incarcerated today are HS dropouts. Powerhouse will reduce those entering the DJJ by providing them the alternative of a healthy productive life in society. This can be measured by looking at pre/post analysis of students who have secured a full-time job or pursuit of certification/degree after high school.
