#### 14. Program Performance

#### a. What specific purpose or goal will be achieved by the funds requested?

These funds will help design and construct a state certified fire training facility that will be multipurpose for all public safety sectors. In addition, it will be purposed as a regional and state facility to fulfill needs locally, regionally, and across the state as needed.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

Activities will vary from classroom leadership settings to hands on practical exercises including live fire training, roof ventilation, search and victim removal, forcible entry, rope operations, and shoring. Additional training on the site will be driving, water supply, land navigation, and more. Partnerships with local and regional law enforcement departments would allow for building clearing, classroom classes, rope training, or any need that the design of the building would support; this would also be applicable for EMS in patient removal and emergency management in local disaster exercises.

#### c. What direct services will be provided to citizens by the appropriation project?

The training provided at this site will allow for the maintenance and enhancement of emergency services capabilities provided to citizens.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

The main focus of this project is to train and enhance firefighting skills at a facility designed to meet the mission of todays and tomorrows fire service. Classes or trainings will vary from basic to advance and each skill set master will directly effect the outcome of a citizen or a visitor to Ecambia County in their time of need. Current population is approximately 320,000.

# e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Maintenance and enhancement of emergency services capabilities, which will influence the ability to provide emergency services response to the community through initial training of recruits, maintaining skills, and enhancing capabilities. This will also provided a required training facility needed to improve our Insurance Service Organization (ISO) Public Protection Classification. This is done by providing required training at a certified and defined training facility. Local measurements will be through reviews of training provided, skills gained and score on next ISO PPC score.

# f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

All appropriate local, state, and federal requirements will be followed while administering the funding. Any contract will be reviewed by the Legal Department of Escambia County that will outline deliverables, performance measures, and any penalties if applicable.
